Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed audits of the accompanying financial statements of The Adecco Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF PLAN

The following description of The Adecco Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the official Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide employees of certain subsidiaries and affiliates of Adecco, Inc. (the Company) with retirement benefits in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective February 16, 2022, the Company merged the Adecco, Inc. Associates 401(k) Plan (Associates Plan), the Adecco, Inc. Specialty Brands 401(k) Plan (Specialty Brands Plan) and the Plan into a single plan with the Plan as the surviving plan; and changed the name of the surviving plan from Adecco, Inc. Colleagues 401(k) Plan (Colleagues Plan) to The Adecco Group 401(k) Plan.

In 2023 the following plans were merged into the Plan: AKKA USA, LLC 401(k) Plan (AKKA Plan); PDS 401(k) Plan for Defense Employees; PDS 401(k) Plan for Engineering Employees; PDS 401(k) Plan for IT Section Employees, PDS Aviation, PDS Corporate Staff, PDS Maritime and PDS Staff Profit Sharing Plan. A residual amount from the AKA Plan was deposited into the Plan in April 2024 and is reflected as a transfer within the statement of changes in net assets for the year ended December 31, 2024.

Post merger, the original plan provisions of all the aforementioned plans, continued to remain in effect. As a result, the Company remains directly responsible for those obligations under the original plans, which are subject to the provisions of the ERISA.

Eligibility

Colleagues Plan

Company Colleague employees of participating employers are eligible to make voluntary contributions to the Plan after three months of service, as defined in the Plan document.

Associates Plan

All Company associate employees of participating employers are eligible to participate in the Plan as soon as administratively possible as defined in the Plan document.

Specialty Brands Plan

Company employees, referred to as "Colleagues" and "Associates," are eligible to participate in the Plan after three months of service, as defined in the Plan document.

Participant Contributions

Eligible nonhighly compensated participants may make voluntary contributions through salary reductions from 1% to 75% of their eligible annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC. Further, participants who are 50 years of age or older may contribute an additional “catch up” contribution. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common collective trust funds and pooled separate accounts as investment options for participants.

The Plan includes an automatic enrollment provision. Therefore, when a nonhighly compensated employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of those participants, defer 3% of the participants’ total eligible compensation (as defined). An employee can elect not to participate in the Plan.

Rollover Contributions

The Plan may receive, on behalf of a participant, rollover contributions from other qualified plans subject to approval by the Plan administrator. These contributions are 100% vested upon contribution.

Employer Contributions

Colleagues Plan

The Company makes a matching contribution of 50% of the lesser of the 401(k) deferral for the Plan year or 6% of the participant’s eligible compensation. Participants are eligible to receive matching contributions if they have worked for the Company for at least three months.

Associates Plan

The Company does not provide any employer matching contribution.

Specialty Brands Plan

For participants classified as Colleagues, the Company makes a matching contribution of 50% of every dollar contributed not-to-exceed 3% of the participant’s eligible wages.

For participants classified as Associates, the Company makes a matching contribution of 50% of every dollar contributed not to exceed 1.5% of the participant’s eligible wages. Associates must be employed as of December 31 of the Plan year and have accrued 40 or more hours in the last full calendar month of such year to be eligible to receive a matching contribution.

Participants’ Accounts

Each participant’s account is credited with their respective contribution and allocation of: (a) employer contributions; and (b) Plan earnings or losses.

Vesting

Colleagues Plan

Participants' voluntary contributions, employer matching contributions and any earnings thereon vest immediately. Participants may have received a discretionary profit-sharing contribution in prior years. These discretionary contributions vest ratably over a period of seven years, beginning with the participant's third year of service. In the event of death, disability or attainment of age 65 (or if later, five years of plan participation, as defined in the Plan document), participants' accounts become fully vested.

Associates Plan

Participants' voluntary contributions and any earnings thereon vest immediately.

Specialty Brands Plan

Participants' voluntary contributions and any earnings thereon vest immediately. Participants vest in employer matching contributions ratably over a period of four years. In the event of death, disability or attainment of age 65 (or if later, five years of Plan participation, as defined in the Plan document), participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59½. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

All the Plans' participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to 10 years. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will serve to reduce future Company contributions and reduce Plan expenses. The Company used forfeitures totaling \$935,792 to reduce Company contributions for the Plan year ended December 31, 2024. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,110,698 and \$1,363,066, respectively

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 9 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Fair Value

Accounting standards provide a common definition of fair value and establish a framework to make the measurement of fair value in GAAP more consistent and comparable. Accounting standards also require expanded disclosures to provide information about the extent to which fair value is used to measure certain financial assets and liabilities, the methods and assumptions used to measure fair value, and the effect of fair value measures on earnings. The Plan's financial assets reflected in the financial statements at fair value include its investments (see Note 8).

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document.

The Plan has an ERISA budget account used to pay administrative expenses. As of December 31, 2024 and 2023, the balances were \$215,173 and \$253,508, respectively. For the year ended December 31, 2024, \$335,991 was used to pay Plan expenses.

Subsequent Events

Effective January 1, 2024, the Plan was amended to add a three month service requirement for the Associates Plan. The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Principal), the trustee of the Plan.

4. TAX STATUS

The Plan uses a prototype Plan document sponsored by Principal Financial Group. The prototype Plan document received an opinion letter from the Internal Revenue Service (IRS), dated June 20, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The prototype document has been amended since receiving the opinion letter; however, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. RELATED PARTY TRANSACTIONS

During 2024 and 2023, the Plan held investments, which were units of common collective trust (CCT) funds and pooled separate accounts (PSAs) managed by the trustee; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Additionally, for the year ended December 31, 2024, the Plan paid administrative and recordkeeping fees of approximately \$989,000 to the Plan's recordkeeper, investment management fees of approximately \$155,000 to the Plan's investment advisor/consultant and approximately \$39,000 in legal and audit fees.

6. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time by resolution of the Board of Directors, subject to the provisions of ERISA. In the event that the Plan and the related trust fund terminate, participants will be 100% vested in their account balances and all accounts will be valued as of the termination date and account balances will be distributed in full to participants.

8. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust (CCT) Funds: Valued based on the underlying unit value of the assets held. The assets on the underlying funds are invested in mutual funds, equity securities, debt securities. The NAV of the units of the accounts is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Pooled Separate Accounts (PSAs): Valued based on the published value of the underlying assets adjusted for distributions, reinvested dividends and expenses. The NAV of the units of the accounts is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
