## INDEPENDENT AUDITOR'S REPORT

To the Management of the  
Concrete Technologies, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Concrete Technologies, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). For the Year Ending December 31, 2024

*A. Description of Plan*

The following description of the Concrete Technologies, Inc. (the "Company") 401(k) Plan (the "Plan") is general in nature. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

1. *General* - The plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age 18 or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, commonly referred to as ERISA. Concrete Technologies, Inc. is the Plan Sponsor and Administrator. The Standard Insurance Company serves as the Record Keeper for the Plan.

2. *Contributions* - Contributions to the Plan are made through employee salary deferrals, including catch-up contributions, Company contributions and participant rollover contributions. Contributions are subject to certain limitations set by the IRS.

*Employee Contributions* - Eligible employees may elect to defer eligible compensation on a pre-tax basis or an after-tax (Roth) basis. Employees age 50 and over may elect to defer additional amounts (called "catch-up contributions") to the Plan. The catch-up amount is limited by IRS rules and adjusted periodically for cost-of-living adjustments. Employees are not automatically enrolled into the Plan when they become eligible. Employees have the option to opt in or out, and change their deferral amounts at any time in accordance with the Plan.

*Company Contributions* - The Plan is a Safe-Harbor Plan, as defined by the IRS. The Company matches contributions equal to 100% of employee salary deferrals that do not exceed 4% of the employee's eligible compensation. The matching contribution is 100% vested immediately. The Company may choose to make additional discretionary matching contributions or profit sharing contributions, in accordance with the Plan documents and IRS limitations.

*Participant Rollover Contributions* - Participants eligible for a withdrawal from another eligible retirement plan or IRA may roll over all or part of the account balance into the Plan. The Plan also allows for In-Plan Roth Conversions, Rollovers and Transfers, in accordance with Plan documents and IRS limitations.

3. *Participant accounts* - Each participant's account is credited with the participant's contributions and Company contributions (including matching contributions and discretionary matching and profit sharing contributions) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of expenses may be based on proportion of account balance or equal among participants, depending on the nature of the expense.

4. *Vesting* - Participants are vested immediately in their salary deferral contributions and safe harbor company matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and profit-sharing contributions is as follows:

5. *Notes receivable from participants* - Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the assets in the participant's account, and will be charged a fixed interest rate deemed as "commercially reasonable" by the Plan Administrator. In general, the repayment term of participant loans will not exceed 5 years.

6. *Payment of benefits* - On termination of service due to death, disability, or retirement, a participant may elect to receive their vested balance in either a single lump-sum payment, partial withdrawal, or installments over time, as set forth in the Plan documents. For termination of service for other reasons, a lump sum distribution will be received if the account balance is less than \$5,000. The Plan also allows for in-service distributions as set forth in the Plan documents.

7. *Forfeited accounts* - As of December 31, 2024 and 2023, there was no balance of forfeited accounts. Forfeitures are retained in the Plan and are first used to pay administrative expenses. Remaining amounts reduce future employer contributions.

## B. Summary of Accounting Policies

1. *Basis of Accounting* - The financial statements are prepared on the accrual basis of accounting.

2. *Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. *Investment Valuation and Income Recognition* - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for more information on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

4. *Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

5. *Payment of Benefits* - Benefits and withdrawals are recorded when paid.

6. *Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant loans are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

7. *Subsequent Events* - The Plan has evaluated subsequent events through August 8, 2025, the date the financial statements were available to be issued. Through that date, there were no additional items requiring disclosure.

### C. Fair Value Measurements

ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* — Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* — Inputs to the valuation methodology are unobservable and significant to the fair value (these are often based on internal models and there is rarely a two-way market).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments held in the Plan primarily consist of mutual funds and pooled separate accounts. The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

*Pooled Separate Accounts* - Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. These PSAs are classified as Level 2. The redemption frequency of each of these PSA is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan's investment in PSAs.

*Mutual Funds* - Valued at the daily closing NAV price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These securities are classified as Level 2. Investments in mutual funds generally may be redeemed daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

#### D. Group Annuity Contract With Minnesota Life Insurance Company

The Plan has entered into a group annuity contract with Minnesota Life Insurance Company. The contract is a traditional investment contract. Under the contract, the participant principal and interest are fully guaranteed by the general account assets of Minnesota Life Insurance Company. The investment strategy employed seeks to achieve consistent returns to support a competitive

credited rate. Bonds invested in the general account segment have an average maturity between three and seven years; are investment-grade in quality; and are diversified across a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgages, private equity, etc.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include, but are not limited to the Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under section 501(a) of the Code; premature termination of the contract; Plan terminations or merger; changes to the Plan's prohibition or competing investment options; and bankruptcy of the Plan Sponsor or other events of the Sponsor, such as divestitures, that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer as that would limit the ability of the Plan to transact at contract value with the participants.

#### E. Related-Party Transactions and Party-in-Interest Transactions

As defined by ERISA, parties-in-interest include the Plan sponsor, service providers, and Plan participants. Transactions with these parties are allowed under ERISA if they meet certain exemptions.

The Plan permits participant loans, which are secured by the participant's vested account balance and bear a reasonable interest rate. These are considered party-in-interest transactions but are exempt from the prohibited transaction rules.

The Plan also engages The Standard Insurance Company as recordkeeper and investment provider. Fees for these services, which may be paid by the Plan or Plan sponsor, are considered party-in-interest transactions.

#### F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants become 100% vested in their accounts.

## G. Tax Status

Effective May 2020, the Plan was restated using a nonstandardized prototype plan document designed by Minnesota Life Insurance Company, which received an IRS opinion letter dated June 30, 2020, stating that the prototype plan document complied with the applicable law. The Plan, which continues to use that prototype document, has been subsequently amended and restated since 2020; however, management believes it is designed and continues to be operated in compliance with the applicable requirements of the Code and thus is exempt from federal income taxes under the provisions of Section 401(a) of the Code.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## I. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Standard Insurance Company.
