## INDEPENDENT AUDITORS' REPORT

To the Pension Administrator and the Pension Advisory Committee of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Retirement Plan for Employees of Saint Michael's College (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Retirement Plan for Employees of Saint Michael's College and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Retirement Plan for Employees of Saint Michael's College's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Retirement Plan for Employees of Saint Michael's College's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institutions agrees to or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. DESCRIPTION OF PLAN

The following description of the Retirement Plan for Employees of Saint Michael's College (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is sponsored and administrated by Saint Michael's College (the "College"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

- (a) General - The Plan is a defined contribution, safe harbor 401(k) plan covering all eligible employees of the College. Employees who are not eligible to participate are leased employees, students, volunteers, interns, camp workers, on-call employees, summer stock workers, members of the Society of Saint Edmund and certain nonresident aliens who have no earned income within the United States.

Participants become eligible to participate in the Plan the first day of the calendar quarter coincident with or next following the date on which the employee has satisfied the Plan's eligibility requirement of one year of service or at least 1,000 hours.

Prior to April 1, 2007, contributions could have been invested in various TIAA and CREF funds. Beginning April 1, 2007, the Plan added Charles Schwab Trust Bank as a trustee of Plan investments. No new contributions to TIAA and CREF are allowed subsequent to April 1, 2007.

The Plan automatically enrolls employees at a salary deferral rate of 2% of the employee's eligible compensation. The automatic deferral arrangement applies to employees who are hired, or rehired, on or after January 1, 2016, unless the employee makes an affirmative election to defer an amount or an election to defer no amount by opting out of the Plan. The automatic deferral percentage increases 1% per year up to 6% unless the participant takes affirmative action to change or turn off the automatic increase.

- (b) Contributions - During 2024 and 2023, the College elected to satisfy the safe harbor by making a non-elective contribution equal to 3% of the participant's eligible compensation. There was no other discretionary contribution for the 2024 and 2023 plan years. In the initial year of participation, compensation is from the effective date of participation.

Participants may elect to defer a percentage of their eligible compensation on a pre-tax or after-tax basis. The Plan's administrator will notify them of the maximum amount that may be deferred up to the legal limit that is set by the Internal Revenue Service ("IRS"). In addition, participants who are age 50 or older by the end of a calendar year may elect to defer additional amounts (i.e. catch-up contributions) to the Plan as of the January 1<sup>st</sup> of that year up to the IRS limit.

- (c) Participant Accounts - Up to five separate accounts will be maintained for each participant as follows: (1) salary deferral account for the participants' 401(k) contributions and any "catch-up contributions"; (2) voluntary after-tax contribution account for any voluntary contributions made before January 1, 2003; (3) nonelective contribution account for safe harbor contributions; (4) prior money purchase plan account for the contributions made under the Plan prior to April 1, 2007; and (5) Roth 401(k) after-tax account.

Each participants' account is credited with the applicable contributions and investment earnings. Allocations are based on participants' base earnings or account balances, as defined in the Plan document. Each of the participants' accounts is also adjusted to reflect the current value of the assets in which such accounts are invested. The benefit to which the participant is entitled is the benefit that can be provided from the total of the participant's vested accounts. All investments are participant directed.

- (d) Vesting - Participants are immediately 100% vested in all earnings and contributions when made.
- (e) Distributions - On termination of service for any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in their accounts in either a lump-sum amount, or monthly, quarterly, semi-annually or annual cash installments not extending beyond the participant's life expectancy (or joint life expectancy of the participant and their beneficiary).
- (f) In-Service Distributions - Participants who previously made voluntary after-tax contributions prior to 2003 may withdraw, at any time, the balance of their voluntary after-tax contribution account.

Participants may withdraw all or a portion of their salary deferral account and/or nonelective contribution account upon the participant's attainment of age 59½.

- (g) Notes Receivable - Participants may borrow against their accounts. Loans shall not be less than \$1,000 nor greater than the lesser of (1) \$50,000, reduced by the excess of the highest outstanding loan balance during the preceding twelve month period over the outstanding loan balance on the date the loan is made, or (2) one half of the present value of the participant's vested nonforfeitable accrued benefits under the Plan. Loans carry an annual interest rate of 1% over the prime rate. Only one loan per participant may be outstanding at any time. Loans are repaid over a period not greater than 60 months.

## 2. SUMMARY OF ACCOUNTING POLICIES

- (a) Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

- (b) Investments - Investments are stated at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully-benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment income includes all interest, dividends, and other investment income earned with respect to each fund. This investment income is reinvested in such fund, with a pro rata share being credited to each participant's account.

- (c) Cash Equivalents - The Plan considers cash equivalents to be short-term, highly liquid investments, with maturities of less than three months at the time of purchase. These cash equivalents are carried at cost, which approximates market value.
- (d) Risks and Uncertainties - The Plan provides for several different investments. These investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' benefits and the amounts reported in the statements of net assets available for plan benefits.
- (e) Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (f) Notes Receivable - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.
- (g) Allocated Contracts - In past years, qualifying participants could enter into a Minimum Distribution Option (MDO) contract with TIAA and CREF. These transfers are no longer allowed. Plan management considers those assets allocated and no longer an obligation of the Plan. Total amounts that have been excluded from the accompanying financial statements as of December 31, 2024 and 2023 are \$1,759,509 and \$1,746,267, respectively.

- (h) Administrative Expenses - The Plan document provides that direct expenses of administering the Plan may be paid out of Plan assets unless paid by the College.
- (i) Payment of Benefits - Benefits are recorded when paid.
- (j) Subsequent Events - The Plan evaluated subsequent events through July 31, 2025, the date the Plan's financial statements were available to be used.

### 3. INVESTMENTS

Prior to April 1, 2007, contributions could have been invested in various TIAA and CREF funds. Beginning April 1, 2007, the Plan added Charles Schwab Trust Bank as a trustee of Plan investments. No new contributions to TIAA and CREF are allowed subsequent to April 1, 2007.

The Plan has entered into a fully benefit-responsive investment contract. Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### 4. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Pooled Separate Accounts:* The TIAA Real Estate Account is a pooled separate account stated at fair value based on the fund's net asset value as determined by TIAA and CREF.

*Annuity Contracts:* The value of the contracts equal the accumulated cash contributions and interest credited, less any withdrawals.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. INFORMATION CERTIFIED BY THE TRUSTEE AND INSURANCE CARRIERS**

Under the regulations issued by the U.S. Department of Labor, the Plan has elected the “alternative method of compliance” with respect to the required audit of the financial statements for the years ended December 31, 2024 and 2023. As a result of adopting this method, Teachers Insurance and Annuity Association of America and College Retirement Equity Fund (TIAA and CREF) (insurance carriers), and the Charles Schwab Trust Bank (trustee), certified to the plan administrator that the information provided to the plan administrator by the trustee and insurance carriers, which indicates the Plan’s investments held by each respective trustee and insurance carriers as well as earnings on those investments, was complete and accurate and that reported investments were under their control. The accompanying financial statements and supplemental schedule summarize the information provided and certified by the trustee and insurance carriers.

### **6. TAX STATUS**

On October 10, 2023, the Internal Revenue Service issued a determination letter ruling that the Plan document constitutes a qualified plan under Section 401(a) of the Internal Revenue Code (IRC) and is therefore exempt from Federal income taxes on related business income under provisions of Section 501(a). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **7. RELATED PARTY TRANSACTIONS**

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

### **8. PLAN AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

Additionally, the College may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

9. WITHDRAWING PARTICIPANTS
