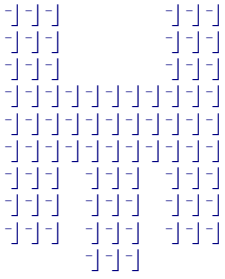

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hulett Environmental Services, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hulett Environmental Services, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. **Description of Plan**

The following description of Hulett Environmental Services, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of Hulett Environmental Services, Inc. (the "Company"), except leased employees, non-resident aliens and those covered under a collective bargaining agreement, who have at least 90 days of service to the Company, as defined, and have attained the age of eighteen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on February 1, 1997, and restated in its entirety on January 1, 2022, as required by Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Plan is administered by The Benefit Practice, a third-party administrator (TPA). The Plan's trustee is John Hancock Trust Company, LLC (John Hancock Trust). As of December 31, 2024 and 2023, the investment manager, custodian and party which directs the custody and management of the Plan's assets is John Hancock Retirement Plan Services (John Hancock Retirement).
- c) *Contributions* – Each year participants may make pretax and/or Roth 401(k) contributions to the Plan of up to 100% of their annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated multi-index preservation fund until changed by the participant. The Company currently matches 50% of the first 6% of the employee elective contributions. Furthermore, the Company may elect to make discretionary profit-sharing contributions to the Plan. For the year ended December 31, 2024, the Company did not make any discretionary contributions.
- d) *Participant Accounts* – Each participant's account is credited with participant's contribution, the employer's matching contribution, Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e) *Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 100% vested after 6 years of credited service or immediately upon death or disability.
- f) *Administrative Expenses* – Loan fees, investment fees, and administrative costs associated with Plan operations and compliance are paid first from forfeitures and then from individual participant accounts.

1. **Description of Plan, continued**

- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct the investment of their contributions to any of the investment options offered in the John Hancock Retirement program and determined by the Plan Administrator. Participants may change their investment options via phone or Internet access to John Hancock Retirement at any time.
- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan is taken (currently Prime Rate plus 2%). The interest rates on participant loans receivable as of December 31, 2024 and 2023 range from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions. Participant loans are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments in the Form 5500, and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the participant's life expectancy. In-service distributions are permitted for employees attaining age 59 ½. Hardship distributions are also permitted from all accounts that are fully vested.
- j) *Forfeited Accounts* – Forfeitures of non-vested accounts are used to pay administrative expenses. Total forfeitures available as of December 31, 2024 and 2023 amounted to \$20,591 and \$2,382, respectively. During the year ended December 31, 2024, \$17,714 was forfeited by employees, and \$0 was applied to administrative fees.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c) *Payment of Benefits* – Benefits are recorded when paid.

2. **Summary of Significant Accounting Policies, continued**

- d) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds and mutual funds held in common collective trust) are reported at fair value of the fund's quoted market price, which represents the net asset value (NAV) as quoted by the custodian of the shares held by the Plan at year end. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchases and sales of securities are recorded on a trade-date basis.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rate, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments are shares of mutual funds and common collective trust managed by the custodian. Change in the custodian's management may affect operating results of the funds adversely. Additionally, the financial position of the Plan Sponsor, Hulett Environmental Services, Inc., may have a significant impact on the Plan. Specifically, this includes the ability of the Plan Sponsor to continue to make contributions under the program and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan and the Plan assets include legislation or regulations established by the Internal Revenue Service, Employee Retirement Income Security Act of 1974 (ERISA), and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

3. Fair Value Measurements, continued

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions provide the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- a) *Mutual funds, including those held in common collective trust* – Valued at quoted market prices of a national security exchange on the last business day of the year, of units held by the Plan at year end.

5. Related Party Transactions

Certain plan investments include shares of mutual funds and common collective trust managed by John Hancock Retirement. John Hancock Retirement is the investment manager and custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

The Plan is utilizing a Non-Standardized Pre-Approved Profit-Sharing Plan document provided by its TPA at the time of adoption – The Benefit Practice. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Plan has an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although the Company intends the Plan to be permanent and continuing, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded, or required to be funded, must be distributed to the participants.

8. Subsequent Events

Plan's management has evaluated subsequent events through July 28, 2025, the date on which the financial statements were available to be issued, and determined no additional disclosures were required to be presented in these financial statements.
