### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Knauf Insulation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Knauf Insulation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Knauf Insulation Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was organized effective April 17, 1978, as a defined contribution retirement savings plan for eligible employees of Knauf Insulation, LLC (the Employer) and its participating affiliates Knauf Insulation e-Services US Inc., Knauf Digital LLC, and 2M Resources Corp. The Plan also allows eligible employees covered under the collective bargaining agreement with Teamsters, Local 137 (Local 137) to participate in the Plan. The Plan covers all eligible employees who are age 18 or older and not covered by the Glass, Molders, Pottery, Plastics and Allied Workers of the International Union, Local No. 32 collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

**Contributions**

Each year, participants may authorize the Employer to contribute to the Plan, as a pre-tax 401(k), or Roth contribution, up to 50% of their eligible annual compensation, subject to the maximum annual amount permitted under the Internal Revenue Code (IRC). The Plan also allows for after-tax contributions for all eligible employees except for Local 137 employees. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees (excluding Local 137) are automatically enrolled in the Plan unless an affirmative election not to participate in the Plan is executed. Automatically enrolled participants have their contribution rate set at 6% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

The Employer makes safe-harbor matching contributions of 100% on the first 6% of compensation that each participant contributes to the Plan (excluding Local 137). The Employer may elect to make discretionary matching and other contributions to the Plan. There were no Employer discretionary matching or other contributions for the years ended December 31, 2024 and 2023. Each participant is eligible to receive Employer discretionary and safe-harbor matching contributions after completing 1,000 hours and one year of service, beginning on the first pay date of the calendar quarter following completion of the service requirement.

**Contributions (Continued)**

For Local 137 participants, the Employer makes matching contributions up to 3% of eligible compensation that each participant contributes to the Plan as follows:

For Local 137 participants, the Employer also makes safe harbor nonelective contributions equal to 3% of eligible compensation to the Plan.

Participants direct the investment of their contributions, as well as those made by the Employer and its participating affiliates, into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Employer and its participating affiliates' matching contributions, as well as allocations of the Employer matching, other, and nonelective contributions and Plan earnings. Participants may be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings or account balances, or specific transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and Forfeited Accounts**

Participants are vested immediately in their contributions, Employer safe-harbor matching and other contributions, and Employer safe harbor nonelective (Local 137) contributions plus actual earnings thereon. Vesting in the Employer and its participating affiliates' matching contributions portion of their account is based on years of credited service. A participant becomes 100% vested after three years of service for Local 137 matching contributions.

**Vesting and Forfeited Accounts (Continued)**

At December 31, 2024 and 2023, forfeited nonvested accounts of terminated participants totaled \$10,346 and \$2,048, respectively. These accounts will be used to reduce future Employer contributions or pay Plan expenses. In 2024 and 2023, forfeited nonvested accounts of \$-0- and \$1,853 were used to reduce Employer contributions, respectively. In 2024 and 2023, \$737 and \$6,860 were used to pay Plan expenses, respectively.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes cannot exceed five years except for the purchase of the participant's principal residence, for which the terms may exceed five years per the Plan document. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.

**Benefit Payments**

Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan document, a participant may elect to receive a lump-sum cash distribution equal to the value of the participant's vested interest in his or her account, or monthly installments. The Plan allows for in-service withdrawals, as defined in the Plan document, from a participant's rollover account, and hardship distributions subject to Plan provisions. If the value of the vested interest in a participant's account is \$7,000 or less, the participant's account will be cashed out by distributing the vested interest in the account in a single-sum payment or by direct rollover to an IRA or other eligible retirement plan as soon as reasonably practicable following the date employment terminates. The account will be cashed out even if the participant does not consent to the distribution.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor, insurance company, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments and the Plan administrator deems the note receivable from the participant to be in default, the balance of the note receivable from the participant is reduced, and a benefit payment is recorded per the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses for maintaining the Plan may be paid by the Employer or the Plan, at the Employer's discretion. Expenses paid by the Employer are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Deferred Contributions**

Deferred contributions represent amounts contributed to the Plan during the year ended December 31, 2024 that relate to payroll dates in January 2025.

**Subsequent Events**

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

**NOTE 3 INVESTMENT INFORMATION CERTIFIED BY INSURANCE COMPANY AND TRUSTEE**

Empower Annuity Insurance Company (formerly Prudential Insurance and Annuity Company), the Insurance Company, and Empower Trust Company (formerly Prudential Bank & Trust, FSB), the Trustee, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract with Empower. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan, ERISA, and the IRC. In the event of Plan termination, each investment fund shall be valued, and all accounts and sub-accounts shall be adjusted with any unallocated contributions or forfeitures being allocated as of the termination date. All participant accounts shall be disposed of or for the benefit of each participant or beneficiary and the vested interest of each participant and beneficiary in employer contributions shall be 100%.

**NOTE 8 PLAN TAX STATUS**

The Plan obtained its latest determination letter dated May 24, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with applicable requirements of the IRC and is, therefore, not subject to tax under current income tax law. The Plan administrator believes that the Plan, as amended, is currently designed and being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. As a result, no provision for income tax is required.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)**

Certain Plan investments are managed by Empower and therefore, transactions in these investments qualify as exempt party-in-interest transactions under ERISA. Empower also received indirect fees from investments which are deducted from investment returns. In 2024 and 2023, direct fees paid by the Plan to the Insurance Company and Trustee and their affiliates totaled \$158,405 and \$169,414, respectively. In 2024 and 2023, direct fees were paid by the Employer to the Plan's auditors and excluded from the financial statements. In 2024 and 2023, direct fees paid by the Plan to Capital Strategies Investment Group totaled \$42,599 and \$71,270, respectively. Capital Strategies Investment Group is a Registered Investment Advisor as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. The Employer provides certain accounting, administrative, and investment management services to the Plan for which it receives no compensation. Notes receivable from participants are permitted party-in-interest transactions.

**NOTE 10 NON-EXEMPT TRANSACTION**

During the year ended December 31, 2024, the Employer failed to remit certain employee deferral contributions totaling \$118 during within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The employer remitted the missed contributions in January 2025 and is currently working with Empower to determine the lost earnings associated with the late contributions.

**NOTE 11 SUBSEQUENT EVENTS**

The Plan was amended effective February 1, 2025 to remove 2M Resources Corp. as a participating employer in the Plan.

### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Knauf Insulation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Knauf Insulation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Knauf Insulation Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Knauf Insulation Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

***Other Matter — Supplemental Schedules Required by ERISA***

The supplemental schedule of delinquent participant contributions and schedule of assets (held at end of year) as of or for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Knauf Insulation Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was organized effective April 17, 1978, as a defined contribution retirement savings plan for eligible employees of Knauf Insulation, LLC (the Employer) and its participating affiliates Knauf Insulation e-Services US Inc., Knauf Digital LLC, and 2M Resources Corp. The Plan also allows eligible employees covered under the collective bargaining agreement with Teamsters, Local 137 (Local 137) to participate in the Plan. The Plan covers all eligible employees who are age 18 or older and not covered by the Glass, Molders, Pottery, Plastics and Allied Workers of the International Union, Local No. 32 collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

**Contributions**

Each year, participants may authorize the Employer to contribute to the Plan, as a pre-tax 401(k), or Roth contribution, up to 50% of their eligible annual compensation, subject to the maximum annual amount permitted under the Internal Revenue Code (IRC). The Plan also allows for after-tax contributions for all eligible employees except for Local 137 employees. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees (excluding Local 137) are automatically enrolled in the Plan unless an affirmative election not to participate in the Plan is executed. Automatically enrolled participants have their contribution rate set at 6% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

The Employer makes safe-harbor matching contributions of 100% on the first 6% of compensation that each participant contributes to the Plan (excluding Local 137). The Employer may elect to make discretionary matching and other contributions to the Plan. There were no Employer discretionary matching or other contributions for the years ended December 31, 2024 and 2023. Each participant is eligible to receive Employer discretionary and safe-harbor matching contributions after completing 1,000 hours and one year of service, beginning on the first pay date of the calendar quarter following completion of the service requirement.

**Contributions (Continued)**

For Local 137 participants, the Employer makes matching contributions up to 3% of eligible compensation that each participant contributes to the Plan as follows:

For Local 137 participants, the Employer also makes safe harbor nonelective contributions equal to 3% of eligible compensation to the Plan.

Participants direct the investment of their contributions, as well as those made by the Employer and its participating affiliates, into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Employer and its participating affiliates' matching contributions, as well as allocations of the Employer matching, other, and nonelective contributions and Plan earnings. Participants may be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings or account balances, or specific transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and Forfeited Accounts**

Participants are vested immediately in their contributions, Employer safe-harbor matching and other contributions, and Employer safe harbor nonelective (Local 137) contributions plus actual earnings thereon. Vesting in the Employer and its participating affiliates' matching contributions portion of their account is based on years of credited service. A participant becomes 100% vested after three years of service for Local 137 matching contributions.

**Vesting and Forfeited Accounts (Continued)**

At December 31, 2024 and 2023, forfeited nonvested accounts of terminated participants totaled \$10,346 and \$2,048, respectively. These accounts will be used to reduce future Employer contributions or pay Plan expenses. In 2024 and 2023, forfeited nonvested accounts of \$-0- and \$1,853 were used to reduce Employer contributions, respectively. In 2024 and 2023, \$737 and \$6,860 were used to pay Plan expenses, respectively.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes cannot exceed five years except for the purchase of the participant's principal residence, for which the terms may exceed five years per the Plan document. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.

**Benefit Payments**

Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan document, a participant may elect to receive a lump-sum cash distribution equal to the value of the participant's vested interest in his or her account, or monthly installments. The Plan allows for in-service withdrawals, as defined in the Plan document, from a participant's rollover account, and hardship distributions subject to Plan provisions. If the value of the vested interest in a participant's account is \$7,000 or less, the participant's account will be cashed out by distributing the vested interest in the account in a single-sum payment or by direct rollover to an IRA or other eligible retirement plan as soon as reasonably practicable following the date employment terminates. The account will be cashed out even if the participant does not consent to the distribution.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor, insurance company, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments and the Plan administrator deems the note receivable from the participant to be in default, the balance of the note receivable from the participant is reduced, and a benefit payment is recorded per the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses for maintaining the Plan may be paid by the Employer or the Plan, at the Employer's discretion. Expenses paid by the Employer are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Deferred Contributions**

Deferred contributions represent amounts contributed to the Plan during the year ended December 31, 2024 that relate to payroll dates in January 2025.

**Subsequent Events**

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

**NOTE 3 INVESTMENT INFORMATION CERTIFIED BY INSURANCE COMPANY AND TRUSTEE**

Empower Annuity Insurance Company (formerly Prudential Insurance and Annuity Company), the Insurance Company, and Empower Trust Company (formerly Prudential Bank & Trust, FSB), the Trustee, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract with Empower. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)**

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan, ERISA, and the IRC. In the event of Plan termination, each investment fund shall be valued, and all accounts and sub-accounts shall be adjusted with any unallocated contributions or forfeitures being allocated as of the termination date. All participant accounts shall be disposed of or for the benefit of each participant or beneficiary and the vested interest of each participant and beneficiary in employer contributions shall be 100%.

**NOTE 8 PLAN TAX STATUS**

The Plan obtained its latest determination letter dated May 24, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with applicable requirements of the IRC and is, therefore, not subject to tax under current income tax law. The Plan administrator believes that the Plan, as amended, is currently designed and being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. As a result, no provision for income tax is required.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)**

Certain Plan investments are managed by Empower and therefore, transactions in these investments qualify as exempt party-in-interest transactions under ERISA. Empower also received indirect fees from investments which are deducted from investment returns. In 2024 and 2023, direct fees paid by the Plan to the Insurance Company and Trustee and their affiliates totaled \$158,405 and \$169,414, respectively. In 2024 and 2023, direct fees were paid by the Employer to the Plan's auditors and excluded from the financial statements. In 2024 and 2023, direct fees paid by the Plan to Capital Strategies Investment Group totaled \$42,599 and \$71,270, respectively. Capital Strategies Investment Group is a Registered Investment Advisor as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. The Employer provides certain accounting, administrative, and investment management services to the Plan for which it receives no compensation. Notes receivable from participants are permitted party-in-interest transactions.

**NOTE 10 NON-EXEMPT TRANSACTION**

During the year ended December 31, 2024, the Employer failed to remit certain employee deferral contributions totaling \$118 during within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The employer remitted the missed contributions in January 2025 and is currently working with Empower to determine the lost earnings associated with the late contributions.

**NOTE 11 SUBSEQUENT EVENTS**

The Plan was amended effective February 1, 2025 to remove 2M Resources Corp. as a participating employer in the Plan.
