Opinion

We have audited the accompanying financial statements of Butler-Zanesville Works Hourly and Salaried Union Retirees Health Care Fund, which comprise the statements of net assets available for plan benefits and of plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.



NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Butler-Zanesville Works Hourly and Salaried Union Retirees Health Care Fund (The “Fund”) provides limited information. Participants should refer to the Summary Plan Description for a more complete description of the Funds’ provisions.

General

The Butler Portion of the Fund and its associated Trust were established pursuant to two settlement agreements between AK Steel (The “Company”), and the United Auto Workers and Butler Armco Independent Salaried Union. This portion of the Fund is a welfare benefit plan and was established March 1, 2011.

The Zanesville Portion of the Fund and its associated Trust were established pursuant to a settlement agreement with AK Steel. This portion of the Fund is a welfare benefit plan and was established May 1, 2013. At the same time, it was merged with the Butler Works Hourly and Salaried Union Retirees Health Care Fund.

The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Funding

The Company was obligated to contribute to the Trust under the terms of the agreements. Butler received \$81,900,000.00 in total over a period of 3 years ending in 2013. Zanesville received \$9,325,000.00 in total over a period of 3 years ending in 2015. The ongoing cost of the coverage will be paid from the assets of the Plan and contributions from eligible participants.

Benefits

For retirees and dependents under 65, medical benefits are provided through the Steelworkers Health and Welfare Fund and administered by Highmark Blue Cross. Prescription drugs are covered through Highmark Blue Cross and dental benefits are provided through Delta Dental PPO.

For retirees and dependents over 65, medical benefits and prescription drugs are provided through the United Healthcare Medicare Advantage Plan PPO. Dental benefits are provided through Delta Dental PPO. Medicare eligible participants may apply for reimbursement of their Medicare Part B premium up to set limits (this benefit is subject to annual Trustee approval).

There is a death benefit on the life of the retiree which is subject to change by the Trustees.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America. Significant accounting policies are summarized below:

Date of Management’s Review of Subsequent Events - Subsequent events were evaluated through the date of the Independent Auditor’s Report, which is the date the financial statements were available to be issued, and it was determined that there were no subsequent events that require disclosure.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance. The trustees also determine the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Income Tax Status - The plan obtained its latest determination letter in 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. Plan management and Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Postretirement Benefit Obligations - Postretirement benefit obligations represent the total actuarial present value of those estimated future benefits that are attributed to employee service rendered through the date of the statement of Plan's benefit obligations. Postretirement benefits include future benefits expected to be paid to or for currently retired or terminated employees and their beneficiaries and dependents.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to estimate future annual premium costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Recognition of Benefits - Benefits are recognized when paid.

Plan Benefit Obligations

Amounts Currently Payable - The amount reported as amounts currently payable to or for participants represents benefits incurred prior to December 31, and paid in the subsequent year.

For measurement purposes, a 7.00 percent annual rate of increase in medical/drug costs is assumed for the year ended December 31, 2025; the rates are assumed to decrease by .50 percent to 5.00 percent after 4 years and to remain at that level thereafter.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 by \$ 2,628,745 and by \$ 2,640,249 as of December 31, 2023.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements – There are currently no investments classified as Level 2.

Level 3 Fair Value Measurements - For those assets with fair value measured using Level 3 inputs the Fund determines the fair value measurement using available current market conditions and other applicable third party information.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.


