1) Description of Plan

The Kymera Independent Physicians 401(k) Plan (the "Plan") was initially established on January 1, 2003, and was adopted by Kymera Independent Physicians, the Sponsor of the Plan. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Kymera Independent Physicians (the "Company") who are at least 21 years of age and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

The Plan has been restated at various dates since its inception to comply with new ERISA standards as they are issued by the U.S. Department of Labor.

Contributions

Participants may contribute up to the maximum annual limits defined by the IRS. Participants may also contribute rollover amounts in cash from other qualified plans, including plans described by IRC 401(a), 403(a), 403(b) and 457(b). The Plan has elected to be a safe harbor plan and the Plan Sponsor makes a safe harbor contribution equal to 3% of compensation for all eligible participants, and all participants are immediately fully vested in these contributions. The Plan Sponsor may elect to make additional contributions at the discretion of the Plan Sponsor's Board of Directors and are allocated to qualified participants as defined by the Plan. The Company is not obligated to make future contributions to the Plan and has no control over the Plan assets other than through its ability to appoint administrators to the Plan.

Participants direct the investment of their elective deferrals, employer safe harbor contributions, and discretionary contributions among investment options offered by the Plan. The amounts contributed may not exceed the maximum amounts prescribed by law.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (1) the employer's contributions, and (2) Plan earnings charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1) Description of Plan — continued

Forfeited Accounts

Forfeited portions of terminated participant's nonvested employer contribution accounts are available to meet the Employer's contribution obligations to the Plan or to pay Plan expenses, as directed by the Plan Administrator. Forfeited amounts originated from prior amendments of the Plan which had vesting provisions for employer contributions. At December 31, 2024 and 2023, there were \$12,482 and \$12,398, respectively, of forfeited nonvested accounts.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions into several investment options offered by Lincoln Financial Group. The investment options are registered investment companies and pooled separate accounts with underlying investments being primarily in the form of mutual funds.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to 50 percent of the participant's vested account balance. The number of outstanding loans for a participant is limited to one. Loan terms range from one to five years or up to 30 years if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with the local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 8.50% on loans outstanding at December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

Vesting

Participants are immediately vested in their employee deferral and related earnings, employer safe-harbor contributions, and discretionary profit-sharing contributions.

Payments of Benefits

On termination of service due to death, disability or retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account or receive annual installments. For terminated participants that have a vested balance of less than \$5,000, the Plan administrator may distribute the entire vested benefit amount in a single lump sum. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

The Plan provides for automatic rollover of a mandatory distribution greater than \$1,000 for which the participant does not elect to have such distribution either paid directly to an eligible retirement plan or to receive the distribution directly. The distribution will then be made in a direct roll over to an individual retirement account designated by the Plan administrator.

1) Description of Plan — continued

Plan Termination

Although it has not expressed an interest to do so, the Sponsor has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to ERISA provisions. In the event of Plan termination, participants will receive the full amount of their accounts.

Upon such termination of the Plan or complete discontinuance of contributions, after payment of all expenses and proportionate adjustments of accounts to reflect such expenses and fund losses or profits, each participant shall be entitled to receive any amounts then credited to the participant's account in the Plan. The participants' respective interests as they exist at the time shall be deemed fully vested. The Trustee may make payments of such amounts in cash or in assets of the Plan or in the form of immediate or deferred annuities as the Plan Administrator shall in his sole discretion direct.

Tax Status

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements presented have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments are recorded when paid.

Investment Valuation and Income Recognition

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value. If available, quoted market prices are used to value investments. In accordance with valuing investments at fair value, the net unrealized appreciation or depreciation is presented in the statement of changes in net assets available for benefits.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses incurred in the administration of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are expenses charged to the underlying funds by the fund managers and are included in administrative expenses. Certain asset management and service fees are paid by the Plan and allocated to participants' accounts on a quarterly basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

3) Information Prepared and Certified by the Custodian

The following information, included in the accompanying financial statements and the Schedule of Assets (Held at End of Year) was obtained from data that has been prepared and certified as complete and accurate by the custodian of the Plan. Lincoln Financial Group Trust Company, Inc. served as the custodian as of December 31, 2024 and 2023, and during the years ended December 31, 2024 and 2023.

- a. Total investments at fair value as shown in the accompanying statements of net assets available for benefits were \$7,232,119 and \$6,802,086 at December 31, 2024 and 2023, respectively.
- b. Notes receivable from participants were \$102,514 and \$100,703 at December 31, 2024 and 2023, respectively.
- c. Net appreciation in the fair value of investments as shown in the accompanying statements of changes in net assets available for benefits were \$517,612 and \$692,244 during the years ended December 31, 2024 and 2023, respectively.
- d. Interest and dividend income on investments was \$35,271 and \$30,211 during the years ended December 31, 2024 and 2023, respectively.
- e. Interest income on notes receivable of \$8,330 and \$4,955 during 2024 and 2023, respectively.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

4) Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4) Fair Value Measurements – continued

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The hierarchy is measured in three levels based on the reliability of the inputs:

Level 1 Fair Value Measurements – Valuations based on unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

Level 2 Fair Value Measurements – Valuations based on inputs other than quoted prices included within Level 1 that are observable for the asset, either directly and indirectly. Observable inputs include quoted prices for similar assets active or non-active markets.

Level 3 Fair Value Measurements – Valuations derived through the use of valuation models or methodologies using significant unobservable inputs. Level 3 valuations incorporate certain assumptions and projections that are not observable in the market and as a result significant professional judgment may be used in determining the fair values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies – Valued at the net asset value of shares held by the Plan at the end of each day, which is determined by quoted prices in an active market.

Pooled Separate Account – Valued at the net asset value of shares held (or its equivalent) by the Plan at the end of each day as a practical expedient and are not categorized in the fair value hierarchy.

5) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

6) **Related Parties**

The Plan’s investments in registered investment companies and pooled separate accounts include assets managed by the Plan’s custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and third-party administrator fees amounted to \$54,203 and \$41,802 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
