## NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. PLAN DESCRIPTION

The following description of the Cline Design Employee Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General –Cline Design Associates, PA (the "Company") established the Plan effective January 1, 2022. The Plan was designed to operate, as a leveraged employee stock ownership plan ("ESOP"). The Plan was designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 as amended ("IRC"), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan trustee is Miquel Paredes. The Plan is administered by the ESOP Trust and Plan Committee.

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

The Plan was amended with an effective date of January 1, 2024, to increase the mandatory cashout limit to \$7,000 reflect changes in accordance with SECURE and SECURE 2.0.

On November 16, 2022, the ESOP Trust acquired from two of the Company's shareholders 158,599.5487 shares of common stock at a cost of \$4,876,936. The shares were acquired in exchange for a note payable to the Company shareholders (the "ESOP Note").

The terms of the ESOP note require the Company to fund the ESOP sufficiently to pay the Plan's obligation under the ESOP Note. The Company may make additional payments to the ESOP at the discretion of management. The ESOP is required under the terms of the ESOP Note to pay principal and interest to the Company.

The borrowing is to be repaid over a period of 19 years by fully deductible Company contributions to the trust fund. Because of the Plan's outstanding obligation for the debt related to the purchase of Company stock, the Company is required to contribute sufficient amounts to service the current year's principal and interest payments on the obligation. As the Plan makes each payment of principal, as appropriate percentage of stock is allocated to eligible employees' accounts in accordance with applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares of stock and guaranteed by the Company. The lender has no rights against the shares of common stock once they are allocated to the participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, present

separately the assets and liabilities and changes therein pertaining to:

- a. the accounts of employees with vested rights in allocated common stock (“Allocated”) and
- b. common stock not yet allocated to employees (“Unallocated”).

Eligibility - Employees of the Company are eligible to participate in the Plan upon reaching age 21 and completing at least 1,000 hours during the Plan year. Employees who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are not eligible for an allocation of Company contributions for such year.

Contributions - The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan’s dividend and interest earnings, as applicable, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Participant contributions are not permitted. During the year ended December 31, 2024, the Company contributed \$347,084.

Payment of Benefits – Distributions on account of death, disability, or retirement are paid out by the end of the following Plan year. If a participant reaches normal retirement date and has reached the 10<sup>th</sup> anniversary of the year in which such participant commenced participation in the Plan may begin to receive distributions of their account by the 60<sup>th</sup> day following the Plan year. A participant who terminates employment prior to normal retirement age, other than upon death or disability, may elect to begin to receive distribution of their vested account by the end of the sixth Plan year following the plan year in which termination occurs. If a terminated participant’s balance is less than \$1,000, distribution is made in a lump-sum payment as soon as administratively feasible after the close of the Plan year in which the participant’s employment terminates. If the terminated participant’s balance exceeds \$1,000 but is less than \$7,000, then the participant may elect to receive the vested account balance in a lump sum by the end of the following Plan year. Distributions are made in Company stock, cash or a combination of Company stock and cash in the discretion of the Plan administrator in a uniform and discriminatory manner. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Voting Rights – All Company stock in the Trust shall be voted by the Trustee. Each participant or beneficiary in the Plan is entitled to direct the Trustee as to the manner in which voting rights on shares of Company Stock which are allocated to the Company stock account of such participant or beneficiary are to be exercised with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all of the Company’s assets, or such similar transaction as the secretary may prescribe in the Treasury Regulations.

Participant Accounts – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each Plan year with an allocation of the Company’s common stock released by the Trustee from the unallocated account and forfeitures of terminated participants’ non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations, including fractional shares, earnings and losses are based on the participant’s compensation for that plan year as a percentage of total compensation for all eligible

participants for that year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting - If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, the participant would vest in the balances in their account based on total years of service with the Company. Employees vest 20% per year after completing two years of service until becoming 100% vested after six years of credited service in accordance with the Plan document.

Put Option - Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. In accordance with Code section 401(a)(9), participants who have 10 years of Plan participation and reach age 55 are eligible to diversify a portion of the employer securities held in their ESOP accounts. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of the shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. For participants who elect to diversify, the value of the diversified shares may transferred to another qualified Plan of the employer with at least three investment options. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeitures – Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participant accounts for the years ended December 31, 2024 and 2023, totaled \$8,319 and \$9,423, respectively. Forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023, were \$0.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Allocations – The financial statements of the Plan present separately the assets and liabilities and changes therein, pertaining to (a) accounts of employees with rights in allocated stock (“allocated”)

and (b) stock not yet allocated to employees (“unallocated”), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition – The shares of the Company’s common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the trustee and an independent annual appraisal.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan’s gains and losses on the investments bought and sold as well as held during the year.

Operating Expenses - As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. All expenses of maintaining the Plan are paid by the Company.

Payment of Benefits - Benefit payments to participants are recorded when paid.

Administrative Expenses - Administrative expenses of the Plan are paid by the Plan or by the Company, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

### 3. INVESTMENTS

### 4. FAIR VALUE MEASUREMENTS

Fair Value Measurements, in accordance with current accounting standards, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Company Common Stock:* The fair value of the investment in common stock of the Company held by the Plan is valued at an estimated fair value as determined by an independent annual appraisal. Due to significant unobservable inputs included in the valuation model for the Company common stock, the resulting fair value of this investment is classified as a level 3.

The Plan recognizes transfers between the levels as of the beginning of the reporting period. There were no transfers between the levels for the years ended December 31, 2024 and 2023.

There were no purchases/sales or transfers of level three assets for the years ended December 31, 2024 and 2023. There was a net appreciation in fair value for the Company stock for the year ended December 31, 2024 equal to \$765,519.

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation (depreciation) in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

The fair value of the investment in common stock of the Company held by the Plan is valued at an estimated fair value as determined by an independent annual appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years as illustrated in the following table for the year ended December 31, 2024.

The valuation process involves the selection of an appraiser under contract for a term of three years with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. NOTES PAYABLE

On November 16, 2022, the Company and Cline Design Employee Stock Ownership Trust entered into a note and pledge arrangement in the amount of \$4,876,936. The proceeds of the loan were used to purchase Company common stock. The ESOP acquired from two of the Company's shareholders 158,599 shares of common stock at a cost of \$4,876,936. The shares were acquired in exchange for a note payable to the Company's President (the "ESOP Note"). The ESOP Note and Exchange Note bear interest at 3.92%. The ESOP note requires annual payments of principal and interest of \$344,532 due on December 31 each year through 2041 and are secured by the shares

of unallocated Company common stock held by the ESOP plus any dividends accrued.

The agreement provides for the loan to be repaid over a total of 19 years with a due date of December 31, 2041. The fair value of the note payable as of December 31, 2024 and 2023 was \$4,217,592 and \$4,390,035, respectively. The interest rate is fixed at 3.92% per annum.

Unallocated shares are used as collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments.

This resulted in 7,929.97744 shares being released and allocated for the Plan year ended December 31, 2024.

#### 6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and exempt party-in-interest transactions. As described in Note 1, the Company has historically paid all Plan administrative expense. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

#### 7. PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

#### 8. FEDERAL INCOME TAX STATUS

The Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan and the related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 9. ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Company common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee

through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

#### 10. RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock which is exposed to various risks such as interest rate, market, and credit risks as well as valuation assumption based on earnings, cash flows, and other such techniques. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of common stock will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

#### 11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.
