Notes to Financial Statements

1. Plan Description

The following description of the Construction Specialties, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all employees of Construction Specialties, Inc. (the Company or the Employer) and its domestic participating subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Vanguard Fiduciary Trust Company is the trustee, and The Vanguard Group, Inc. provides administrative services to the Plan.

Eligibility

The Plan allows employees to participate and contribute to the Plan on the first day following completion of 30 days of eligible service. There is no minimum age requirement. In order to become eligible for the safe harbor non-elective and Employer discretionary matching contributions, full-time employees must complete a 30-day period of service. Part-time employees have to complete at least 1,000 hours of service to qualify for both safe harbor non-elective and Employer discretionary matching contributions. Eligibility for discretionary profit-sharing contributions requires all eligible employees to complete 1,000 hours and one year of service, as defined. Collectively bargained employees, non-resident aliens, and leased employees are excluded from participation in the Plan.

Contributions

A participant may contribute any amount under the deferred salary 401(k) provisions of the Plan, subject to annual Internal Revenue Service (IRS) limitations. Rollovers from other qualified plans and catch-up contributions are allowed. For 2024 and 2023, the Plan incorporated safe harbor provisions. As a result, the Employer makes a non-elective safe harbor contribution to the account of each eligible participant in an amount equal to 3% of participants' eligible compensation for the Plan year subject to annual IRS limitations. The safe harbor contributions for the years ended December 31, 2024 and 2023 totaled \$2,018,897 and \$2,020,293, respectively.

The Company provides a discretionary matching contribution of all or part of a participant's contribution under the 401(k) provisions as determined prior to the beginning of each Plan year. Effective January 1, 2022, the Company's discretionary matching contributions are credited and funded to participants' accounts at each payroll cycle upon completing the service requirement. For the years ended December 31, 2024 and 2023, the Company provided a discretionary matching contribution of 100% of salary deferrals up to 2.25% of gross pay, as defined, for all eligible participants. The discretionary matching contributions for the years ended December 31, 2024 and 2023 totaled \$1,085,767 and \$1,050,020, respectively.

The Plan also permits the Company to make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant contributions and an allocation of (i) any discretionary profit-sharing contributions, (ii) any discretionary matching contributions, (iii) any non-elective safe harbor contributions, and (iv) Plan earnings or losses. Allocations of the Company's contributions are based on participant gross pay, account balance, or participant deferrals, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Funds and Vesting

The Plan's provisions grant the Construction Specialties, Inc. Corporate Retirement Savings Committee (the Investment Committee) the sole discretionary authority to establish or designate investment funds, each having different investment objectives and policies to provide participants with opportunities for diversification, various risk/return alternatives, and to reasonably accommodate anticipated investment preferences among Plan participants. The Investment Committee has the right, exercisable upon reasonable notice to the participants, to (i) add or eliminate a separate investment fund, and (ii) terminate any and all separate investment funds. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Participants may elect to direct their deferrals, after-tax savings, or rollover contributions in any of the available investment options. All Company contributions are credited to investment funds as directed by the participant.

Participants are 100% vested in their contributions and the Company's non-elective safe harbor contribution when made. Effective September 1, 2022, the discretionary profit-sharing contributions and discretionary Company matching contributions vest as follows:

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum or in installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or in installments. Hardship withdrawals are available, as are distributions to participants who have attained the age of 59½. Participants may withdraw up to 100% of the balance in his or her elective deferral account and up to 100% of the vested balance in his or her rollover account for financial hardships, as defined.

Forfeitures

A participant becomes fully vested in the case of death, permanent disability, or upon normal or early retirement, as defined. The non-vested account balances of participants who terminated for any reason other than death, disability, or retirement can be used to offset future Employer contributions or to pay Plan expenses. For the years ended December 2024 and 2023, no amounts were applied from the forfeiture account to offset Employer contributions or to pay plan expenses. During the year ended December 31, 2024, \$46,368 of uncashed checks, due to withdrawing participants, was deposited to the forfeiture account. These checks will be reissued in the subsequent period. As of December 31, 2024 and 2023, net assets available for benefits include \$104,319 and \$47,267, respectively, of forfeitures, which can be used to reduce future Employer contributions.

Notes Receivable from Participants

Participants may borrow from their participant accounts an amount not to exceed a maximum of \$50,000, or 50% of the participant's vested account balance, whichever is less. Participants may borrow a minimum of \$1,000 and are allowed up to three loans outstanding at a time. The notes are secured by the participant's vested account balance and, except for funds used to acquire a principal residence, must have a repayment period of generally no greater than five years. The interest rates for the notes outstanding as of December 31, 2024 and 2023 were from 4.25% to 9.50%. Loans bear a fixed rate of interest at the prime rate plus 1% at loan origination. Principal and interest are paid ratably through payroll deductions made on a weekly basis. Repayment of the entire balance is permitted at any time.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on an accrual basis.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain administrative expenses are paid by the Plan to the extent not paid for by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses are charged to participants for loan processing fees and shareholder servicing fees. The Plan is also responsible for certain administrative expenses, including investment advisory and recordkeeping fees relating to the management of Plan assets.

Direct compensation paid by the Plan for certain administrative expenses, including investment advisory and recordkeeping fees, totaled \$123,935 and \$121,578 for the years ended December 31, 2024 and 2023, respectively.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies for plan assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Money Market Fund - The Vanguard Federal Money Market Fund invests in U.S. government securities and seeks to provide current income and preserve shareholders' principal investments. Although the fund invests in short-term, high-quality securities, the amount of income that a shareholder may receive will be largely dependent on the current interest rate environment. The money market fund investment held by the Plan is actively traded. The Vanguard Federal Money Market Fund's investment objective is to seek to provide current income while maintaining liquidity and a stable share price of \$1. The money market fund is valued at the unadjusted quoted market prices, which represent the net asset value (NAV) of shares owned by the Plan at year-end. As such, these investments are classified as Level 1.

Mutual Funds - Mutual funds primarily consist of publicly traded funds of registered investment companies. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds - Common collective trust funds are valued using the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The beneficial interest of each participant is represented in units. Units are issued and redeemed daily at the fund's closing NAV.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the Plan and all participants' accounts shall become fully vested and will be distributed in accordance with the provisions of the Plan.

The Company may reduce or suspend the non-elective safe harbor contributions upon satisfaction of certain requirements provided under IRS Bulletin No. 2013-50, including a 30-day advanced notice to all eligible employees.

5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution.

6. Tax Status

The Plan uses a pre-approved plan document sponsored by the Vanguard Group. The Vanguard Group received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal, state, and/or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest and Related Party Transactions

Construction Specialties, Inc. (the Plan sponsor) and Vanguard Fiduciary Trust Company (the trustee) are parties-in-interest with respect to the Plan under the provisions of ERISA. Notes receivable from participants also qualify as party-in-interest transactions. Plan investments include shares of registered investment companies managed by the trustee; therefore, these transactions qualify as

party-in-interest transactions. Investment-related fees are reflected as an offset of net investment income and are not readily determinable.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

For the purpose of determining the effects of subsequent events on these financial statements, the Plan's management has evaluated events through August 15, 2025, the date on which the financial statements were available to be issued. There were no material recognizable subsequent events noted.
