Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of C&D Technologies Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of C&D Technologies Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of C&D Technologies, Inc. and, effective April 1, 2020, Trojan Battery Company (collectively, the "Company"), with the exception of residents of Puerto Rico, leased employees, independent contractors, or nonresident aliens with no U.S. income. Employees of the Attica, Indiana facility are eligible to participate on the first day of the month following 90 days of service. All other employees are eligible to participate on the first day of the month following the first day of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for tax-deferred contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also provides for after-tax employee deferral contributions. Deferral contributions are limited to 90 percent of annual compensation. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Newly eligible employees are automatically enrolled in the Plan based on the aforementioned eligibility dates unless they affirmatively decline to participate.

The Plan provides for employer matching contributions, up to 8 percent of the compensation contributed to the Plan, equal to 50 percent of the participant's eligible contributions.

Additionally, the Company may make a discretionary profit-sharing contribution, determined by the Company, to be allocated to each participant based on his or her annual pay. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

The Company is required to make an annual contribution (the "1 percent company contribution") equal to 1 percent of annual compensation to each hourly employee of the Attica, Indiana facility who is employed by the Company on the last day of the year (including any employee laid off on or after December 1 of that year) and has completed at least 1,000 hours of service during that year. Any employee whose death or retirement date occurred during the year also receives this contribution. Any Attica, Indiana facility hourly employee hired on or after September 17, 2018 is not eligible for the 1 percent company contribution.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 100 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Company's contributions are invested in the same manner as that of the participants' elective contributions.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee deferral and rollover contributions and any income or loss thereon. Vesting in the employer contributions, plus actual earnings thereon, is based on years of service. Participants vest in employer matching and discretionary contributions over a three-year period as follows:

C&D Technologies, Inc.'s discretionary contributions, if any, vest according to the following schedule:

Subsequent to year end, the Plan was amended to change the vesting schedule. Pursuant to this amendment, participants will vest in discretionary contributions 33 percent after one year of service, 66 percent after two years of service, and 100 percent after three years of service.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Certain in-service distributions are also payable upon attainment of age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines; however, they are exempt from the prohibited transactions rules under ERISA.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no significant redemption restrictions or unfunded commitments on these investments. Withdrawals of investments in the Fidelity Managed Income Portfolio CL 2 Fund (the "MIP fund") made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur. The MIP fund requires at least 12 months' written notice of intent to liquidate. The balance of the MIP fund as of December 31, 2024 and 2023 was \$6,736,337 and \$7,498,396, respectively. There are no redemption restrictions on any other investments held by the Plan.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 11, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 1 - Plan Description

The following description of C&D Technologies Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of C&D Technologies, Inc. and, effective April 1, 2020, Trojan Battery Company (collectively, the "Company"), with the exception of residents of Puerto Rico, leased employees, independent contractors, or nonresident aliens with no U.S. income. Employees of the Attica, Indiana facility are eligible to participate on the first day of the month following 90 days of service. All other employees are eligible to participate on the first day of the month following the first day of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for tax-deferred contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also provides for after-tax employee deferral contributions. Deferral contributions are limited to 90 percent of annual compensation. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Newly eligible employees are automatically enrolled in the Plan based on the aforementioned eligibility dates unless they affirmatively decline to participate.

The Plan provides for employer matching contributions, up to 8 percent of the compensation contributed to the Plan, equal to 50 percent of the participant's eligible contributions.

Additionally, the Company may make a discretionary profit-sharing contribution, determined by the Company, to be allocated to each participant based on his or her annual pay. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

The Company is required to make an annual contribution (the "1 percent company contribution") equal to 1 percent of annual compensation to each hourly employee of the Attica, Indiana facility who is employed by the Company on the last day of the year (including any employee laid off on or after December 1 of that year) and has completed at least 1,000 hours of service during that year. Any employee whose death or retirement date occurred during the year also receives this contribution. Any Attica, Indiana facility hourly employee hired on or after September 17, 2018 is not eligible for the 1 percent company contribution.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 100 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Company's contributions are invested in the same manner as that of the participants' elective contributions.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee deferral and rollover contributions and any income or loss thereon. Vesting in the employer contributions, plus actual earnings thereon, is based on years of service. Participants vest in employer matching and discretionary contributions over a three-year period as follows:

C&D Technologies, Inc.'s discretionary contributions, if any, vest according to the following schedule:

Subsequent to year end, the Plan was amended to change the vesting schedule. Pursuant to this amendment, participants will vest in discretionary contributions 33 percent after one year of service, 66 percent after two years of service, and 100 percent after three years of service.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Certain in-service distributions are also payable upon attainment of age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines; however, they are exempt from the prohibited transactions rules under ERISA.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

Note 2 - Summary of Significant Accounting Policies (Continued)

The collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no significant redemption restrictions or unfunded commitments on these investments. Withdrawals of investments in the Fidelity Managed Income Portfolio CL 2 Fund (the "MIP fund") made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur. The MIP fund requires at least 12 months' written notice of intent to liquidate. The balance of the MIP fund as of December 31, 2024 and 2023 was \$6,736,337 and \$7,498,396, respectively. There are no redemption restrictions on any other investments held by the Plan.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 11, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
