Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TriMas Corporation Hourly Retirement Program (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

A. Description of Plan

The following description of the TriMas Corporation Hourly Retirement Program ("Plan") provides only general information. Participants should refer to the Plan document or summary Plan description for a more complete description of the Plan's provisions.

General - The Plan, established on January 1, 2003, is a defined contribution Plan covering eligible employees of TriMas Corporation and its subsidiaries (the "Company" or "TriMas") and allows employee 401(k) deferrals, employer matching contributions and employer profit sharing contributions per the Plan provisions. Eligible employees may participate in the 401(k) deferral feature and the related employer matching contribution feature of the Plan on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Generally, participants may contribute up to 75% of their pretax or post tax annual compensation as defined by the Plan, subject to applicable legal limits. Newly hired non-union employees are automatically enrolled into the Plan at 5% with automatic annual increases of 1% up to a cap of 10%, unless they opt out or elect a different deferral rate within 45 days. Participants may also make rollover contributions representing distributions from other tax-qualified plans and certain other retirement accounts. The Company provides a matching contribution of 75% of the participant's first 5% contributed, up to a maximum of 3.75% of their eligible compensation for all non-union employees. Union employees are eligible for an agreed upon matching and/or profit sharing contributions according to each of the respective collective bargaining agreements. The Company makes matching and/or profit sharing contributions subject to certain limitations in accordance with Plan provisions, and are invested pursuant to the participant's investment election.

Participants may direct employee and employer contributions in one percent increments in the investment options available under the Plan. These options are professionally managed mutual funds and a guaranteed investment contract ("GIC"), and vary in their respective strategies, risks and goals. Participants may change their investment options daily. Certain administrative expenses of the Plan may be paid by the Company.

Participant Accounts - Each participant's account is credited with the participant's own contributions and the related employer matching contributions, Company profit sharing contributions and an allocation of Plan earnings or losses based upon participant's elections, net of administrative expenses and debited with participant's own withdrawals. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Participants are immediately vested in their contributions as well as employer matching contributions and earnings thereon. Participants vest in Company profit sharing contributions upon three years of service. In addition, a participant is 100% vested upon attainment of normal retirement age (age 65), death or disability as defined under the Plan.

Payment of Benefits - After separation from service due to termination, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over a period not to exceed ten years.

Notes Receivable from Participants - The Plan provides that participants can borrow funds from their account balances, as defined by the Plan. These loans are limited to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years and up to 10 years for the purchase of a primary residence. The loans are collateralized by the participant's vested account balances and bear interest at the prime rate plus 1%. Loan principal and interest are paid ratably through payroll deductions.

Forfeited Accounts - Plan forfeitures resulting from terminated participants' non-vested accounts may be used to reduce the Company's contribution or to fund plan expenses. Accumulated forfeitures available at December 31, 2024 and 2023 were \$30,333 and \$31,237, respectively. During 2024, no accumulated forfeitures were used to fund employer contributions and none were used to pay plan expenses. In 2023, accumulated forfeitures of \$1,406 were used to fund employer contributions and none were used to pay plan expenses.

Transfer of Assets - During 2024 the Plan transferred net assets of \$978,334 from the Plan for participants that transferred to the TriMas Corporation Salaried Retirement Program due to a change in employment status. During 2023 the Plan transferred net assets of \$3,648,997 into the Plan, of which \$1,610,601 related to the transfer in of the assets of the Omega Plastics, Inc. 401(K) Plan ("Omega Plan"), \$582,900 related to the transfer in of the assets of the Intertech Plastics, LLC 401(K) Plan, and \$1,455,496 related to the net assets transferred into the Plan from the TriMas Corporation Salaried Retirement Program due to a change in employment status.

B. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates - The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Risks and Uncertainties - The Plan provides for various investment options in mutual funds and GICs. Investments are exposed to various risks, such as interest rate, liquidity, credit and market risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is reasonably possible that changes in values of investments in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition - Investments in mutual funds are reported at fair value. Mutual funds are valued using quoted market prices from nationally recognized securities exchanges (Level 1 inputs).

Investment transactions are reflected on a trade-date basis. Realized gains and losses on investments are based on average cost. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recognized on the accrual basis of accounting. Dividend income is recorded on the ex-dividend date. Income from other securities is recorded as earned on an accrual basis.

The GIC investments are fully benefit-responsive and are reported at contract value, which represents contributions made under the plan, plus earnings, less participant withdrawals and administrative fees. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts because contract value is the amount the Plan participants generally receive when executing transactions under the terms of the contracts and Plan provisions.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Revenue sharing - Revenue sharing amounts for investments that generate such amounts for Fidelity are returned to the Plan and credited to the accounts of participants who are invested in those funds. These credits are included in other income in the statement of changes in net assets available for benefits.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Expenses - Investment management fees and operating expenses for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. The Plan's record keeping fees are charged to certain participants in the plan.

C. Investments and Notes Receivable from Participants

Fidelity Management Trust Company ("the Trustee") holds investment assets and executes transactions therein, and substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated investment income (loss) and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

D. Fair Value Measurement

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs which use quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access as of the measurement date;
- Level 2: Inputs which use other inputs that are observable, either directly or indirectly;
- Level 3: Inputs which are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset or liability.

E. Fully Benefit-Responsive Investment Contract

The Plan holds a separate account investment option with MassMutual Life Insurance Company ("MassMutual"), which is considered a traditional guaranteed investment contract. The contract is considered to be fully benefit-responsive and is reported at contract value. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options for deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The contract limits the circumstances under which MassMutual may terminate the contract. Circumstances that would allow MassMutual to terminate the contract include: (i) the Plan's loss of its qualified status, (ii) termination or partial termination of the Plan, or (iii) investor breach of a provision of the Agreement. If one of these events were to occur, the issuer could terminate the contract at an amount less than contract value. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Additionally, as a result of the assets transferred from the Omega Plan, the Plan holds a fully benefit-responsive guaranteed investment group annuity contract, issued by the Voya Retirement Insurance and Annuity Company ("Voya"). The Voya Fixed Account guarantees principal and a guaranteed minimum interest rate for the life of the contract. Assets currently held in the Voya Fixed Account will transfer to an alternative stable value option at the direction of the Plan Sponsor. These transfers will be in equal principal payments, with interest, paid over a period not to exceed 60 months. Assets currently held in the Voya Fixed Account are reported at contract value.

F. Income Tax Status

Effective October 1, 2021, the Plan was amended and restated onto the new Pre-Approved Defined Contribution Plan document sponsored by Fidelity Management & Research Company ("FMR"). The underlying plan document has been approved by the Internal Revenue Service ("IRS") pursuant to an opinion letter issued on June 30, 2020 by the IRS to FMR regarding the plan's tax qualification under Section 401 of the Internal Revenue Code ("IRC"), and therefore the Plan is tax-exempt. Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor ("DOL") or IRS; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

G. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds investments that are managed by Fidelity Investments and Fidelity Management Trust Company. Fidelity Management Trust Company, an affiliate of Fidelity Investments, is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan holds notes receivable from participants which qualify as party-in-interest transactions.
