Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PAN Communications, Inc. 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

NOTE 1 DESCRIPTION OF PLAN

General

The following description of PAN Communications, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established on January 1, 1996. The Plan covers substantially all employees of PAN Communications, Inc. (the Sponsor). The Plan is administered by the Sponsor (the Plan administrator) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All eligible employees having attained the age of 21, as defined, are eligible for participation.

Contributions

A participant may contribute an amount of up to 90% of his/her compensation, as defined in the Plan and subject to maximums in accordance with federal regulations. Such contributions are deducted from the participant's pre-tax earnings. A participant may subsequently elect to increase or decrease the rate of contributions at the beginning of each Plan month. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). For the year ended December 31, 2024, the Company elected to make a discretionary matching contribution up to 50% of the first 6% of an employee's compensation contributed to the Plan under a discretionary match formula. For the year ended December 31, 2024, the Sponsor made discretionary matching contributions of \$379,628. Both Sponsor and participant contributions are subject to certain limitations as defined in the Plan documents and in accordance with applicable regulations.

The Sponsor may also, at its sole discretion, make profit sharing contributions to the Plan on behalf of certain participants. Profit sharing contributions will be allocated to the eligible participant's accounts in the same proportion that their compensation bears to the total compensation paid to all eligible participants. For the year ended December 31, 2024, the Sponsor did not make a profit sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and Sponsor contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Sponsor contributions, investment income, and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting of Contributions

A participant's contributions and earnings thereon are fully vested at all times. Under normal vesting circumstances, the employer matching and profit sharing contributions and earnings thereon are 20% vested after one year of service, and an additional 20% vested each subsequent year until 100% vested after five years of vesting service, as defined in the Plan. Any participant automatically becomes fully vested upon death, disability, or attainment of age 65.

Forfeited Accounts

The nonvested portion of a participant's employer matching and profit sharing contributions is tentatively forfeited after the earlier of the distribution of the entire vested portion of the participant's account who has severed employment, or the last day of the Plan year in which a participant who has severed employment incurs five consecutive one-year breaks in service, as defined in the Plan. If the participant is reemployed prior to five years of severance and repays the Plan an amount equal to the total distribution, the tentatively forfeited amounts without investment income will be reinstated. Amounts not reinstated serve to pay administrative expenses and reduce future contributions by the Sponsor.

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,171 and \$42,656, respectively. For the year ended December 31, 2024, forfeitures used to reduce matching contributions and pay administrative fees amounted to \$74,022.

Notes Receivable from Participants

A participant may borrow against his/her vested account balance. A participant's loan is limited to his/her vested account balance not to exceed \$50,000. The minimum loan amount is \$1,000. A loan bears interest at a fixed rate, as determined by the Plan administrator, which is credited to the participant's account. A loan is required to be repaid in at least quarterly installments of principal and interest over a period not to exceed five years; 10 years if the purpose of the loan was to acquire a primary residence.

Payment of Benefits

Upon termination of service due to retirement or disability, a participant may elect to receive either a lump-sum distribution equal to the value of his/her account or to defer receipt of his/her account balance, provided a distribution is made or commences no later than the April 1st following the end of the calendar year in which the participant attains age 70½.

In the event of death, a participant's entire account balance will be distributed to his/her beneficiary.

Distributions to participants who otherwise terminate employment will be deferred until age 65, unless the participant elects immediate payment or the distribution is less than \$5,000. In such cases, the participant will receive a lump-sum distribution equal to the nonforfeitable value of his/her account.

In-Service Withdrawals

Withdrawals are not permitted except for a severe financial hardship, such as the purchase of a primary residence, educational expenses, uninsured medical expenses, or the prevention of eviction from or foreclosure on a primary residence. Hardship guidelines adhere to the final 401(k) regulations of the Internal Revenue Code (IRC).

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances, plus any accrued interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies and procedures utilizing information provided by the trustee. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Benefit Payments

Benefit payments to participants are recorded when paid.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity, the qualified institution of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 3 TAX STATUS

The Plan has adopted a nonstandardized prototype plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 FAIR VALUE MEASUREMENTS

The Plan has adopted accounting and reporting standards with respect to measuring fair value. These standards establish a framework that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Money Market and Mutual Funds – Money market and mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year-end.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8 SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 11, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, PANBlast LLC was added as a participating employer in the PAN Communications, Inc 401(K) Profit Sharing Plan and Trust Plan, and all employees covered by the employer on this date are immediately eligible for participation in the Plan. Prior to joining the Plan, PANBlast LLC employees participated in the Worksmart Systems, Inc 401(k) Profit Sharing Plan and Trust, which was their former PEO's safe harbor plan. On February 13, 2025, the plan assets of \$3,897,940 in the Worksmart Systems, Inc 401(k) Profit Sharing Plan and Trust were transferred into the PAN Communications, Inc 401(K) Profit Sharing Plan and Trust plan.
