Basis for Opinion

NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The audited financial statements of Brown Chevrolet Company, Inc. Employees' Profit-Sharing Plan (the "Plan") are maintained on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan are adjusted annually to closing market values and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using adjusted basis. Security transaction expenses are considered in computing realized gains and losses on investments.

Investments: Investments in pooled separate accounts (mutual funds) and money market funds are reported at fair value, determined using net asset values (NAV) as of year-end. Investments held in the insurance company's general account under a group annuity contract are reported at both contract value and fair value based on information provided by the issuer; because the contract is not fully benefit-responsive, the investment is presented at fair value in the financial statements. Net appreciation in the fair value of investments, both realized and unrealized, is reflected in the statement of changes in net assets available for plan benefits. Dividends are considered in the fair value determination.

Cash: Cash represents funds forfeited by participants that is held in non-interest bearing accounts.

Benefit Payments: Benefits are recorded when paid.

Concentration of Credit Risks: Concentration of credit risk with respect to investments is reduced as a result of the diversity of the underlying investments.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B – DESCRIPTION OF THE PLAN

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Brown Chevrolet Company, Inc. Employees' Profit Sharing Plan is a defined contribution plan, established January 1, 1973, covering virtually all employees of Brown Chevrolet Company, Inc. (the Plan Sponsor) who have one year of employment. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

NOTE B – DESCRIPTION OF THE PLAN - continued

SECURE 2.0 Act: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Company is evaluating the provisions and has not amended the Plan as of the date of these financial statements.

Contributions: The Plan Sponsor's matching contribution to the Plan is discretionary and is determined each year by the Board of Directors. Participants direct the matching contribution into various investment options offered by the Plan. Participants may also contribute amounts representing distributions ("rollovers") from other qualified defined benefit or contribution plans.

Participant Accounts: Each participant's account is allocated a percentage of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: A participant's account becomes 100% vested upon attaining the Plan's normal retirement age or if employment is terminated due to death or disability. If employment is terminated prior to normal retirement age for any reason other than death or disability, then the employee's interest in employer contributions becomes 100% vested following 6 years of employment in accordance with specific vesting schedules based on years of service as required by the Department of Labor Rules and Regulations.

Forfeitures: At the election of the Plan Sponsor, forfeitures may be used to pay administrative expenses of the Plan or allocated to participants. Forfeited non-vested accounts totaled \$4,053 in 2024 and \$2,329 in 2023.

Investment Options: Upon enrollment in the Plan, a participant may change their investment options daily.

Payment of Benefits: Payment of the vested account balance is immediate when the participant reaches normal retirement age, dies or terminates employment. If the total vested account balance is less than \$5,000, the participant may receive a single lump sum payment; however, for distributions made after December 31, 2023, this threshold increases to \$7,000 pursuant to provisions of the SECURE 2.0 Act. If the vested account balance is equal to or greater than the applicable threshold, various payment options are available and are described more fully in the Plan agreement.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments at December 31, 2024 and 2023 and the related investment earnings for the years then ended, were certified and held by John Hancock Life Insurance Company, the Custodian, and were not audited by the independent auditor.

NOTE D - INCOME TAX STATUS

The Internal Revenue Service has ruled that the Plan qualifies under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is appropriately designed and is currently being operated in compliance with applicable requirement of the IRC. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

NOTE E –TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments include shares of mutual funds managed by John Hancock Life Insurance Company, the Plan custodian. Therefore, these shares qualify as party-in-interest transactions. Fees paid during the year for legal, accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services and have been paid by the Plan Sponsor.

NOTE F – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used during 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Fund: Valued at fair value based on quoted net asset value (NAV) in an active market as of year-end.

Mutual Funds: Valued at fair value using the net asset value (NAV) per unit as reported by the insurance company, which represents the Plan's proportionate interest in the underlying assets of the separate account at year-end.

Insurance Company Guaranteed Account: Valued at fair value based on information provided by the issuer and classified as Level 3 due to the use of significant unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
