**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Westlie Motor Company 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Westlie Motor Company (the "Company"), who have worked for the Company for two months and are age twenty-one or older. The entry date into the Plan is monthly after eligibility requirements are met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. A third party administrator performs general plan administration services and maintains the records of the participant data. A separate party serves as the trustee of the Plan and holds the Plan assets.

**Contributions**

Each participant in the Plan may withhold up to 100% of their compensation. However, the maximum deferral amount may not exceed IRS limits. The Employer makes matching contributions equivalent to 100% of the participant's elective deferral that do not exceed 2% of the participant's compensation. The Employer may also contribute an additional profit-sharing amount determined at its own discretion.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit, contribution plans, or individual retirement accounts.

**Participant's Accounts**

Each participant's account is credited with the participant's contributions and Company contributions. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company contributions, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting the third-party administrator.

**Payment of Benefits**

Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. If the vested value of the participant's account is less than \$7,000, the participant will be forced out of the Plan. The participant's mandatory distribution will be paid in a lump sum.

Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service retirement distributions.

Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Vesting**

Participants are immediately vested in their voluntary contributions. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Forfeitures**

The non-vested portion of a paid participant's balance is used to pay administrative fees or to reduce the employer's matching contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$39,669 and \$19,368, respectively. Forfeitures of \$11,000 and \$19,969 were used to reduce employer matching contributions during the years ended December 31, 2024 and 2023, respectively. In addition, during the years ended December 31, 2024 and 2023, forfeitures of \$300 and \$1,218 were used to pay administrative fees.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the certain reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisors and the plan provider. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statement of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Administrative Fees**

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2     Inputs to the valuation methodology include:  
                  Quoted prices for similar assets or liabilities in active markets;  
                  Quoted prices for identical or similar assets or liabilities in inactive markets;  
                  Inputs other than quoted prices that are observable for the asset or liability;  
                  Inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- Level 2     If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.  
                  Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan is a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan sponsored by the TPA (Avantax Planning Partners) and adopted by the Company. The Internal Revenue Service informed the TPA by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan is acceptable under Section 401 of the Internal Revenue Code. The Plan has not requested its own determination letter from the IRS. The Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Avantax is the recordkeeper of the Plan and, therefore, is a party-in-interest. Avantax provides certain administrative services to the Plan pursuant to the service agreement between the Company and Avantax. Avantax receives revenue from mutual fund service providers for services Avantax provides to the funds. This revenue is used to offset certain amounts owed by Avantax for its administrative services to the Plan. If revenue received by Avantax from such mutual fund service providers exceeds amounts owed under the service agreement, Avantax remits the excess to the Plan as earnings. During the year ended December 31, 2024 and 2023, \$5,889 and, \$7,727, respectively, of revenue sharing was used to offset fees.

Fees paid to Avantax Retirement Plan Services for the year ended December 31, 2024 and 2023 were \$67,242 and \$63,897, respectively.

**NOTE 7 PLAN TERMINATION AND AMENDMENTS**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, the rights to all participants shall remain nonforfeitable. In the event of plan termination, participants will become 100 percent vested in their accounts.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

No significant events have occurred subsequent to the Plan's year end. Subsequent events have been evaluated through August 19, 2025, which is the date these financial statements were available to be issued.
