

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Paris Cleaners, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all full-time employees of Paris Cleaners, Inc. and RMP Transportation Co., Inc. (the Company) who have reached 1,000 hours of service, regardless if they were employed for the entire twelve months, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee is responsible for oversight of the Plan. The administrative committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the management group charged with Plan governance.

Effective May 20, 2024, loans are no longer permitted under the Plan. Effective June 13, 2024, the Plan will cover all full-time employees of Stern Asset Management.

During the year ended December 31, 2024, the Company experienced a partial plan termination of the Plan. This occurred due to the closing of the plant as a result of the Company’s sale of its assets. In accordance with IRC Section 411(d)(3) and Revenue Ruling 2007-43, all affected employees who had a severance from employment during the partial termination measuring period were fully vested in their benefits to the extent funded on that date. The Company has taken the necessary steps to ensure all affected participants have been made whole and any previously forfeited amounts have been restored to their accounts, along with any earnings.

**Contributions**

The Plan is funded through employer contributions and pre-tax employee payroll deductions. Each year participants can elect to defer up to 75% of their pre-tax annual compensation to the Plan to a maximum dollar amount as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

**Contributions (Continued)**

Effective January 1, 2018, any profit sharing contributions will be approved by the Company on a quarterly basis and instead of being classified as profit sharing contributions, if a participant elects the additional amount is reflected as an employee deferral. Participants have the option to receive their allocation of the profit sharing contribution as a cash payment, deferred into the Plan and receive the 25% Company match or receive the allocation into their Health Savings Account (HSA). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company contributes 25% of the first 12% of eligible compensation that a participant contributes to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's respective deferral, the employer contributions and plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately 100% vested in amounts attributable to employee deferrals and earnings. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The Company's vesting schedule is as follows:

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's, or their beneficiary's, assumed life expectancies. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The CARES Act allowed qualifying participants to withdraw up to \$100,000 from their account and waived the usual statutory restrictions on in-service distributions.

**Forfeitures**

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,768 and \$10,215, respectively. These accounts can be used to reallocate participant balances for eligible participants or used to pay administrative expenses. In 2024, forfeitures of \$2,209 and \$8,006 were used to fund the employer profit sharing contribution and employer match, respectively.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to 50% of their vested account balance, a minimum of \$1,000 to a maximum of \$50,000. The participant loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through semi-monthly payroll deductions.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Reclassification**

Amounts in the prior period's financial statements are reclassified whenever necessary to conform to current period presentations.

**Date of Management's Review**

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

**NOTE 3. CERTIFICATION OF FINANCIAL INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 4. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 2 or Level 3 inputs available to the Plan.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trust fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**NOTE 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as party-in-interest transactions.

**NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 8. TAX STATUS**

The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We have noted no particularly sensitive accounting estimates included in the financial statements.

Certain plan financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were the plan investment disclosures. The disclosures in the financial statements are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We noted no corrected or uncorrected misstatements of the financial statements.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated July 29, 2025.

*Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition to our retention.

*Other Matters*

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. As a result, affected employees become immediately vested in their benefits. However, during our forfeiture testing, it was determined that amounts were forfeited by three participants incorrectly. The Company has taken the necessary steps to ensure all affected participants have been made whole and any previously forfeited amounts have been restored to their accounts.



**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Paris Cleaners, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all full-time employees of Paris Cleaners, Inc. and RMP Transportation Co., Inc. (the Company) who have reached 1,000 hours of service, regardless if they were employed for the entire twelve months, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee is responsible for oversight of the Plan. The administrative committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the management group charged with Plan governance.

Effective May 20, 2024, loans are no longer permitted under the Plan. Effective June 13, 2024, the Plan will cover all full-time employees of Stern Asset Management.

During the year ended December 31, 2024, the Company experienced a partial plan termination of the Plan. This occurred due to the closing of the plant as a result of the Company’s sale of its assets. In accordance with IRC Section 411(d)(3) and Revenue Ruling 2007-43, all affected employees who had a severance from employment during the partial termination measuring period were fully vested in their benefits to the extent funded on that date. The Company has taken the necessary steps to ensure all affected participants have been made whole and any previously forfeited amounts have been restored to their accounts, along with any earnings.

**Contributions**

The Plan is funded through employer contributions and pre-tax employee payroll deductions. Each year participants can elect to defer up to 75% of their pre-tax annual compensation to the Plan to a maximum dollar amount as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

**Contributions (Continued)**

Effective January 1, 2018, any profit sharing contributions will be approved by the Company on a quarterly basis and instead of being classified as profit sharing contributions, if a participant elects the additional amount is reflected as an employee deferral. Participants have the option to receive their allocation of the profit sharing contribution as a cash payment, deferred into the Plan and receive the 25% Company match or receive the allocation into their Health Savings Account (HSA). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company contributes 25% of the first 12% of eligible compensation that a participant contributes to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's respective deferral, the employer contributions and plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately 100% vested in amounts attributable to employee deferrals and earnings. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The Company's vesting schedule is as follows:

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's, or their beneficiary's, assumed life expectancies. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The CARES Act allowed qualifying participants to withdraw up to \$100,000 from their account and waived the usual statutory restrictions on in-service distributions.

**Forfeitures**

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,768 and \$10,215, respectively. These accounts can be used to reallocate participant balances for eligible participants or used to pay administrative expenses. In 2024, forfeitures of \$2,209 and \$8,006 were used to fund the employer profit sharing contribution and employer match, respectively.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to 50% of their vested account balance, a minimum of \$1,000 to a maximum of \$50,000. The participant loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through semi-monthly payroll deductions.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Reclassification**

Amounts in the prior period's financial statements are reclassified whenever necessary to conform to current period presentations.

**Date of Management's Review**

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

**NOTE 3. CERTIFICATION OF FINANCIAL INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 4. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 2 or Level 3 inputs available to the Plan.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)**

The common collective trust fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**NOTE 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as party-in-interest transactions.

**NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 8. TAX STATUS**

The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively.

**NOTE 8. TAX STATUS (CONTINUED)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
