We have performed audits of the financial statements of Chicago Rivet & Machine Co. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - PLAN DESCRIPTION

The following description of the Chicago Rivet & Machine Co. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is administered by a committee (the Committee) appointed by the Board of Directors of Chicago Rivet & Machine Co. (the Company).

General: The Plan, established on August 2, 1943, is a defined contribution plan covering substantially all eligible employees of the Company. Employees are eligible to contribute to the 401(k) feature of the Plan on the first day of the month following the completion of 60 days of employment. To be eligible for participation in the profit sharing feature of the Plan, employees must complete 1,000 hours of service in the first twelve months of employment. If not met in the first twelve months of employment, 1,000 hours of service are required in the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may contribute up to 60% of pretax annual compensation to the 401(k) feature of the Plan to the maximum amount allowed as determined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified pension or profit sharing plans.

For each plan year, the Company's profit sharing contribution is discretionary based on the Company's judgment. These contributions are made on behalf of active participants employed by the Company as of the end of the plan year, including any participant disabled during the year and any employee over the age of 65 who terminates or retires prior to year-end. For the year ended December 31, 2024, the Company's profit sharing contribution was \$0.

Participant Accounts: Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of the Plan's earnings and is decreased by withdrawals and plan losses, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their own contributions plus actual earnings thereon. A participant becomes vested in the Company's contributions and earnings thereon according to the following schedule:

Less than 2 years	0%
At least 2 but less than 3 years	20%
At least 3 but less than 4 years	40%
At least 4 but less than 5 years	60%
At least 5 but less than 6 years	80%
6 years or more	100%

Forfeitures of non-vested participant accounts are used to reduce employer contributions or pay administrative expenses. Unallocated forfeitures as of December 31, 2024 and 2023 were \$19,779 and \$8,347, respectively. During 2024, no forfeitures were used to pay Plan expenses.

Payments of Benefits: On termination of service due to death, disability, retirement, or other separation of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a direct rollover into an eligible retirement plan.

Notes Receivable from Participants: Participants may borrow from their 401(k) accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their 401(k) vested account balance. Note terms are five years except for notes made for the purchase of a primary residence, which may be repaid over a period up to ten years. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined at the time the note is requested. Principal and interest are repaid through payroll deductions.

Investment Elections: Participants direct the investment of their accounts into various mutual funds offered by the Plan. Participants are allowed to change the investment of their accounts on a daily basis.

Administrative and Investment Management Expenses: Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. Certain direct administrative fees and expenses may be paid by the Company. Certain other expenses are paid by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various investments that, in general, are exposed to various risks, such as interest rate, credit, liquidity, global events, and overall market volatility risks. Due to the level of risk and uncertainty associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the participants' individual account balances.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompany financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) of fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

NOTE 5 - INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined by a letter dated June 30, 2020 that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has been amended since the adoption of the prototype plan; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Company pays certain professional fees for the administration and audit of the Plan.

Certain plan investments were shares of mutual funds offered by Fidelity Investments ("Fidelity"), an affiliate of the Plan's trustee. Accordingly, these investments qualify as party-in-interest investments.

Participants in the Plan are permitted to borrow funds from their vested balance as described in Note 1. These transactions qualify as party-in-interest transactions.

Administrative fees and certain professional fees for the year ended December 31, 2024, were paid by the Plan to Fidelity and other service providers, which are considered party-in-interest transactions.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through July 28, 2025, which is the date the financial statements were available to be issued.
