### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the CompareNetworks, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Note 1. Description of Plan

The CompareNetworks, Inc. 401(k) Plan (Plan) was established effective January 1, 2006. The Plan is sponsored by CompareNetworks, Inc. (Company). The Plan was most recently restated effective January 1, 2023.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *a. General*

The Plan is a defined contribution profit-sharing plan with a 401(k) feature covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan assets are held by T. Rowe Price Trust Company, the Trustee of the Plan. Company contributions, participant elective deferrals, and participant accounts are administered by the Trustee, which invests cash received and income from investments based on instructions from the Company and participants and makes distributions to participants. The Plan administrators and investment advisors are responsible for the oversight of the Plan, including investment offerings and monitoring investment performance.

#### *b. Contributions*

Each year, participants may contribute a percentage of their pre-tax annual compensation, subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Participants may contribute after-tax Roth elective contributions to the Plan. The maximum participant deferral for pre-tax and after-tax Roth elective contributions was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions up to a maximum of \$7,500 for both years ended December 31, 2024 and 2023. Participants may also contribute rollover amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Each year, the Company may contribute a discretionary matching contribution to the Plan. Effective July 1, 2024, the Company contributes 75% of the first 3% of eligible compensation that a participant contributed to the Plan. Prior to July 1, 2024, the Company contributed 50% of the first 3% of eligible compensation that a participant contributed to the Plan. In addition, the Company may also make a discretionary profit-sharing contribution, which is determined annually. The discretionary profit-sharing contribution is allocated to each participant's account based upon the participant's eligible compensation. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 or 2023.

Participants direct the investment of contributions into various investment options offered by the Plan.

### c. Plan Eligibility

Employees are eligible to participate in the Plan and to receive the Company's discretionary matching and profit-sharing contributions, if any, upon reaching 21 years of age. There is no length of service requirement for employees that are expected to work more than 1,000 hours on an annual basis. Employees expected to work less than 1,000 hours on an annual basis are required to complete 12 months of service in which they are credited with 1,000 hours during the eligibility computation period. The "initial eligibility computation period" is defined as the 12-month period beginning with the date the employee is hired. If the employee does not meet the hours of service requirement during the first year following the date of hire, the eligibility period becomes the Plan year and the requirements can then be met during the Plan year. Employees may enter the Plan on the first pay period following the date the eligibility requirements are met.

### d. Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions (if any), as well as allocations of (a) the Company's discretionary profit-sharing contributions (if any); (b) the Plan's investment earnings (losses), net of investment expenses; and (c) administrative expenses paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

### e. Vesting

Participants are immediately vested in their contributions (including rollovers), plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions is based on years of service. A participant is 100% vested upon: (1) disability, (2) death, (3) normal retirement at age 65, or (4) termination of the Plan. A participant shall have a vested and nonforfeitable interest in his or her account determined by the number of years of service as follows:

### f. Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance, reduced by the highest outstanding loan balance in the previous 12 months. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the origination date of the loan, as determined by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions. In general, loans must be repaid within five years.

### *g. Payment of Benefits*

Upon the termination of service due to death, disability, reaching the normal retirement age, or other reasons, a participant (or their beneficiary upon death) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or installment payments over a period specified by the participant. The Plan also allows for in-service distributions at age 59½ and hardship distributions. If the vested portion of a participant's account balance is \$5,000 or less, this amount will be automatically rolled over to an Individual Retirement Account for the benefit of the participant as soon as possible following termination, retirement, or disability, or to their beneficiary following death.

### *h. Forfeiture Accounts*

The non-vested portion of terminated participants' accounts, as defined by the Plan, represents a forfeiture. Forfeitures are used to reduce employer contributions or pay Plan expenses. There were no forfeitures used to reduce employer contributions during the year ended December 31, 2024. Forfeitures used to reduce employer contributions totaled approximately \$700 during the year ended December 31, 2023. Forfeitures used to pay Plan expenses totaled approximately \$8,000 and \$8,500 during the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures totaled approximately \$10,200 and \$3,200 as of December 31, 2024 and 2023, respectively.

## Note 2. Summary of Significant Accounting Policies

### *a. Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined contribution plans.

### *b. Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *c. Investment Valuation and Income Recognition*

Investments are reported at fair value, which is defined as the price that would be received to sell an asset in an orderly transaction between market participants on the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### *d. Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year the employee contributions are withheld from compensation.

#### e. Notes Receivable From Participants

Participant notes receivable are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Loans treated as distributions totaled approximately \$8,400 and \$1,400 during the years ended December 31, 2024 and 2023, respectively.

#### f. Payment of Benefits

Benefits are recorded when paid.

#### g. Administrative Expenses

Administrative expenses of the Plan are paid by the Plan and the Company. Administrative expenses paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable are charged directly to participants' accounts and are included in administrative expenses. Other administrative expenses paid by the Plan are allocated proportionately to participants based on the value of their account balances. Investment-related expenses are included in net appreciation in fair value of investments.

#### h. Subsequent Events

The Plan has evaluated subsequent events for potential recognition or disclosure through August 12, 2025, the date the financial statements were available to be issued.

### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income from participant notes receivable for the years then ended, was obtained by management and agreed to, or derived from, information certified as complete and accurate by the Trustee of the Plan.

### Note 4. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies at December 31, 2024 or 2023.

*Money market funds and mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and then adjusted by the issuer to contract value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) could occur daily. Trust units are issued and redeemed only on a valuation date and at the NAV per unit computed on that date. Participant-directed redemptions do not have restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire shares in the fund. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and with participants. There are no unfunded commitments related to this investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants will become 100% vested in their accounts.

### Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
