Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NCAA Qualified Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following brief description of the NCAA Qualified Savings Plan (the “Plan”) of the National Collegiate Athletic Association (the “Employer” or NCAA) is provided for general information purposes only. Participants should refer to the Summary Description or Plan document for more complete information.

General—The Plan is a defined contribution profit sharing plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was effective September 1, 1999 and amended April 18, 2022. Fidelity Management Trust Company serves as the asset trustee of the Plan.

Eligibility—The Plan covers generally all employees of the NCAA who have been employed at least six months and who are contributing at least 1% of their compensation into a separate 403(b) arrangement sponsored by the Employer. The entry date is the first day of the plan year, or the fourth, seventh, and tenth month, whichever falls after completion of the service requirement.

Contributions—Upon meeting eligibility requirements, the NCAA contributes 100% of the first 3% and 50% of the next 2% of the participants’ eligible compensation, as defined by the Plan, based upon the amount deferred by the participant under a separate 403(b) arrangement. Participants are not required nor are they permitted to contribute to the Plan.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the NCAA’s contribution and an allocation of Plan earnings. Each participant’s account is charged with the participant’s withdrawals, forfeitures, allocated administrative expenses based on participant transaction activity, as applicable, and allocated Plan losses based on the participants selected investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Notes Receivable from Participants—Participants may borrow from the Plan amounts approved up to the lesser of 50% of the participant’s total balance in all NCAA-sponsored retirement plans or \$50,000, minus the highest outstanding loan balance in the previous 12 months, whichever is less. A participant may have only one loan outstanding at a time, amongst all the NCAA-sponsored retirement plans. Interest on the amount borrowed is based on prevailing commercial interest rates. The loans are collateralized by the vested balance in the participant’s account not to exceed 50% of such vested interest. Principal and interest are paid ratably through biweekly payroll deductions or directly from the participant’s bank as determined at loan origination. Loans are repaid generally over a period of five years, unless the loan proceeds are for the purchase of a principal residence in which case the maximum loan term is 15 years. As of December 31, 2024 and 2023, the Plan maintained loans of \$12,952 and \$14,294, respectively. The loans are carried at amortized cost.

Vesting—Participants are always 100% vested in their account balances. Accordingly, there are no forfeitures.

Investment Options—Participants direct the investment of their employer contributions into various investment options offered by the Plan. Currently, the Plan offers mutual funds, common/collective trusts, and a money market fund. Additionally, participants may elect to open a Fidelity BrokerageLink Account, a self-directed investment platform, and direct the investment of some or all of their accounts pursuant to the Plan in other mutual funds, stocks, bonds or any other investment. These investments must meet the Plan’s legal investment requirements.

Plan Administration—The NCAA has a Benefits Committee (the “Benefits Committee”) to serve as administrator of the Plan. The Benefits Committee serves as the fiduciary with full power, authority, and responsibility to control and manage the operation and administration of the Plan.

Payment of Benefits—Participants or their beneficiaries may request a distribution of their account balance upon separation of service by retirement, death, disability, or termination. The form of the benefit distribution will be determined by the participant and may be made in installment payments or in a lump sum.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, credit, and market risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits—Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not been paid at December 31, 2024 and 2023.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—All expenses incurred in the administration of the Plan may be paid by the NCAA or from the assets of the Plan. Administrative expenses were paid primarily by the NCAA during the year ended December 31, 2024.

Plan Termination—Although it has not expressed any intention to do so, the NCAA has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. If terminated, the Plan would distribute the related participant account balances to participants.

3. INFORMATION CERTIFIED BY ASSET TRUSTEE

Fidelity Management Trust Company (the “Asset Trustee”) has been retained by the Plan administrator to assist in the operation of the Plan, including assistance with the administration of the Plan’s assets. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by the Asset Trustee, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Asset Trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s policy is to recognize significant transfers between levels at the actual date of the event or change in circumstances that caused the transfer.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and are considered a Level 1 investment.

Common/Collective Trusts—

- *Managed Income Portfolio*—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Redemptions are normally available on a daily basis without notice, but may be temporarily suspended due to liquidity concerns. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.
- *Vanguard Target Retirement Trusts*— Valued at the net asset value of units of the Vanguard Fiduciary Trust Company Target Retirement Income and Growth Master Trust (the Master Trust), as determined by the trustee, based on the net asset value of each underlying Vanguard fund in the Master Trust. Redemptions are available on a daily basis. The Trusts are direct filing entities.
- *Loomis Sayles -* Valued at the net asset value of units of the Loomis Sayles Core Plus Fixed Income Fund (the "Trust"), as determined by the trustee, based on the net asset value of each underlying Loomis Sayles fund in the Trust. Redemptions are available on a daily basis. The Trusts are direct filing entities.

Money Market Fund—Valued at cost plus accrued interest which approximates fair value. The money market fund is categorized as Level 1.

Self-directed Brokerage Account—Valued based on the underlying investments selected by the individual participants. Individual investments in the self-directed brokerage account are as follows:

- *Cash equivalents*—Cash equivalents consist of the Fidelity Cash Reserve Fund. These funds are valued at their stated values at year-end. Cash equivalents are categorized as Level 1.
- *Common stock*—Valued at the closing price reported on the active market on which the individual securities are traded. Investments in common stock are categorized as Level 1.
- *Mutual funds*—Valued at the daily closing price as reported by the fund. Mutual funds held in the self-directed brokerage accounts are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and are considered a Level 1 investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

6. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Fidelity Management and Research Company ("Fidelity"). Fidelity received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) stating that the prototype plan is designed in accordance with applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The NCAA provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation.

Certain Plan investments are shares of mutual funds and a common/collective trust managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the asset trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions.

8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NCAA Qualified Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following brief description of the NCAA Qualified Savings Plan (the “Plan”) of the National Collegiate Athletic Association (the “Employer” or NCAA) is provided for general information purposes only. Participants should refer to the Summary Description or Plan document for more complete information.

General—The Plan is a defined contribution profit sharing plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was effective September 1, 1999 and amended April 18, 2022. Fidelity Management Trust Company serves as the asset trustee of the Plan.

Eligibility—The Plan covers generally all employees of the NCAA who have been employed at least six months and who are contributing at least 1% of their compensation into a separate 403(b) arrangement sponsored by the Employer. The entry date is the first day of the plan year, or the fourth, seventh, and tenth month, whichever falls after completion of the service requirement.

Contributions—Upon meeting eligibility requirements, the NCAA contributes 100% of the first 3% and 50% of the next 2% of the participants’ eligible compensation, as defined by the Plan, based upon the amount deferred by the participant under a separate 403(b) arrangement. Participants are not required nor are they permitted to contribute to the Plan.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the NCAA’s contribution and an allocation of Plan earnings. Each participant’s account is charged with the participant’s withdrawals, forfeitures, allocated administrative expenses based on participant transaction activity, as applicable, and allocated Plan losses based on the participants selected investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Notes Receivable from Participants—Participants may borrow from the Plan amounts approved up to the lesser of 50% of the participant’s total balance in all NCAA-sponsored retirement plans or \$50,000, minus the highest outstanding loan balance in the previous 12 months, whichever is less. A participant may have only one loan outstanding at a time, amongst all the NCAA-sponsored retirement plans. Interest on the amount borrowed is based on prevailing commercial interest rates. The loans are collateralized by the vested balance in the participant’s account not to exceed 50% of such vested interest. Principal and interest are paid ratably through biweekly payroll deductions or directly from the participant’s bank as determined at loan origination. Loans are repaid generally over a period of five years, unless the loan proceeds are for the purchase of a principal residence in which case the maximum loan term is 15 years. As of December 31, 2024 and 2023, the Plan maintained loans of \$12,952 and \$14,294, respectively. The loans are carried at amortized cost.

Vesting—Participants are always 100% vested in their account balances. Accordingly, there are no forfeitures.

Investment Options—Participants direct the investment of their employer contributions into various investment options offered by the Plan. Currently, the Plan offers mutual funds, common/collective trusts, and a money market fund. Additionally, participants may elect to open a Fidelity BrokerageLink Account, a self-directed investment platform, and direct the investment of some or all of their accounts pursuant to the Plan in other mutual funds, stocks, bonds or any other investment. These investments must meet the Plan’s legal investment requirements.

Plan Administration—The NCAA has a Benefits Committee (the “Benefits Committee”) to serve as administrator of the Plan. The Benefits Committee serves as the fiduciary with full power, authority, and responsibility to control and manage the operation and administration of the Plan.

Payment of Benefits—Participants or their beneficiaries may request a distribution of their account balance upon separation of service by retirement, death, disability, or termination. The form of the benefit distribution will be determined by the participant and may be made in installment payments or in a lump sum.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, credit, and market risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits—Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not been paid at December 31, 2024 and 2023.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—All expenses incurred in the administration of the Plan may be paid by the NCAA or from the assets of the Plan. Administrative expenses were paid primarily by the NCAA during the year ended December 31, 2024.

Plan Termination—Although it has not expressed any intention to do so, the NCAA has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. If terminated, the Plan would distribute the related participant account balances to participants.

3. INFORMATION CERTIFIED BY ASSET TRUSTEE

Fidelity Management Trust Company (the “Asset Trustee”) has been retained by the Plan administrator to assist in the operation of the Plan, including assistance with the administration of the Plan’s assets. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by the Asset Trustee, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Asset Trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s policy is to recognize significant transfers between levels at the actual date of the event or change in circumstances that caused the transfer.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and are considered a Level 1 investment.

Common/Collective Trusts—

- *Managed Income Portfolio*—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Redemptions are normally available on a daily basis without notice, but may be temporarily suspended due to liquidity concerns. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.
- *Vanguard Target Retirement Trusts*— Valued at the net asset value of units of the Vanguard Fiduciary Trust Company Target Retirement Income and Growth Master Trust (the Master Trust), as determined by the trustee, based on the net asset value of each underlying Vanguard fund in the Master Trust. Redemptions are available on a daily basis. The Trusts are direct filing entities.
- *Loomis Sayles -* Valued at the net asset value of units of the Loomis Sayles Core Plus Fixed Income Fund (the "Trust"), as determined by the trustee, based on the net asset value of each underlying Loomis Sayles fund in the Trust. Redemptions are available on a daily basis. The Trusts are direct filing entities.

Money Market Fund—Valued at cost plus accrued interest which approximates fair value. The money market fund is categorized as Level 1.

Self-directed Brokerage Account—Valued based on the underlying investments selected by the individual participants. Individual investments in the self-directed brokerage account are as follows:

- *Cash equivalents*—Cash equivalents consist of the Fidelity Cash Reserve Fund. These funds are valued at their stated values at year-end. Cash equivalents are categorized as Level 1.
- *Common stock*—Valued at the closing price reported on the active market on which the individual securities are traded. Investments in common stock are categorized as Level 1.
- *Mutual funds*—Valued at the daily closing price as reported by the fund. Mutual funds held in the self-directed brokerage accounts are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and are considered a Level 1 investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

6. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Fidelity Management and Research Company ("Fidelity"). Fidelity received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) stating that the prototype plan is designed in accordance with applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The NCAA provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation.

Certain Plan investments are shares of mutual funds and a common/collective trust managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the asset trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions.

8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.
