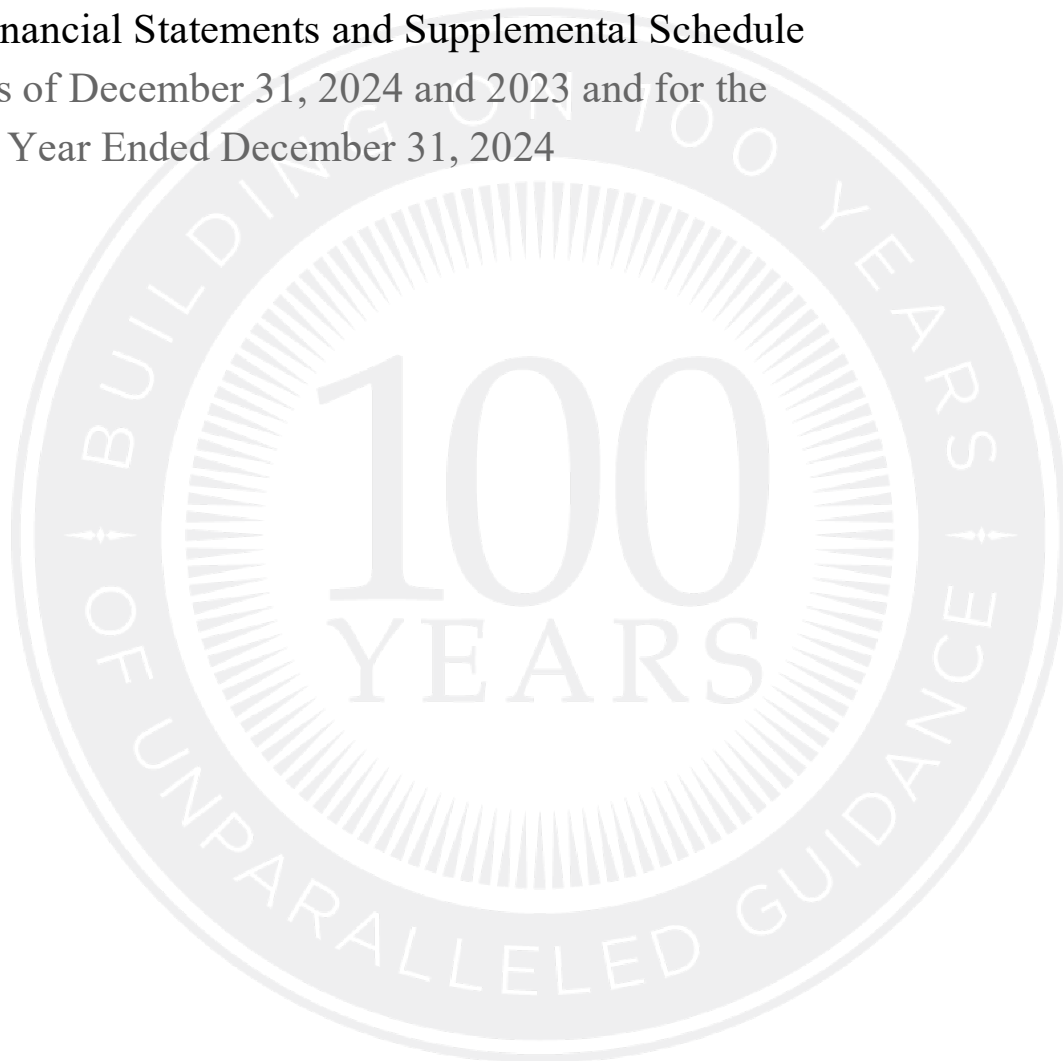

Independent Auditor's Report

To the Plan administrator of the Dime Bank 401(k) Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Dime Bank 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

As of December 31, 2024 and 2023 and for the
Year Ended December 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Dime Bank 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Dime Bank (the “Bank”). It covers primarily all full-time employees of the Bank who have attained 21 years of age and completed a minimum of 300 hours in the first three months of service, with specific exclusions for contract employees, as defined by the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may contribute a percentage of pretax annual compensation, as defined by the Plan, up to a certain dollar limit which is set by law. Newly eligible employees will be automatically enrolled in the plan and a 3% employee contribution will be withheld unless they elect to opt out of the Plan. After 90 days of service, the Bank matches 100% of the first 3%, and 50% of the next 2%, of annual compensation that a participant contributes to the Plan on a payroll basis. Effective April 1, 2017, the Plan was amended to add a mandatory employer profit sharing contribution of 5% of eligible compensation for participants hired on or after April 1, 2017. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover), additional “catch-up” contributions as allowed by law, and after-tax contributions. Participants direct the investment of their contributions into any of the investment options offered by the Plan. The matching Bank contribution is invested directly in the participant’s selected investment options in the same allocation ratios.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, any contributed amounts from other qualified defined benefit or contribution plans, and allocations of the Bank’s contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Fees associated with participant loans are charged to the individual participant’s account.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,690 and \$37,598, respectively. These accounts will be used to reduce future employer contributions.

During the year ended December 31, 2024, \$56,605 was used to reduce employer contributions from forfeited non-vested accounts.

Vesting

Participants are immediately vested in their contributions and employer match plus actual earnings thereon. The participants are vested in the profit share after three years.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account, range in term from 1 to 5 years, except for loans used to acquire the principal residence of the participant, which may be a term up to 15 years, and bear an interest rate of Prime, as published in the Wall Street Journal on the loan origination date, rounded to the nearest quarter point, plus one percent. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Generally, active employees age 59½ or older can annually elect to receive a non-hardship withdrawal of any portion of their vested interest in their account. Also, an active employee may elect to receive a hardship withdrawal of any portion of their vested interest in their account, provided all hardship withdrawal criteria and Plan restrictions are satisfied.

Upon termination of service, participants with vested balances less than \$1,000 in their account will automatically be paid as a lump-sum payment unless a roll-over distribution is elected. If a vested account balance is over \$1,000, participants can elect a lump-sum payment or a partial cash payment, unless a roll-over distribution is elected. If no election is made, a participant is not required to receive a distribution of Plan benefits until the time they would reach their normal retirement date.

On termination of service due to death, disability, or retirement, a participant (surviving spouse, beneficiary or estate, if applicable), may elect to receive the vested interest in their account by a lump-sum distribution or payment of annual installments over a period of not more than the participant's assumed life expectancy.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Bank as provided by the Plan document. Expenses that are paid by the Bank are excluded from these financial statements. Investment-related expenses are included in net appreciation/depreciation of fair value of investments.

3. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. PLAN TERMINATION

The Bank has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to receive their respective shares of the Plan's net assets after payment of all liabilities and expenses. At December 31, 2024, the Bank had not expressed any intention to terminate and expects to continue the Plan indefinitely.

5. TAX STATUS

The Plan has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the prototype plan has been amended and restated since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The information related to investments and notes receivable from participants, and the investment income and interest income on notes receivable from participants, reflected in the financial statements, footnotes and the supplemental schedule, was derived from information furnished to the Plan Administrator by Ascensus, as agent for Ascensus Trust Company, the Plan's Trustee. The Plan Administrator obtained certifications from Ascensus, as agent for Ascensus Trust Company, that such information was complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

7. FAIR VALUE MEASUREMENTS

Fair value estimates are made as of a specific point in time based on the characteristics of the financial instruments and relevant market information. In accordance with GAAP, the fair value estimates are measured within the fair value hierarchy, which gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities

(Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement

Level 1 – Unadjusted quoted prices for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 quoted prices such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs that reflect an entity’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: A common collective trust fund that is composed primarily of fully-benefit-responsive investment contracts is valued at the net asset value (“NAV”) of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trusts, the issuers reserve the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

8. RELATED PARTY AND PARTIES IN INTEREST TRANSACTIONS

Certain administrative functions, including plan administration, are performed by officers and employees of the Bank. No compensation is paid for these services. Certain Plan investments are managed by Vanguard Group, Inc. (“Vanguard”). Vanguard is the recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Total fees paid to Vanguard in 2024 were \$8,863. Notes receivable from participants also qualify as party-in-interest transactions.

9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 14, 2025, which is the date the financial statements were available to be issued. Effective July 1, 2025, the Company amended its 401(k) Plan recordkeeping agreement with Vanguard to implement automatic force-out distribution services. Under this amendment, Vanguard is authorized to automatically process distributions for terminated participants meeting the Plan's force-out criteria, including required notices and distributions to rollover IRAs or participants who don't make affirmative elections. There were no other subsequent events that require adjustment to or disclosure in the financial statements.
