To the Trustees of the

### **Opinion**

We have audited the accompanying financial statements of the Pacific Realty Associates, L.P. Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

#### **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, as listed in the accompanying table of contents, as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following description of the Pacific Realty Associates, L.P. Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established for the benefit of eligible employees of Pacific Realty Associates, L.P. and its affiliates, PW Commerce Center, L.P. and M&T Chico Ranch (collectively, "the Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). None of the Plan's investments are participant-directed. Accordingly, all investment decisions, including investment allocation, are made by the Plan's trustees (the Trustees).

#### Eligibility

All employees of the Employer – other than "leased employees" as defined in the Internal Revenue Code (the IRC) and employees covered by a collective bargaining agreement that does not provide for participation in the Plan – are eligible to participate in the Plan upon completion of 1,000 hours of service (as defined in the Plan document). Plan entry dates for newly-eligible employees are each January 1 and July 1.

#### Contributions

The Employer, at its discretion, may make an annual contribution to the Plan. Employer contributions are allocated to each eligible participant's account based upon the ratio of each participant's eligible compensation to the total eligible compensation of all participants, not to exceed 25% of a participant's eligible compensation (all as defined in the Plan document). A participant must be employed on the last day of the Plan year and meet all other eligibility requirements to receive his or her share of the Employer's contribution for that respective year.

The Employer's contributions are funded on or before the filing of the Employer's annual tax returns.

Participant salary deferral contributions to the Plan are not permitted. At the discretion of the Trustees, and upon meeting certain other criteria, participants may contribute certain amounts to the Plan representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts (i.e., rollover contributions).

#### Participant accounts

Each participant's account is credited (charged) with the participant's rollover contributions (if any) and allocations of (a) the Employer's contributions, (b) Plan earnings (losses), and (c) administrative expenses. Earnings (losses) are allocated to participants' accounts based on the individual participant's account balance as compared to the total balance of all participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in their rollover contributions and the actual earnings (losses) thereon. Vesting in the Employer's contributions is based on years of service as follows:

In addition, upon death, disability, or retirement at age 65 or older, participants will immediately become 100% vested in their share of the Employer's contributions and the actual earnings (losses) thereon.

### Forfeitures

Participants who terminate employment or have a break in service (defined as working less than 500 hours during a Plan year for five consecutive Plan years) will forfeit the unvested portion of their accounts. Any forfeited amounts remain in the Plan and will first be used to restore any previously forfeited amounts related to certain previously participating employees who have been rehired. Any remaining forfeitures will then be allocated to the accounts of the remaining participants in the same manner as Employer contributions. As of December 31, 2024 and 2023, there were no unallocated forfeited nonvested accounts. During the years ended December 31, 2024 and 2024, no forfeitures were used to restore any previously forfeited amounts. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$12,000 and \$23,000, respectively, were allocated to participant accounts.

### Benefits

Upon retirement, death, disability, or other separation of service, participants (or their beneficiaries) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon retirement or separation of service, if a participant's vested account balance is \$1,000 or less, and the participant does not elect to receive a distribution, the Employer may direct the Plan to automatically distribute the participant's vested account balance in a lump-sum. In addition, upon reaching age 62, a participant may elect to withdraw all or a portion of his or her vested account balance from the Plan prior to termination of employment, subject to certain restrictions.

### Administrative expenses

At the Employer's discretion, administrative expenses of the Plan may be paid directly by the Employer; certain other administrative expenses may be paid by the Plan. Expenses that are paid by the Employer are excluded from the accompanying financial statements. Certain investment related expenses are offset against net appreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

## 2. Summary of Significant Accounting Policies

### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management of the Plan (Management) to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodians. See Note 3 for discussion of fair value measurements.

### Investment income recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of benefits

Benefits are recorded when paid.

### Subsequent events

Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through August 14, 2025 which is the date that the financial statements were available to be issued.

## 3. Fair Value Measurements

GAAP defines fair value, establishes a framework for measuring fair value, and requires certain disclosures about fair value measurements. The hierarchy of fair value valuation techniques under GAAP provides for three levels: Level 1 provides the most reliable measure of fair value, whereas Level 3 generally requires significant management judgment. The three levels for categorizing assets and liabilities under GAAP's fair value measurement requirements are as follows:

- Level 1: Fair value of the asset or liability is determined using unadjusted quoted prices in active markets (that the Plan has the ability to access) for identical assets or liabilities;
- Level 2: Fair value of the asset or liability is determined using inputs other than quoted prices that are observable for the applicable asset or liability, either directly or indirectly, such as quoted prices for similar (as opposed to identical) assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active; and
- Level 3: Fair value of the asset or liability is determined using unobservable inputs that are significant to the fair value measurement and reflect the Plan's own assumptions regarding the applicable asset or liability.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### Years Ended December 31, 2024 and 2023

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Exchange Traded Funds (ETFs)* – ETFs are generally traded in active and highly liquid markets, and their fair value is based on the daily closing price as reported by the exchange on which the fund is traded. As such, the Plan's investment in ETFs is classified as Level 1 in the fair value hierarchy.

*Mutual funds* – The fair value of mutual funds is based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Limited partnership* – The fair value of the limited partnership is based on the NAV of the units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value; and, accordingly, the Plan's investment in the limited partnership is excluded from the fair value hierarchy in accordance with GAAP. The underlying investments comprising the limited partnership are primarily funds of funds, and master funds, which are fixed-income relative value funds.

The methods above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Management believes that the valuation methods used by the Plan are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements as of the reporting date.

As of December 31, 2024 and 2023, the Plan's limited partnership investment consisted of an investment in Rimrock High Income PLUS (Cayman) Fund, Ltd. (Rimrock Cayman). Rimrock Cayman's primary investment consists of an interest in Rimrock High Income PLUS (Master) Fund, Ltd. (Rimrock Master), which is a fixed-income relative value fund. Rimrock Master's investment objective is to take advantage of structural and technical inefficiencies in the market, especially in the short-end of the yield curve, primarily by investing in a variety of fixed-income securities. Under the subscription agreement, redemptions are permitted on the last business day of each calendar quarter upon 120 days of notice. In addition, the Plan has committed to contribute up to a maximum amount of capital to the limited partnership.

#### **Years Ended December 31, 2024 and 2023**

Capital contributions due under this agreement are generally paid to the limited partnership in various amounts upon issuance of capital calls by the limited partnership. As of December 31, 2024, the Plan did not have any remaining capital commitments to the limited partnership.

#### **4. Related Party Transactions**

The Employer is the sponsor of the Plan and paid certain administrative expenses of the Plan during the years ended December 31, 2024 and 2023. The Trustees are also participants in the Plan.

#### **5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

#### **6. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated September 27, 2013, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Management and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Risks and Uncertainties**

The Plan invests in various investment instruments which are exposed to certain risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements and supplemental schedule.
