INDEPENDENT AUDITOR'S REPORT

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Alpine Banks of Colorado Employee Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides medical insurance benefits covering eligible employees of Alpine Banks of Colorado, Inc. (the Company) and employees' dependents. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan was adopted January 1, 2000 and provides medical insurance benefits to all eligible salaried and hourly employees and their dependents. Eligible employees must be scheduled to work 20 or more hours per week.

Funding

Funding is derived from the funds of the Company and contributions made by the covered employees. Participant contributions are used to fund the cost of the Plan as soon as practicable after they have been received from the participant. Benefits are paid directly from the Plan through the claims administrator.

Contributions

The Plan agreement provides that the Company shall, from time to time, evaluate the liabilities and expenses of the Plan and determine the amount to be contributed by the Company and the amount to be contributed by each covered participant. Employees may contribute specified amounts, determined periodically by the third party administrator, to extend coverage to eligible dependents.

Insurance

Health care benefits are self-insured up to a ceiling amount. Under the program terms, the Company contracts with a third party administrator for claims processing and determination of funding requirements. Individual claims over \$140,000 for the years ended December 31, 2024 and 2023, are covered by stop-loss insurance policies maintained with a third party insurance company.

The stop-loss insurance policy is a 12/15 policy. Claims incurred between January 1 and December 31 paid during the year the claim was incurred and through March 31 of the following year are eligible for reimbursement under the insurance policy.

As of December 31, 2024 and 2023, the Plan had amounts receivable from the stop-loss policy included in reinsurance, refunds, and other receivables.

Effective January 1, 2023, the Plan adopted ASU 2016-13, *Financial Instruments-Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments* (ASU 2016-13), as amended, which modifies the measurement of expected credit losses on certain financial instruments. The Plan adopted ASU 2016-13 utilizing the modified retrospective transition method. ASU 2016-13 requires measurement and recognition of expected versus incurred losses for financial assets held. Financial assets held by the Plan that are subject to ASU 2016-13 include reinsurance, refunds, and other receivables. The adoption of ASU 2016-13 did not have a material impact on the Plan's financial statements but did change how the allowance for credit losses is determined.

For the year ended December 31, 2024 and 2023, all receivables were determined to be collectible; therefore management determined that an allowance for credit losses was not considered necessary.

Other

Although it has not expressed any intention to do so, the Company has the right under the Plan to alter, amend, or terminate the Plan, subject to the provisions set forth in ERISA. Upon termination, the assets then remaining shall be subject to the applicable provision of the Plan then in effect and shall be used until exhausted to pay benefits to employees in order of their entitlement.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Obligations

Benefit obligations of the Plan at December 31, 2024 and 2023 for health claims incurred by participants but not reported at that date are estimated by the Plan by analyzing claim lag studies. Such amounts are reported at an undiscounted amount because amounts typically are payable within one year. Any differences in the estimated amounts and actual amounts will be reported in future years.

Concentrations of Credit Risk

The Plan maintains its cash balances with the Company. The balance at the Company is insured by the Federal Deposit Insurance Corporation up to \$250,000. At various times, the Plan has exceeded this limit.

Contingencies

The Plan could be subject to various fees and penalties if the Plan is not in compliance with ERISA, the Internal Revenue Service, and the Department of Labor, including compliance with the Consolidated Omnibus Budget Reconciliation Act (COBRA).

NOTE 3 - TAX STATUS

The Plan administrator and the Plan advisors believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 13, 2025, the date at which the financial statements were available to be issued, and determined that no events have occurred that require disclosure.
