We have performed audits of the financial statements of Hospice of the Bluegrass 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Hospice of the Bluegrass 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

Participation: The Plan is a defined contribution, safe harbor plan covering substantially all full-time employees of Hospice of the Bluegrass (the Company). Employees are automatically enrolled after two months of employment at deferral percentages of 3% and must “opt-out” should they choose not to participate. Eligibility for the employer contribution occurs after one year of service and reaching 21 years of age.

Participants direct the investment of their accounts into various investment options offered by the Plan, including a guaranteed investment contract and underlying sub-accounts of the Standard Insurance Company’s Separate Account A. The sub-accounts of the Standard Insurance Company separate account are each passively invested in a single mutual fund generally identified in the names of the sub-account. Participants may change their investment options daily and may direct future contributions in any percentage increment up to 100%.

Funding: Contributions made to the Plan are comprised of participant and employer contributions. Participants may defer their salary up to the maximum annual deferral amount defined by the Internal Revenue Service. The Company will make an employer contribution for each eligible participant that equals 100% of the participant’s deferrals up to 3% and 66 2/3% of the participant’s deferrals from 3% to 6%.

The Plan also allows for transfers or rollovers into the Plan from other qualified plans or retirement accounts.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and allocations of Company contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting/Forfeitures: Participants are immediately vested in their contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in employer non-safe harbor contributions, plus actual earnings thereon, occurs ratably based on years of continuous service where a participant is 100 percent vested after three years of credited service or upon retirement, death or disability. For the year ended December 31, 2024, forfeitures of \$0 were used to pay participant-based fees. As of December 31, 2024 and 2023, no forfeitures were available to reduce employer contributions.

Administrative and Investment Management Expense: The Plan’s record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan or included in administrative expenses. All other expenses of the Plan are paid by the Company.

Withdrawals: Withdrawal payments are made in the form of partial, periodic, or lump-sum payments upon termination, disability, or retirement. In addition, the plan allows for hardship distributions if certain criteria are met. Active participants may also take distributions from the Plan upon attainment of age 59^{1/2}.

Termination: Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the net assets are to be allocated to the participants on the basis of their individual interests and participants would become 100% vested in their employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of the Plan are prepared under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Accounting Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Common Stocks Held within Self-Directed Brokerage Accounts: The fair values of investments in common stocks are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held by the Plan in sub-accounts of Separate Account A are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each sub-account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund’s net asset value per unit.

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Standard Insurance Company.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive group annuity contract with the Standard Insurance Company (“Standard”; Issuer), a Standard Stable Asset Fund Guaranteed Investment Contract. Standard maintains the contributions in its general account. Standard’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the Issuer or otherwise. The contract value of the Plan’s fully benefit-responsive investment contracts at December 31, by general type, are presented below:

The Plan’s guaranteed investment contract specifies certain events that limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. In the event that the Plan Sponsor terminates the contract and requests an immediate payout, the contract payout would be subject to a 5% termination fee. The plan administrator does not believe that the occurrence of any such events, which would limit the Plan’s ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the volume submitter plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended from the original volume submitter plan, Plan management believes that the Plan is designed and being operated in accordance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Plan investments are issued or managed by The Standard Insurance Company, thus making all investments party-in-interest investments. Any administrative fees paid from the Plan to service providers of the Plan also qualify as party-in-interest transactions. Contract administrator fees of \$35,081 were paid to The Standard Insurance Company by the Plan in 2024.

NOTE 8 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 15, 2025, which is the date the financial statements were available to be issued.
