Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Buechel Stone Corp. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Buechel Stone Corp. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Buechel Stone Corp. and its wholly owned subsidiary: Rolling Rockstar Transit, LLC (collectively referred to as the "Company"). The Plan excludes leased employees, nonresident aliens, employees covered by a collective bargaining agreement, and contract employees. Full-time employees are eligible to participate in the Plan and to receive Company discretionary matching contributions upon attaining age 18 and following the completion of at least 500 hours of service during the first six consecutive months of service. Part-time, temporary, and seasonal employees are eligible to participate upon completing one year of service, as defined in the plan document. Effective January 1, 2024, under the SECURE 2.0 Act, long-term part-time employees who attained age 21 and worked at least 500 hours in the previous three consecutive years are also eligible to participate in the Plan. Participants must also be employed on the last day of the plan year in order to receive any Company discretionary nonelective contributions. Entry dates are the first of every quarter coinciding with or next following the date eligibility requirements are satisfied.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the plan document, on a pre-tax or Roth basis, not to exceed the maximum allowable limits by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions. For 2024, the Company made discretionary matching contributions of 5% of participant deferrals up to \$500 per year. Rollover contributions are not matched. The Company may also make discretionary nonelective contributions. The Company did not make any discretionary nonelective contributions for the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of (a) the Company's discretionary nonelective contributions and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of administrative and investment management expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions, plus actual earnings thereon, is based on years of continuous service. Participants vest at the rate of 20% per year, beginning with the second year of service. Participants become fully vested after six years of service, or upon death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years. Participant may only have one loan outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at prime plus 1.00%. Interest rates on existing notes as of December 31, 2024 ranged from 4.50% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Excess Contributions Payable

Contributions in excess of amounts allowed by the IRS during 2023, totaling \$11,392 were recorded as a liability on the statements of net assets available for benefits at December 31, 2023. This amount was distributed to participants during 2024.

Payment of Benefits

On termination of service due to death, disability, or retirement (age 65), or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in lump-sum distributions or partial withdrawals. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

Note 1: Description of Plan (Continued)

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$656 and \$4,037, respectively. These accounts may be used at the discretion of the Company in accordance with the plan document. During the year ended December 31, 2024, the Company used \$4,793 of forfeitures to reduce Company contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 4, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. This is a stable fund and its NAVs are based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of this fund or unfunded commitments as of December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC ("John Hancock"), the trustee of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by John Hancock, the trustee of the Plan and, therefore, transactions with John Hancock qualify as party-in-interest transactions. Fees paid directly by the Plan to John Hancock for administrative services amounted to \$18,711 for the year ended December 31, 2024.

Note 5: Party-in-Interest Transactions (Continued)

Wilshire Associates, Inc. ("Wilshire") is the investment advisor for the Plan and, therefore, fees paid to Wilshire also qualify as party-in-interest transactions. Fees paid directly by the Plan to Wilshire for investment management services amounted to \$16,776 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary contributions.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
