## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Cardinal Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cardinal Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

### AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the Cardinal Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**—Cardinal Glass Industries, Inc. (the “Company”), established the Plan, a 401(k) defined contribution plan, to provide retirement income and other benefits to qualified employees on October 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Operations**—The Company is the sponsor and administrator of the Plan. The Company has appointed Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) as the trustee and recordkeeper of the Plan. Principal is responsible for holding the assets of the Plan and executing investment transactions. Substantially all costs of administering the Plan are paid from the Plan’s assets. Principal is responsible for certain administrative duties related to the management of the Plan. The Plan provisions are subject to collective bargaining. The Plan allows for transfers between the Plan and the Cardinal Cash-In II Plan based upon an employee’s eligibility to participate in the Plan due to a change in union or nonunion employment status. For the year ended December 31, 2024, plan transfers reported in the statement of changes in net assets available for benefits to the Cardinal Cash-In II Plan were \$103,881 and plan transfers received from the Cardinal Cash-In II Plan were \$35,972.

**Eligibility**—All union employees are eligible on their date of hire.

**Investments**—Participants direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers various registered investment companies, and collective funds (including a stable value fund).

**Contributions and Vesting**—The Plan allows eligible participants to reduce their compensation by a specific percentage or dollar amount and have that amount deferred as a pretax employee contribution or an after-tax Roth employee contribution. Participants are allowed to contribute 1% to 25% of their regular wages. Participants age 50 or higher during the plan year may elect to defer additional amounts (called “catch up contributions”) to the plan each year. The Company matches the participants contributions at 50% up to a maximum of 6% of participant compensation excluding any catch-up contributions. The participant’s contributions and earnings thereon are immediately 100% vested. The Company’s matching contributions are not vested until the employee has been a participant of the plan for three years. Notwithstanding the three year vesting period, employer contributions, if any, will become fully vested (100%) upon the occurrence of any of the following events while the participant is employed by the Company: if the participant is employed on or after their normal retirement age or the participant’s death or disability or a termination of the Plan.

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) the Plan earnings, and is charged with an allocation of administrative expenses and plan losses. Allocations are based on participant compensation and on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Distributions**—Distributions are available to participants on the occasion of retirement, termination, disability, or hardship. A participant may request a withdrawal while still employed if the participant has attained age of 59 1/2 years. A participant, or the participant's beneficiary, is entitled to his or her account balance in the event of the participant's death or disability. On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial payment, as defined in the Plan Document.

**Notes Receivable from Participants**—The Plan document contains a loan provision, which allows participants to borrow from their accounts at an interest rate established by the plan administrator commensurate with the prevailing interest rate charged on similar loans under like circumstances. Participants may borrow from their accounts for any purpose. The minimum loan amount available is \$1,000, and the maximum is the lesser of 50% of the participant's vested account balance or \$50,000. A participant may only have one loan outstanding at any time. Participants repay loans through payroll deductions. The repayment period for a residential loan (to build or buy a primary residence) is 10 years, and the repayment period for a loan taken for any other purpose is five years. As of December 31, 2024, participant loans have maturities through 2029 at interest rates ranging from 4.25% to 9.5%. Interest income associated with participant loans was \$23,363 in 2024.

**Plan Amendment and Termination**—The Company reserves the right to amend or terminate the Plan at any time. In the event of the Plan's termination, the participant accounts are fully vested. A final distribution will then be made in accordance with the Plan.

**Forfeited Accounts**—When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer contributions or pay plan administrative expenses for the plan year. However, if a participant is re-employed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. There were \$11,228 and \$15,755 of forfeited nonvested accounts at December 31, 2024 at December 31, 2023, respectively, which were used to offset administrative expenses.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment

securities, such as a pandemic or international conflict. Further, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of participants' account balances and the amounts reported in the financial statement.

**Investment Valuation and Income Recognition**—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Administrative Revenues/Expenses**—Administrative expenses of the Plan are paid by the Plan or the Company, as provided in the Plan document. Investment management fees for investments are included as a reduction of investment return and not reflected separately in the statements of changes in net assets available for benefits. Administrative revenues arise when investment managers return a portion of the investment fees to Principal. Any excess fees from this revenue sharing provision are credited to the participant accounts as a reduction of investment management fees.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024 and 2023.

**Subsequent Events**—Subsequent events were evaluated through August 20, 2025, the date the financial statements were available to be issued. Other than disclosed below, no such events were identified.

### 3. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the information regarding the Plan as of and for the years ended December 31, 2024 and 2023 included in the Plan's financial statements and supplemental schedules that was prepared by or derived from information prepared by Principal, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Mutual Funds**—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds:**

**Collective Trust Funds**—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This

practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

*Stable Value Fund*—A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to confirm that securities liquidations will be carried out in an orderly business manner.

The collective trust funds and stable value fund as presented above are offered by SEI Trust Company, and are valued using the NAV per share. The Funds redemption and subscription frequencies are daily. As of December 31, 2024 and 2023, the Funds had no redemption notice periods or unfunded commitments, except as described in Note 4.

**6. FEDERAL INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by Fredrikson & Byron, P.A. and adopted by Cardinal Glass Industries, Inc., which received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, that the Plan was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements. The Plan itself has not received a determination letter from the IRS. However, the Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**7. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, a final distribution will then be made in accordance with the Plan document.

**8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Fees paid for investment management services were included as a reduction of the return earned on each fund as contractually applicable and disclosed to Plan participants.

The Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan issues loans to participants, which are secured by the vested balances in the participants’ accounts.

The Plan has a fee levelization revenue-sharing provision whereby certain investment managers return a portion of the investment fees to the recordkeeper which are credited to the participant’s accounts as a reduction of investment management fees.
