Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Doorking, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Doorking, Inc. Profit Sharing Plan (the Plan) only provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - Doorking, Inc. (the Company) established the Plan, a defined contribution plan, effective February 1, 1989, to provide savings benefits for all eligible employees. The Plan was amended effective February 1, 1996. Effective February 1, 2006, the Plan elected to change the date of its year-end to December 31.

The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Third Party Administrator, Custodian and Trustee - The Plan is administered by the Company. The third party administrator is ADP Retirement Services (recordkeeper). The Custodian and trustee of the Plan is Reliance Trust Company.

Eligibility - Participants are eligible to begin contributing on the first day of the month following 60 days of employment. Participants are eligible for employer contributions once he or she (1) has worked for the Company for one year, (2) has worked 1,000 hours during the year and (3) has been employed on the last day of the year (December 31).

Contributions - Employer: The Company's contributions are discretionary and are made to the plan without regard to the existence of net profits of the company.

Employee: Each year, participants may contribute an amount up to 90% of their compensation for the contribution period, subject to annual dollar limits set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Each new participant is subject to the automatic deferral provision unless otherwise elected by the participant. The initial automatic deferral amount equals 4% of compensation and is increased by 1% each year to a maximum of 10%.

NOTES TO FINANCIAL STATEMENTS – (Continued)

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN – (Continued)

Participant Accounts - Each Participant account is credited with an allocation of the Company's contributions, Plan earnings, and forfeitures of terminated participant non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant vested account.

Forfeitures - The unvested portion of a terminated participant's employer account will be forfeited and contributed on a pro rata basis to eligible employees or pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$36,969 and \$56,176, respectively. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts were distributed to participants in the amount of \$57,482 and \$31,654, respectively.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. With respect to employer contributions, a participant becomes 20% vested after two years of service plus an additional 20% for each additional year of qualified service up to a maximum of 100%.

Notes Receivable from Participants - Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to 50 percent of their vested account balance with a maximum loan of \$50,000. The loans are secured by the balance in the participants' accounts and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time of borrowing, as determined by the Plan administrators. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments as permitted. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contribution Payable – Accounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024, respectively.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan management has evaluated subsequent events through August 13, 2025, which is the date the financial statements were available to be issued.

3. TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated July 16, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions, amend the Plan at any time, and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

5. CERTIFIED INVESTMENT

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations and Disclosures under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820 (formerly FAS 157), *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements) as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability of access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds— Valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market pricing in an active market. The applied inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

7. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan held a synthetic guaranteed investment contract (GICs) with Invesco Trust Company totaling \$5,662,140 and \$7,507,821 as of December 31, 2024 and 2023, respectively. Synthetic GICs are a portfolio of securities (debt securities or units of collective trusts) with wrap contracts associated with the portfolios. The investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure to fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Invesco, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expense. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

Investment contracts have elements of risk due to lack of secondary market and resale restrictions resulting in the inability of a Trust to sell a contract. In addition, investment contracts may be subject to credit risk based on the ability of the wrapper providers to meet their obligations under the terms of the contract.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

7. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT – (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan's failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA and changes to the Plan's prohibition on competing investment options. No events are probable of occurring that limit the ability of the Plan to transact at contract value with the issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include termination of the Plan, merger or consolidation of the Plan, material breaches by the trustee related to the administration of the 12-month put queue, or material misrepresentation.

8. PLAN EXPENSES/PARTY-IN-INTEREST TRANSACTIONS/EXPENSES

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain Plan investments are managed by ADP Retirement Services and Reliance Trust Company. During 2024, the Plan paid fees of \$77,136 to ADP Retirement Services and other third parties for administration, recordkeeping and advisory services. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

9. RISKS AND UNCERTAINTIES

The Plan provides for investments in various instruments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for plan benefits.
