INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Server Products, Inc. Employees 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Server Products, Inc. Employees 401(k) Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Server Products, Inc. Employees 401(k) Retirement Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include the plan administrator's evaluation of the events and transactions occurring subsequent to December 31, 2024 through August 6, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Server Products, Inc. is the plan sponsor, employer and plan administrator. ADP, LLC is the third party administrator that maintains plan documents and tax counsel that performs various compliance tests. Reliance Trust Company is the plan trustee that holds custody of plan assets and maintains participant investment records. Effective January 1, 2025, ADP Retirement Trust Services replaced Reliance Trust Company as trustee. ADP Strategic Plan Services, LLC ("ADPSPS") is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV"), and are deemed to be actively traded.

Common/collective trust - Valued at the NAV based on units of the common/collective trust. The common/collective trust held by the plan is a direct filing entity. The NAV, as provided by Reliance Trust Company, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by common/collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the common/collective trust will sell the investment for an amount different than the reported NAV.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General - The plan was established on January 1, 1988 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to make elective deferral contributions and receive employer discretionary matching and safe harbor contributions once they have completed two months of service and have reached age nineteen. An employee can enter the plan on the first day of the month immediately following the date the plan's eligibility requirements are met. Employees are eligible to receive employer discretionary non elective contributions if they have completed at least 1,000 hours of service during the plan year and are employed by the plan sponsor on the last day of the plan year. The non elective contribution conditions are waived upon death, disability or attainment of early retirement age in the year of which the contribution relates to.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations ("elective deferral contributions"). Upon meeting the eligibility requirements, employees will be automatically enrolled in the plan and have 6% of their compensation withheld as elective deferral contributions. These elective deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease, or stop the deferral by completing the necessary documentation. The plan also permits Roth elective deferrals contributions.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. The employer may make matching contributions equal to a discretionary percentage of the employee elective deferral contributions. Discretionary matching contributions equal to 50% of the first 6% of the employee's compensation contributed to the plan as elective deferral contributions were made in 2024 and 2023. Discretionary matching contributions are made coinciding with each pay period.
- d. The employer is required to make safe harbor contributions equal to 3% of the employee's eligible compensation, which are made coinciding with each pay period.
- e. The employer may make additional non elective contributions at their discretion. There were no non elective contributions made in 2024. Non elective contributions were made equal to 3% of the employee's eligible compensation in 2023. These contributions are funded annually subsequent to year end.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options daily and change deferral percentages at any time.

Vesting - Participants are always 100% vested in their elective deferral, rollover contributions and employer safe harbor contributions and related earnings. Participants are vested in employer discretionary matching and non elective contributions and related earnings upon one year of service at which time they are 33% vested. The participant then vests at the rate of 33% for each year thereafter until they are fully vested after three years of service. Upon death, disability or attainment of early retirement age as defined in the plan, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Participants generally receive their distribution in the form of lump sum payments, installments or partial withdrawals. In-service withdrawals can commence upon attaining the age of 59½. Hardship withdrawals are permitted under the plan in certain circumstances.

Forfeitures - Forfeitures may be used to pay plan administrative fees or reduce employer contributions. Forfeitures used to reduce employer contributions were \$39,000 in 2024 and \$18,000 in 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and \$4,000 as of December 31, 2023.

Administrative expenses - Certain administrative costs of the plan are paid by the plan sponsor. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and non-participant directed charges for services and administrative fees. Non-participant directed charges are allocated to participants on an account value basis.

Notes receivable from participants - Actively employed participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. The maximum loan term for a general purpose loan is five years. The loan terms may be extended if the loan proceeds are used to purchase a primary residence. Notes receivable from participants are secured by the balance in the participant's account and bear interest at rates set by the plan administrator. As of December 31, 2024, the notes receivable from participants have various repayment schedules through September 2029 with interest rates from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor, third party administrator (ADP, LLC), investment advisor (ADPSPS), and plan trustee (Reliance Trust Company) qualify as party-in-interest transactions. Direct administration fees paid to ADP, LLC by the plan were \$41,000 in 2024 and \$37,000 in 2023. ADP, LLC acts as the billing and collection agent for certain fees which are remitted to ADPSPS pursuant to a services agreement. Reliance Trust Company does not charge the plan directly for any services provided. ADP, LLC compensates the trustee directly for services rendered.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all employer discretionary matching and non elective contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted an ADP, LLC Non-Standardized Pre-Approved Profit Sharing Plan. The pre-approved plan received a favorable opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
