INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Network Innovations 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Network Innovations 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Network Innovations 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Network Innovations 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Network Innovations 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Network Innovations 401(k) Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees from Network Innovations US Inc. (the Company) and any affiliate that has adopted the Plan. The Company is the Plan sponsor, with the following participating employers: NIC4 Inc. dba Network Innovations U.S. Government, Network Innovations EN, Inc., Field Intelligence, Inc. (from January 1, 2020 through October 15, 2024), Fusion Marine Technology, Inc. dba Network Innovations Maritime, Knight Sky LLC (from January 1, 2022 through January 1, 2024) and STS Global dba Network Innovations Advanced Networks (from August 1, 2022 through September 14, 2024). The Plan commenced on April 1, 2008 (amended January 1, 2020) and was restated during June 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All non-union employees of the Company are eligible to participate in the Plan on the first day of employment. Entry date into the Plan is the day the eligibility requirement is met. Members of collective bargaining agreements are excluded.

Funding

Each year participants may contribute up to 90% of their compensation on a pre-tax or post-tax (ROTH) basis as defined in the Plan. According to Internal Revenue Service IRS rules, the deferral may not exceed \$23,000 in 2024 and \$22,500 in 2023. Participants who have reached at least age 50 may contribute an additional catch-up yearly contribution of \$7,500 during 2024 and 2023. Eligible participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The employer will contribute 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of compensation but do not exceed 5% of the compensation. This employer matching contribution is a fully vested safe harbor contribution applied on each payroll period. Contributions are subject to certain limitations.

The employer may also make, at its sole discretion, non-elective (profit-sharing) contributions to the Plan established each Plan year. The profit-sharing contributions would be allocated to each eligible participant in pro rata shares as of the last day of the Plan year.

Participant Accounts

Each participant's account is credited with 1) participant contributions; 2) the employers' matching contribution; and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is charged with any distributions made to that participant.

Vesting

Participants are immediately vested in their elective contributions, rollover contributions, and employer safe harbor matching contributions plus actual earnings thereon. The interest in any employer discretionary contributions plus actual earnings will vest in accordance with the following vesting schedule:

Participants become fully vested upon attainment of normal retirement age while being employed by the Company. Normal retirement age for this purpose is defined as the later of the participant's reaching age 65. Participants also become fully vested on all balances upon death or total and permanent disability while an employee of the Company.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

Payment of Benefits

The Plan provides for mandatory distributions to participants no longer employed by the Plan sponsor with vested account balances of less than \$7,000 excluding any rollovers. If the terminated participant's vested balance does not exceed \$1,000, it will be distributed directly to the participant in cash. If the terminated participant's vested balance is \$1,000 or higher, but does not exceed \$5,000, the balance will automatically be transferred to an IRA under the participant's name unless the participant completes an election form providing other instructions for this mandatory distribution.

Upon termination of service due to disability or retirement, participants may withdraw from the account a lump-sum cash distribution of the vested value of their account.

For participants who die before their account balance distribution, their entire balance must be distributed by December 31 of the calendar year containing the fifth anniversary of their death.

Forfeitures

Forfeitures may be used to reduce employer contributions on an annual basis. During the year ended December 31, 2024, \$124 in forfeitures were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their accounts amounts ranging from \$1,000 up to a maximum of 50% of their vested account balance or \$50,000. Loan terms would not exceed 5 years unless the loan was for the purchase of a primary residence. The maximum loan term for a primary residence is 30 years. The loans would be secured by the balance in the participant's account and bear interest at a rate at 1% over the prime interest rate. As of December 31, 2024 and 2023, interest rates on loans ranged from 4.25% to 9.50% with maturities through 2036. Loans are only available to Plan participants who are active employees of the Plan sponsor or participating employers, therefore, they become payable in full upon termination of employment. Participant loan balances as of December 31, 2024 and 2023 were \$190,631 and \$115,474, respectively. These are reported as notes receivable from participants in the accompanying statements of net assets available for benefits.

Termination

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA. If the Plan were to be terminated, all account balances would become immediately vested.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk

Financial instruments, which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of receivables and investments. The Plan invests in mutual funds, common collective trusts and money market funds, which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

ADP Retirement Services with Reliance Trust Company as trustee held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds and common collective trusts) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$807,867. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used to measure fair value as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5. FULLY BENEFIT-RESPONSIVE COLLECTIVE TRUST

The Plan has a traditional fully benefit-responsive stable value collective trust investment, which was reported at a contract value of \$11,072 and \$9,668 as of December 31, 2024, and 2023, respectively. Contract value is the aggregation of contributions, plus interests, less withdrawals, if any.

NOTE 6. RELATED PARTIES

The Company and participating employers are related parties and absorb virtually all administrative expenses.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 8. TAX STATUS

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management believes that no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to 2021.

NOTE 9. PROHIBITED TRANSACTION

The Department of Labor's (DOL) regulation 29 CFR 2510.3-102 requires that participant contributions be remitted to the Plan on the earliest date on which they can reasonably be segregated from the Company's general assets. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction, which must be separately reported to the DOL and may result in penalties to the Plan sponsor.

During 2023, the participant deferrals of four payroll files totaling \$15,778 were not remitted timely to the Plan. Subsequent to the due date, but prior to the Plan's year-end, the sponsor remitted the contributions. Correction of interest and investment gain was subsequently remitted. These are shown as fully corrected in the Schedule of Delinquent Participant Contributions. There were no such prohibited transactions during 2024.

NOTE 10. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for the Plan through August 8, 2025, the date the financial statements were available to be issued.
