### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Taylor Oil Co., Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The Taylor Oil Co., Inc. 401(k) Plan (the Plan) is administered by Taylor Oil Co., Inc. (Plan Sponsor). The following description of the Plan is provided for general information purposes only. More complete information is provided in the summary Plan description and Plan document, both of which are available from the Plan Sponsor.

**General**

The Plan is a voluntary, participant-directed, defined-contribution 401(k) savings plan as defined under the Internal Revenue Code (IRC), which became effective January 1, 1984. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

All employees of Taylor Oil Co., Inc. and Taylor Oil Northeast, Inc. (together, the Company) who have attained age 20½ and have completed at least one hour of service in a six-month period beginning on the employment commencement date are eligible to participate in the Plan. Eligible employees may enroll in the Plan semi-annually, on January 1 and July 1, immediately following their initial date of eligibility. Participants with 1,000 hours of service in a Plan year are eligible for matching contributions and profit-sharing contributions.

**Contributions**

Participants may elect to contribute up to 99% of eligible pretax or after-tax compensation, as defined by the Plan, up to the annual Internal Revenue Service (IRS) dollar limit. Participants who have attained age 50 are eligible to make catch-up contributions in accordance with, and subject to, IRS limitations. The Plan allows employees to roll over balances from other qualified retirement plans in accordance with ERISA, even when they have not met the eligibility requirements to participant in the Plan. Each year, the Company may make discretionary profit-sharing contributions to the Plan to all eligible participants who are enrolled in the Plan on the last day of the Plan year, and have completed certain service requirements as defined by the Plan. The discretionary contributions, if made, are based on the proportion that the participants' compensation bears to the aggregate compensation of all such participants in the Plan year. The Company may also elect to make discretionary matching contributions each year. There were no discretionary profit-sharing or discretionary matching contributions made for the Plan years ending December 31, 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with an allocation of (a) participant's contributions, (b) Company's contributions, (c) Plan earnings and expenses, and (d) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Portfolio fees charged by the investment funds are applied against the participant's account and reported as a reduction of fund earnings.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting of the Company's profit-sharing contributions and matching contributions is based on years of service. Participants who attain the normal retirement age or become disabled, are automatically 100% vested in their accounts. Vesting in nonelective contributions and matching contributions for all employees is subject to a six-year, graded vesting schedule based on years of service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 Years	0%
A Least 2, but Less than 3	20
At Least 3, but Less than 4	40
At Least 4, but Less than 5	60
At Least 5, but Less than 6	80
At Least 6	100

**Payment of Benefits**

A participant who terminates employment is generally entitled to their vested account balance. Upon termination of employment due to a participant's death, disability or attainment of normal retirement age, the participant's account is considered fully vested and is eligible for distribution generally with a lump-sum payment. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as April 1 following the later of the end of the calendar year of attaining age 72, or retirement. Upon termination, if the vested balance is \$5,000 or less, there is a mandatory distribution. Any amount exceeding \$1,000 can be distributed in cash or may be rolled over to an Individual Retirement Account or Annuity (IRA) for the participant's benefit.

**In-Service Withdrawals**

Participants who have attained age 59½ may request a withdrawal of all or part of the vested portion of their accounts. In the event a participant suffers financial hardship, as defined in the Plan, the participant may withdraw all or part of the vested portion of their account.

**Retirement**

The Plan's normal retirement age is the later of age 65 or the fifth anniversary of participation in the Plan.

**Forfeitures**

Forfeited contributions may be used first to pay administrative expenses, and any remaining amounts will be used to reduce future employer contributions. There were forfeitures of \$19,585 and \$50 available in the forfeiture account at December 31, 2024 and 2023, respectively. No forfeitures were used to pay administrative expenses or to reduce employer contributions during the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their vested account balances. Loan balances are limited to the lesser of 50% of a participant's vested account balance or \$50,000, with a minimum of \$1,000. Participants may only have two loans outstanding at any given time. Interest rates on new loans bear interest at prime plus 1%. Loans must be repaid by payroll deductions over a maximum period of five years unless the loan is a principal residence loan, which can be repaid over 15 years. A participant's vested account balance will be considered by the Plan as security for the outstanding loan balances of all Plan loans made to that participant. If a participant defaults on any outstanding loan, the unpaid balance, and any interest due thereon, shall become due and payable in accordance with the terms of the underlying promissory note.

**Investment Options**

Upon enrollment in the Plan, participants may direct their contributions in any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Quoted market prices are used to value investments, if readily available. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses and Participant Transaction Fees**

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan, are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain expenses that are paid by the Company and reimbursed from the Plan are recorded as accrued expenses by the Plan. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Mutual Fund Fees**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

**Subsequent Events**

The Plan has evaluated subsequent events through August 7, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE PLAN TRUSTEE (UNAUDITED)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

*Registered Investment Company – Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

*Common/Collective Trust* – Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. (Level 2 Input).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan Sponsor has obtained an opinion letter from the IRS dated October 6, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of IRC. Although the Plan has since been amended, the Plan Sponsor believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PLAN TERMINATION**

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions and earnings thereon, as of the termination date.

**NOTE 7 PARTY-IN-INTEREST**

The Plan's investments include investments managed by Reliance Trust Company, the trustee of the Plan, as defined by the Plan. Additionally, administrative expenses are paid to the trustee who acts as the recordkeeper of the Plan and, therefore, those transactions qualify as party-in-interest transactions.

Notes receivable from Plan participants qualify as party-in-interest transactions.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, including interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into various financial instruments.

**NOTE 9 SUBSEQUENT EVENTS**

The Plan changed trustees effective January 2, 2025, the date the Plan assets were first received and accepted by ADP Retirement Trust Services, LLC, the successor trustee.
