To the Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Keller Motors 401(K) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the 2024 audit of Keller Motors 401(K) Profit Sharing Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with the modified cash basis of accounting. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Keller Motors 401(K) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As described in Note 2, these financial statements and supplemental schedule were prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Also, management is responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 – Description of the Plan

The following description of the Keller Motors (“Company”) 401(K) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. General: The Plan is a defined contribution plan covering substantially all employees of the Company who have twelve months of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s investment advisor, Morgan Stanley, determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.
- B. Contributions: Each year, participants may contribute up to 90 percent of pre tax annual compensation which may not exceed a dollar limit which is set by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may contribute an amount equal to the percentage of each contributing participant’s elective deferral which the Company, in its sole discretion, determines from year to year. The Plan allows additional contributions representing distributions from other qualified defined benefit or contribution plans, which are referred to as rollover contributions. Effective September 1, 2023, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 1% of eligible compensation will be contributed to the Plan as a pre-tax deferral. Contributions are automatically invested in a designated balanced fund until changed by the participant.
- C. Participant Accounts: Each participant’s account is credited with the participants’ contribution and an allocation of (a) Company’s contributions and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants’ non vested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.
- D. Vesting: Participants in the 401(K) program are immediately vested in their contributions. Employer contributions become 100 percent vested when participants attain normal retirement age as defined in the Plan or after six years of credited service. Vesting in the profit-sharing program portion of the Company contributions plus earnings thereon is based on years of continuous service.
- E. Participant Loans: Participants may borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear an interest rate equal to 2% above the Wall Street Journal prime rate, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through semi-monthly payroll deductions.
- F. Payment of Benefits: On termination of service, a participant may elect to receive a lump-sum amount or payments in installments. The Plan does not permit distributions in any form other than a lump-sum if the vested account balance does not exceed \$5,000.

G. Forfeited Accounts: On December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,338.37 and \$988.93, respectively. These accounts will be used to reduce future employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Company's policy is to prepare its financial statements on the modified cash basis of accounting; consequently, certain revenues are recognized when received rather than when earned, and certain expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Revenue Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Loans to Participants

Loans to participants are measured at their unpaid principal balance. Interest income on participant loans is recognized when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowances for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant loan is recorded as a distribution based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Management has evaluated subsequent events through August 19, 2025, the date on which the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefit.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted priced for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 2 Fair Value Measurements

According to the Plan custodian, common collective trusts hold a variety of investments that may include bond or money market investments, and the interest in registered investment companies may include investments such as stocks, mutual funds, short-term investments, bonds, etc. Reliance Trust Company owns the underlying assets in the separate accounts. The underlying measurements for the separate accounts have observable (Level 1 or 2) inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the NAV (net asset value) of a separate account is not publicly quoted; accordingly, the fair value of the referenced accounts are reported at Level 2.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Level 1 and 2 and no significant transfers into or out of Level 3.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 5 – Related Party Transactions and Party in Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the trustee are considered party-in-interest transactions.

The Plan's record keeper is ADP, LLC. ADP, LLC received, directly or indirectly, \$5,000 or more in total compensation in connection with services rendered to the plan. Fees paid by the Plan for the recordkeeping services amounted to \$3,568 and \$2,745 for the years ended December 31, 2024 and 2023, respectively.

Jon Keller and Valerie Keller are co-trustees of the Plan. Jon Keller and Valerie Keller are also participants in the Plan. The co-trustees participation in the Plan is in accordance with the Plan's documents. Their employee contributions to the Plan for the years ended December 31, 2024 and 2023, were \$21,000 and \$18,500, each, respectively.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 6 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated July 8, 2014, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan is in compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Certified Investments

Certain information related to investments and loans to participants disclosed in the accompanying financial statements and supplemental schedule, including investments and loans to participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company.
