## **Independent Auditors' Report**

To the Plan Administration of  
Eurpac Service, Inc. 401(k) Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Eurpac Service, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Eurpac Service, Inc. (the "Company" or "Plan Sponsor") 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of the Company who have one year and 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions**

Each year, participants may contribute up to 50 percent of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly hired or rehired eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three (3) percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Plan currently offers various mutual funds, a money market fund and a managed income portfolio as investment options for participants. Upon enrollment in the Plan, a participant may elect to annually contribute to the Plan a minimum of 1%, up to a maximum of 50% of their compensation per payroll period. However, under the Internal Revenue Code ("IRC") for calendar year 2024, the annual maximum employee contribution is \$23,000, plus up to \$7,500 as a catch-up contribution for participants aged 50 or over.

In October 2006, the Plan was amended to allow for the Company's discretionary matching contribution. A matching contribution is announced at the beginning of each calendar quarter and credited to all participants who make an elective contribution during the quarter. The Company contributes 50 percent of the first six percent of base compensation that a participant contributes to the Plan. The Company's matching contributions for the year ended December 31, 2024 amounted to \$741,485.

The Company may designate all or a portion of any nonelective contributions for a Plan year as qualified nonelective contributions and allocate them to non-highly compensated employees. The employees are 100% vested in these contributions and may not request a hardship withdrawal of these contributions.

Any profit-sharing contributions are determined solely by the Company's Board of Directors. The Company did not declare a profit-sharing contribution for the year ended December 31, 2024.

**Rollovers**

Participants may also roll over amounts representing distributions from other qualified plans into the Plan. Participant rollover contributions made to the Plan amounted to \$1,065,012 for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant will be vested in accordance with the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years of service	0%
At least 2 years but less than 3 years	20%
At least 3 years but less than 4 years	40%
At least 4 years but less than 5 years	60%
At least 5 years but less than 6 years	80%
6 years or more	100%

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates of 4.25 to 9.5 percent, which are commensurate with local prevailing rates as determined quarterly at the time the loan is originated by the Plan administrator, and are generally payable in installments over periods ranging from one (1) year to five (5) years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten (10) years). Principal and interest are paid ratably through monthly payroll deductions. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant. Delinquent loans reclassified as distributions were \$417 and included in benefits paid to participants for the year ended December 31, 2024.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant (or their designated beneficiary) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,371 and \$15,118, respectively. These accounts will be used to reduce future employer contributions and Plan administrative expenses. In 2024, employer contributions were reduced by \$39,524 from forfeited non-vested accounts.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and as a corrective distribution.

**Payment of Benefits**

Benefits are recorded when paid.

**Revenue Credits**

Where recordkeeping revenue received in connection with Plan services exceeds agreed-upon compensation, the Trustee can allocate amounts equal to such excess revenue to accounts of eligible participants. Once revenue credit amounts are deposited, the credit will reduce the amount of administrative expenses reported on the financials.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Employer Contributions Receivable**

Employer contributions receivable at year-end represent the employer matching contributions. These contributions are generally received by the Plan in January of the subsequent year. The employer contributions receivable as of December 31, 2024 and 2023 were \$166,842 and \$143,271, respectively.

**NOTE 3: INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE AS COMPLETE AND ACCURATE**

The following information included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained from data that has been prepared and certified to be complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:**

Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

**Common Collective Trust Fund:**

The fund is valued daily. It is the policy of the Trustee to use its best efforts to maintain a stable net asset value (NAV) of \$1 per unit. Neither the fund nor the Trustee can guarantee that the unit value shall always remain at \$1.

The Plan offered its participants a separate fund, Fidelity Managed Income Portfolio (the "Portfolio"), an investment known as a common collective trust ("CCT"). The portfolio is a commingled pool, dedicated exclusively to the active management of the assets of employee benefit plans. The primary investment objective of the Portfolio is to seek the preservation of capital, as well as to provide a competitive level of income over time consistent with the preservation of capital. The portfolio invests in a variety of investment contracts such as guaranteed investment contracts issued by insurance companies and other financial institutions; debt obligations issued or guaranteed by the U.S. government, U.S. government agencies, or U.S. government-sponsored corporations or agencies; debt obligations of domestic and non-U.S. corporations, foreign governmental issuers, and supranational; mortgage-backed securities, including collateralized mortgage obligations and commercial mortgage-backed securities, and other debt instruments backed by mortgage-backed securities; asset-backed securities; obligations issued or guaranteed by U.S. local, city and state governments and agencies; private placements, derivative instruments, cash or short-term obligations; other securities, but not limited to, zero coupon bonds, medium-term notes, preferred securities; and other investment products with similar characteristics.

**NOTE 5: EXCESS CONTRIBUTIONS PAYABLE**

Subsequent to December 31, 2024, certain participant contributions were deemed to be excess contributions under the IRC. Such contributions and the related investment earnings thereon were refunded to the Plan participant in 2025. A liability for excess contributions of \$5,924 were recorded in the Plan's financial statements at December 31, 2024. The Plan Sponsor distributed the 2024 excess contributions payable to the Plan participant prior to the due date of October 15, 2025.

**NOTE 6: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan received a credit from Fidelity Investments Institutional Operations Company, Inc. of \$50,255 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations. Dividend income received by the Plan is net of fees charged to the mutual funds by the administrator or its affiliates. Fees paid by the Plan for the investment management services amounted to \$48,427 for the year ended December 31, 2024.

**NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 8: TAX STATUS**

On June 30, 2020, the IRS stated that the non-standardized pre-approved profit sharing adopted by the Plan, as then designed, qualifies under Internal Revenue Code ("IRC") Section 401(a). The Plan has not received a determination letter specified to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
