Opinion

Note 1 – Plan Description

The following description of the City Holding Company Employee Health and Welfare Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan’s provisions.

General

The Plan is a defined benefit health and welfare plan established February 1, 1991 to provide certain medical, life, accident, disability, and dental benefits to all eligible employees, including their dependents, of City Holding Company and its wholly-owned subsidiaries (the “Sponsor”). In order to participate in the Plan, employees must work a minimum of 24 hours per week. Employees become eligible to participate in the Plan on the first day of the month following their employment date. Employee dependents must also satisfy certain eligibility criteria for participation in the Plan. The Plan also provides these benefits to employees, and their dependents, previously covered under the Plan who meet certain qualifying event criteria specified by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). These former employees and their dependents are entitled by law to have access to medical coverage for limited periods of time as mandated by COBRA. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2024, the Plan document was amended to revise the mandated benefit for testing and treatment for COVID-19 required during the Pandemic back to the standard benefit allowed under the Plan for any other infectious disease or respiratory illness.

Benefits

The Plan includes a partially self-insured medical trust to cover all employees, including qualified dependents, who wish to participate in the Plan and satisfy eligibility requirements. Participants, after selecting single, employee-plus-one, or family coverage, contribute toward the Plan’s costs for medical, dental, vision and prescription drug coverage. The Plan maintains a stop-loss agreement with an insurance company under which the insurance company is obligated to reimburse the Plan for payments of claim expenses exceeding the Plan’s claim liability limit.

The Plan also provides life insurance and accidental death and dismemberment insurance for all qualified employees at no cost to the employee. Minimum life coverage is \$50,000 and maximum life coverage is \$800,000.

Through July 31, 2024, the Plan offered supplemental life insurance and long-term care insurance to employees and their dependents on a voluntary basis. Employees paid 100% of the cost of these insurances based upon their selected level of coverage. Effective August 1, 2024, the long-term care insurance policy was canceled by the provider and is no longer provided to employees on a voluntary basis.

Long-term disability benefits, for either total or partial disability, are paid when an employee has been unable to work for a period of 180 days and is medically deemed unable to return to work.

Insurance policies have been obtained by the Plan to provide life insurance, accidental death and dismemberment, long-term disability benefits, voluntary supplemental life insurance, and voluntary long-term care.

All other Plan benefits are self-insured. Health claims of active participants and their covered dependents are processed by the Plan Administrator.

If the Plan is terminated, the participant is not entitled to benefits after the effective date of termination. Any such termination shall not affect a participant's right to benefits for claims incurred prior to termination.

Any rebates received by the Plan are netted against claims paid.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement with Nationwide Life Insurance Company in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

Contributions

The Sponsor's funding policy is to make monthly contributions to the Plan in such amounts that all benefits, excluding voluntary benefits, will be fully provided for according to the Plan's provisions. Employees provide periodic contributions through payroll withholdings based on the level of coverage selected for medical and dental benefits, voluntary supplemental life insurance, and voluntary long-term care benefits.

Employee premiums are determined internally and approved by management. An analysis is performed on current and prior year costs, benchmark reports, and benefits surveys to determine the amount of increase for employees each year.

Plan funding is monitored by the Plan Administrator. Claim payments, stop-loss insurance premiums, retention, and administrative fees and expenses are paid by the Plan's trust. Contributions to the Plan are deposited directly into the trust by the Sponsor, as stipulated by the Plan document.

Administrative Services Agreement

Benefits Assistance Company, LLC is the recordkeeper for the Plan and serves as the claims processor. Fees paid by the Plan to Benefits Assistance Company, LLC were \$205,779 during 2024. Cigna performs a variety of services for the Plan including medical necessity reviews and PPO claims repricing. Fees paid by the Plan to Cigna were \$179,266 during 2024.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets, liabilities, benefits obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Cash

The Plan's cash is held at a commercial bank. Funds are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, deposits may exceed federally insured limits.

Benefit Obligations

As of December 31, 2024 and 2023, material benefit obligations of the Plan consist of claims payable, which include claims processed and unpaid at year-end and estimated claims incurred but not reported. The Plan has estimated the claims incurred but not reported based on historical claim information.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Sponsor, as provided by the Plan document.

Claims Payable and Claims Incurred but not Reported

Plan obligations for unprocessed health, vision, prescription, and dental claims, as well as claims incurred by active participants but not reported at that date, are estimated by the Sponsor based on claims runout information provided by Benefit Assistance Company, LLC. For purposes of this calculation, the Plan does not distinguish between claims reported and not paid and obligations incurred but not reported. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 3 – Tax Status

Although the Trust, as established under the Plan, has not received an exemption letter from the Internal Revenue Service stating that the trust is tax-exempt under Section 501(a) of the *Internal Revenue Code (IRC)*, as a Voluntary Employee Beneficiary Association, the Plan Administrator believes the Plan and its associated Trust have been designed and are operating to qualify under the appropriate sections of the *IRC* as exempt from federal income taxes. As an employee welfare benefit plan, the Plan and its associated Trust are operating in conformity with the *IRC* and ERISA.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 4 – Related Party Transactions

The Sponsor provides certain accounting and administrative services to the Plan without charge. The Sponsor also pays certain administrative costs on behalf of the Plan, including legal and accounting fees.

Plan assets are invested in a noninterest-bearing checking account maintained with one of the Sponsor's subsidiaries.

Note 5 – Plan Termination

Although it has expressed no intention to do so, the Sponsor reserves the right to discontinue the Plan at any time, and for any reason, and without notice to the members.
