### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Midlands Packaging Corporation 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### Opinion

#### Note 1—Plan Description

The following description of the Midlands Packaging Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all employees of Midlands Packaging Corporation (the Company) who have at least six months of service and are at least twenty and one-half years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective matches made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

##### Contributions

Contributions to the Plan are made as follows:

Participant Contributions—Participants may contribute a portion of their pre-tax compensation to the Plan, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan has adopted an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Contributions are automatically invested in a designated target age retirement fund until changed by the participant.

The Plan also has a Roth contribution feature. Participants are permitted to contribute up to the dollar limit set by law a portion of their taxable compensation to the Plan, subject to Internal Revenue Service (IRS) limitations.

Upon determination of the participant's contributions, the Company remits contributions to the trustee, which are allocated to individual employee accounts and invested at the participants' direction.

Participant Investment Rollovers—The Plan permits participants to transfer or rollover funds into the Plan from other qualified plans.

Employer Matching—The Company has a matching provision using a discretionary formula. The Company's matching contributions were equal to 50% of each participant's contributions, not in excess of 5% of eligible compensation. Total employer matching contributions for the years ended December 31, 2024 and 2023 were \$170,814 and \$174,094, respectively.

Employer Discretionary Contribution—The Company may also elect to make annual discretionary profit sharing contributions. The Company made no discretionary contributions for the years ended December 31, 2024 and 2023.

#### Note 1—Plan Description (Continued)

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's matching contribution and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Payment of Benefits

On termination of service due to death, disability, retirement or severance of employment, a participant with a balance exceeding \$5,000, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not more than their assumed life expectancy. For participants with balances less than \$5,000, the vested account balance may only be distributed as a single lump-sum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as lump-sum distribution.

Hardship withdrawals are permitted from participant accounts if they meet the financial need requirement as permitted by the IRS.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in employer contributions and investment earnings according to the number of years of service as follows:

##### Notes Receivable From Participants

The Plan permits all participants to borrow against their account balance. The minimum loan amount is \$1,000. Participants may borrow an amount up to 50% of their vested account balance, up to a maximum of \$50,000. The notes are secured by the balance in the participant's account.

Loan terms may not exceed five years, however, may be for a longer, reasonable period of time if used for the purchase of a primary residence. The interest rate on loans is at 1% above the prime rate as provided by Ameritas Life Insurance Corporation (Ameritas). Principal and interest are paid ratably through payroll deductions.

##### Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan with Ameritas.

#### Note 2—Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

##### Administration of the Plan

Although there is no requirement to do so, the Company has paid certain administrative costs of the Plan. In addition, certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

As of December 31, 2024 and 2023, all plan assets are held and managed by Ameritas, which invests cash received, interest and dividend income, and makes distributions to participants.

##### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in funds of pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, these fees are reflected as a reduction of net appreciation in fair value of investments.

The change in net unrealized appreciation (depreciation) of investments held from the beginning of the plan year to the end of the plan year is included with realized gains (losses) as net investment income (loss) reported in the accompanying statements of changes in net assets available for benefits.

##### Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### Payment of Benefits

Benefits are recorded when paid.

##### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

##### Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Note 3—Information Certified or Provided by Ameritas Life Insurance Company (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Ameritas Life Insurance Company, the trustee of the Plan. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

#### Note 4—Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Pooled Separate Accounts

The pooled separate accounts are valued at the net asset value (NAV) of the shares held by the Plan at year-end and are classified in Level 1 of the fair value hierarchy. These funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAVs are received daily from fund managers, and the managers stand ready to transact at these quoted amounts. The insurance company custodian transacts in these funds on a daily basis as part of the separate account trading activity.

The calculation of the NAV for funds composed of other funds is essentially the same as the calculation of the NAV for any other fund. The total market value of assets across all underlying funds less any liabilities is divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices.

#### Money Market Fund

The money market fund is classified in Level 1 of the fair value hierarchy as fair value is based on quoted prices in active markets for identical securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement

at the reporting date.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

#### Note 5—Guaranteed Investment Contract with Insurance Company

The Plan has a traditional fully benefit-responsive investment contract with Ameritas, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$2,454,621 and \$2,608,342, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

#### **Note 5—Guaranteed Investment Contract with Insurance Company (Continued)**

Certain events limit the Plan's ability to transact at contract value with Ameritas. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6—Deposits with Investment Company**

Except for the guaranteed investment contract as described in Note 5, all plan investments are held in collective investments by Ameritas. Their collective investments are maintained in pooled separate accounts and money market funds which consist of investments selected to meet a range of investment objectives. Returns are based upon the underlying investments within each pooled separate account.

For each participant, the account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Ameritas and the plan administrator. The investments are included in the financial statements at fair value, as reported to the Plan by Ameritas.

The plan administrator has received information from Ameritas certifying the values and earnings on the investments.

#### **Note 7—Forfeitures**

The Plan provides that forfeited nonvested accounts be allocated to all participants eligible to share in the allocation in proportion to each participant's eligible compensation for the year. Forfeitures allocated to eligible participants were \$134,983 and \$3,104 for the years ended December 31, 2024 and 2023, respectively.

Administrative expenses paid from forfeitures totaled \$0 and \$125 for the years ended December 31, 2024 and 2023, respectively. Employer contributions reduced by forfeitures totaled \$134,583 and \$6,229 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,136 and \$714, respectively.

#### **Note 8—Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts are 100% vested and non-forfeitable.

#### Note 9—Tax Status

The IRS has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust under Ameritas Life Insurance Corporation are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan administrators to evaluate tax positions taken by the plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### Note 11—Related Party Transactions

Certain plan investments are shares of pooled separate account, money market funds and a guaranteed investment contract managed by Ameritas, who is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for the investment management services were \$6,977 and \$3,863 for the years ended December 31, 2024 and 2023, respectively.

#### Note 12—Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## Schedule C, Line 2(h) Formula Description

### Description of Unit Value Calculations

Separate account investments are record kept using unit values.

The pooled separate accounts are invested in mutual funds at NAV. The allocation of these funds is based on the units and unit value for each product and plan invested in the pooled separate account.

Both the number of units, and unit value is available for any plan's funds and can be produced from the system. When multiplied, these will balance to the fair value disclosed on trust reports.

The unit value can and does vary by contract depending on the product invested in. The unit value is determined under the following formula, and is the same calculation for all contracts invested in the pooled separate accounts.

It is through this calculation of the unit value that both earnings and expenses are applied.

NAV = Net asset value provided by mutual fund company

MTD daily dividend factor(t) = dividends month to date as provided by the mutual fund company

Unit Price = the contract specific price in which units are purchased and redeemed for a specific fund

In order to ensure that each contract has a correct proportionate value of the underlying pooled separate account, each contract's units are multiplied by their contract's unit value and summed across all contracts invested in a particular mutual fund. This is then balanced to the pooled separate account and to the mutual fund company on a daily basis.

The Daily Expense Factor is based on the provisions of the contract, with all investments held by Ameritas Life Insurance Corp being charged the same annualized rate.
