Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Core Products Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

General

Core Products International, Inc. (the Company) established the Plan effective January 1, 2017. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). An officer of the Company is the Plan's trustee.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after completing one year of service. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of the plan year are generally not eligible for an allocation of Company contributions for such plan year.

Contributions

The Company may make contributions to the Plan, at the discretion of the Company's board of directors, if the form of cash, Company stock, or a combination of both. Employees are not permitted to make contributions. The Company made a contribution of \$200,000 for the year ended December 31, 2024.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of cash from the Company and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations of cash and forfeitures are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to a participant's account based on the ratio of the participant's account balance to the total account balance of all participants.

Vesting

Participants vest in the Company's contributions and earnings thereon based on years of credited service. Participants with less than one year of credited service will be 0% vested and for each of the next five years will become vested at a rate of 20%, becoming fully vested in their account balance after six years.

In the event of the participant's death, disability, or attainment of normal retirement age while employed by the Company, the participant's account becomes fully vested.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Forfeitures result when participants leave the Company before their accounts become fully vested. Forfeited balances of terminated participants' nonvested account balance may be used to reinstate previously forfeited account balances of former participants, with any remaining forfeitures allocated among the participant accounts in a similar manner as employer contributions. During 2024, \$8,591 of cash forfeitures were allocated to participants.

Diversification

Diversification is offered to participants close to retirement so that they have the opportunity to move part of the value of their investment in Company's common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any share previously diversified. In the sixth year the percentage changes to 50%. Participants who elect to diversify receive a cash distribution, stock distribution, may transfer the amount to alternative investments within the Plan, or may transfer the amount to another qualified plan of the Company.

Payment of Benefits

Distributions on account of death, disability, or retirement are made in a lump sum or installments in the Plan year following the event. Distributions for other separations from service in excess of \$5,000 commence by the fifth Plan year following the separation from service and are made in a lump sum or installments. Distributions for other separations from service less than \$5,000 are made in a lump sum in the Plan year following the separations from service. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Voting Rights

The trustees will vote all shares of the Company's common stock held by the Plan. The participants are entitled to direct the trustee as to their vote on matters which involve a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of the Company.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, using the valuation methods described in Note 3. Interest income is recorded on the accrual basis.

Contributions

Contributions from the Employer are recorded in the year in which the contribution is approved by the Company's board of directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Costs

Expenses incurred in the administration of the Plan are paid by the Company and the Plan. Expenses incurred by the Company are excluded from these financial statements.

Subsequent Events

The plan administrator has evaluated subsequent events through July 24, 2025, the date which the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted priced that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INCOME TAX STATUS

The Plan obtained a determination letter on July 17, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan has been amended since receiving the determination letter. However, Plan management believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the trustees may determine. The interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

As described in Note 2, the Company and the Plan pay Plan expenses. The Plan relies on service providers and Plan assets are managed by the trustee. Such parties are parties-in-interest under ERISA. Transactions with these parties qualify as party in interest transactions.
