NOTE A – DESCRIPTION OF THE PLAN

Livingston Hearing Aid Center, Inc. (the “Company”) is the plan sponsor for the Livingston Hearing Aid Center, Inc. 401(k) Plan (“the Plan”). The Plan was established March 1, 2000. Participants should refer to the plan documents for a complete description of plan provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees make contributions to the Plan at rates which they set. Employer contributions are discretionary. The Company has not made contributions to the Plan for the years ended December 31, 2024 or 2023.

Administration

Principal Life Insurance Company (“the Trustee”), a member of Principal Financial Group, has been contracted by the Plan to act as administrator, record keeper, investment manager, and custodian of the Plan, subject to an agreement dated July 1, 2010.

Eligibility

Employees become eligible for the Plan when they attain age 21 and have worked for the Company for a minimum of three months. Employees may enter the plan on January 1, April 1, July 1, or October 1.

Employee Contributions

Employees determine how much they would like to contribute to the Plan, either as a percentage of gross wages or as a flat dollar amount. Contributions are subject to limitations described in Internal Revenue Code (“IRC”) §401(k). Contributions may be made pre- or post-tax.

Investments

The investment fund options include a variety of mutual funds with different levels of risk and related earnings. Participants may choose which funds to invest in when they first enroll and may change their investment selection at any time subsequent by contacting the Trustee.

NOTE A – DESCRIPTION OF THE PLAN, CONTINUED

Vesting

Each participant’s employer contributions, if applicable, vest over a period of six years as follows:

3 Years	40%
4 years	60%
5 Years	80%
6 Years	100%

If a participant passes away or becomes disabled, the participant’s accrued benefit derived from employer contributions, if any, becomes 100% vested without regard to the above schedule. In the event of a full or partial termination of the Plan, the affected participants will become 100% vested.

At December 31, 2024 and 2023, the participants’ vested interest in their accounts were \$7,642,193 and \$6,198,449, respectively.

Loans

Participants may withdraw loans from their vested accounts. They may withdraw as a loan a maximum of \$50,000 or 50% of their vested account, whichever is lower. Repayment is required within five years.

Payment of Benefits

Distributions may be made when employees retire and are age 65, are age 59.5 and still working, have died, have become disabled, have their employment terminated, or are suffering a financial hardship.

When benefits are paid at retirement, distributions will be made on your retirement date, unless the participant elects otherwise. If the participant retired early or is otherwise no longer employed by the company, the distributions will be made the earliest first day of the month on or after the date the participant attains age 65. Distributions will begin no later than April 1 during the calendar year when a participant reaches age 70.5.

Requests for withdrawals must be provided in writing on a form provided by the plan administrator. Distributions may be all or part of a participant’s vested account.

NOTE A – DESCRIPTION OF THE PLAN, CONTINUED

Termination of the Plan

The Company may terminate the plan at its own discretion. Participants become 100% vested in their accounts in the event of a termination.

The Company has no plans to terminate the plan as of August 14, 2025, the date the financial statements were available to be issued.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared in accordance with the accounting principles generally accepted in the United States of America (“US GAAP”) and accordingly are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Valuation of Investments

The Plan’s investments are stated at fair value based on quoted market prices. Loans are valued at cost, which approximates fair market value.

The Statement of Changes in Net Assets reflects the net appreciation (depreciation) in the fair value of its investments, which includes the realized and unrealized gains and losses on those investments. Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued when earned, if applicable. Dividend income is recorded on the ex-dividend date, if applicable.

Administrative Expenses

The Plan is responsible for the payment of administrative fees owed to the Trustee for the management of the Plan. Administrative fees were \$66,373 and \$47,813, respectively, during the years ended December 31, 2024 and 2023.

Other expenses associated with the Plan, including audit fees, are paid by the Company. The Company paid \$20,820 and \$10,010, respectively, during the years ended December 31, 2024 and 2023.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Operating Expenses

Operating expenses include, but are not limited to, custodial fees, transfer taxes, brokerage fees, processing fees, and other taxes and fees associated with the operation of a separate account. Operating expenses are deducted from the separate accounts associated with a particular charge on the next valuation date after the operating expenses have been paid or are payable.

NOTE C – INVESTMENTS

FASB ASC 820-10 requires that investments be measured at fair value using one of three levels. Level 1 measurements use unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date. Level 2 measurements generally use available indirect information, such as quoted prices for similar assets or liabilities in active markets, quote prices for identical or similar assets or liabilities in markets that are not active, or inputs that are observable for the asset or liability, such as interest rates or yield curves. Level 3 measurements are the most subjective and are generally based on the entity’s own assumptions developed using the best information available in the circumstances.

The Plan’s investments in mutual funds were valued using Level 1 measurements.

#### NOTE D – INCOME TAX STATUS

The Plan is operated by Livingston Hearing Aid Center, Inc. The Plan operates as a qualified plan of an organization under IRC §401(a). The Plan obtained its latest determination on March 31, 2014, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan was amended on December 31, 2019. The Plan administrator believes that the Plan is designed and being operated in accordance with the applicable requirements.

Open audit years for the Plan include 2020-2024.

#### NOTE E – RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks including interest rates, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits. The Plan assets are not covered under any collateralization agreements or other credit risk mitigating financial arrangements.

#### NOTE F – RELATED PARTIES

The Company pays audit fees and any other expenses which may arise for the Plan on behalf of the Plan.

The Trustee acts as record keeper, investment manager, and custodian of and for the Plan. The Plan pays reasonable fees to the Trustee for these services.
