## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Benesch, Friedlander, Coplan and Aronoff Elective Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following description of the Benesch, Friedlander, Coplan, and Aronoff Elective Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan began December 31, 1968 and is a defined contribution plan covering significantly all employees of Benesch, Friedlander, Coplan, and Aronoff LLP and West Four LLC (the "Firm") who have completed at least one month of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions:

Participants may make voluntary pre-tax or Roth 401(k) contributions of up to 90% and after-tax contributions of up to 50% of their compensation, subject to certain limits imposed by the Internal Revenue Service ("IRS"). The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover).

The Firm may make discretionary matching contributions or profit sharing contributions to the Plan for the related year. Discretionary matching contributions are allocated as of the last day of the Plan year and are allocated based on the ratio of participants' payroll reduction contributions to all participant payroll reduction contributions. There were no such matching contributions authorized for 2024. Qualified non-elective contributions (profit sharing) are given only to participants employed at the end of the Plan year who have completed at least 1,000 hours of service during the Plan year, and are based on participants' compensation for the Plan year.

Participant Accounts:

Each participant's account is credited with the participant's contribution and an allocation of any Firm contribution and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants direct their investment fund options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to the extent of one-half of their vested account balance under the Plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account. A participant may have two loans approved in any twelve-month period, but may only have one outstanding loan balance at any time. The loan interest rates will be based on the rates available for similar loans from commercial lending institutions. Principal and interest is paid ratably through payroll deductions.

**Note 1. Description of Plan (Continued)**

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Firm's contribution portion of their accounts is based on years of continuous service. A participant is fully vested after two years of credited service with no vesting before that time or upon becoming disabled.

Payment of Benefits:

A participant or his/her beneficiary, upon termination, death, or retirement, receives payment of his/her vested account balance in the form of a lump sum or annuity options. Additionally, the Plan has provisions for an active participant to make in-service and hardship withdrawals from his/her account, subject to limitations and restrictions.

Forfeited Accounts:

Forfeited nonvested accounts are utilized in the Plan year subsequent to the year in which they were transferred to the forfeiture account. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,664 and \$1,191, respectively. During 2024, \$127 was used to reduce administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").
- B. Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Fidelity Management Trust Company ("Fidelity"). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments, the plan administrator deems the participant loan to be in default. The change in this allowance each year is reflected as deemed distributions on the statement of changes in net assets available for benefits and is net of previously defaulted loans of former participants who took full distribution of their accounts in the current year. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Note 2. Summary of Significant Accounting Policies (Continued)**

- D. Administrative Fees – Fees of the Plan are paid by the Firm or the Plan at the discretion of the Firm. Certain transactions and account maintenance fees are charged to the affected participants. Revenue credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. The Firm monitors the payments received by the Plan service providers to ensure they are used properly for qualifying Plan administrative and operating expenses. The revenue credit account had a balance of \$-0- and \$48,566 at December 31, 2024 and 2023, respectively, and \$51,458 was used to reduce administrative expenses during the year ended December 31, 2024.
- E. Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- F. Benefit Payments – Benefits are recorded when paid.
- G. Subsequent Events – The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

**Note 3. Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will receive a total distribution of their account.

**Note 4. Unaudited Information**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Fidelity Management Trust Company, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, the supplemental schedule as of December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

**Note 5. Fair Value Measurements (Continued)**

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- The fair value of investments held in the money market and mutual funds is determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.
- The investments in the common/collective trusts are held by Fidelity. The fair value of investments held in these accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Income Tax Status**

The Plan has adopted an approved volume submitter Plan document. This Plan document has obtained an opinion letter dated June 30, 2020 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 7. Party-in-Interest Transactions**

Certain Plan investments are held in a money market fund and mutual funds managed by Fidelity. Administrative expenses were paid to Fidelity or its affiliates during 2024. Fidelity is the Trustee and recordkeeper as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

**Note 8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
