**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Cedar Electronics Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Cedar Electronics Holding Corporation (the “Company”) established the Plan effective January 1, 2017. The Plan was amended and restated effective January 1, 2021 to comply with the legislative and regulatory changes set forth in Internal Revenue Service (“IRS”) Notice 2017-37. The Plan is a defined contribution plan covering substantially all employees of the Company, as defined in the Plan document. For full-time, part-time, temporary, and seasonal employees, as well as interns, there is no service or age requirement to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Cedar Electronics Corporation 401(k) Plan Committee (the “Committee”) that serves at the discretion of the Company’s Board of Directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, and directing the Plan’s trustee.

Contributions: Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code (“IRC”) limitations of their pre-tax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows participants to designate all or a portion of their deferrals as Roth contributions to the Plan on an after-tax basis.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated investment fund until changed by the participant.

The Plan provides for discretionary Company matching contributions for eligible participants. For the year ended December 31, 2024, the Company elected to match 50% of the first 6% of eligible compensation that a participant contributed to the Plan. For the year ended December 31, 2024, the Company made \$302,050 in matching contributions.

Additionally, the Plan provides for discretionary Company profit-sharing contributions to the Plan as approved by the Company’s Board of Directors. Participants must have completed one year of service and be employed on the last day of the Plan year in order to be eligible to receive an allocation of any discretionary Company profit-sharing contributions. Allocations are based on a ratio of each participant’s compensation as it bears to total compensation of all eligible participants. The Company did not make any discretionary Company profit-sharing contributions to the Plan for the year ended December 31, 2024.

Contributions are subject to certain IRC limitations.

Participants may direct all their contributions among one or more funds offered by the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted, pursuant to the Plan’s provisions.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Participant Accounts: Each participant's account is credited with the participant's contributions and any discretionary Company matching contributions, as well as allocations of (a) any discretionary Company profit-sharing contributions, and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one outstanding loan at any given time. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Interest rates on loans outstanding range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years or for loans used for the purchase of a primary residence, a longer term may be granted.

Retirement, Death and Disability: A participant is entitled to 100% of their account balance upon retirement, death or disability.

Payment of Benefits: On separation of service due to death, disability, termination of service, or retirement, a participant will generally receive the value of their vested interest in their account in the form of a lump-sum amount, or they may elect to rollover their account to another entity. In-service withdrawals are allowed upon attainment of age 59½. Installment payments are only permitted for required minimum distributions. If the participant's vested interest in the Plan is less than \$5,000, a mandatory lump-sum distribution may be made to the participant.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in any discretionary Company matching contributions and discretionary Company profit-sharing contributions is based on years of continuous service, as follows:

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan. Any expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and requested distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included as a component of net appreciation in fair value of investments.

Forfeited Accounts: Forfeitures of non-vested Company contributions will generally be used to pay administrative expenses or reduce future Company contributions. For the year ended December 31, 2024, \$586 was used to reduce Company contributions. There were \$12,168 and \$8,989 of unused forfeitures at December 31, 2024 and 2023, respectively.

Plan Termination: The Company reserves the right, by action of its Board of Directors, to terminate the Plan at any time, subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). In the event of termination of the Plan, participants become 100% vested.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions, and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefit payments are recorded when paid.

Reclassifications: Certain prior year amounts have been reclassified in the statements of net assets available for benefits as well as the related notes to the financial statements to conform with current year presentation. Reclassifications had no effect on the total net assets available for benefits previously reported.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through August 20, 2025, which is the date the financial statements were available to be issued.

## **NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

## **NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs when measuring fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Registered Investment Companies:* The fair value of the plan interests in registered investment companies (mutual funds) are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Money Market Fund:* The money market fund held by the Plan is a government money market fund. The fund seeks to maintain a constant net asset values of \$1 per share by investing in high-quality, U.S. dollar denominated money market securities issued by the U.S. government and its agencies and instrumentalities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – GROUP ANNUITY INVESTMENT CONTRACT**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract through a group annuity investment contract with Standard Insurance Company (Standard) in Stable Asset Fund III, totaling \$915,523 and \$1,436,806 as of December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the issuer and is reviewed quarterly for resetting. The declared rate will not be less than 1% per annum. The contract does not permit Standard to terminate the agreement prior to the scheduled maturity date, except under contractually defined events.

This contract meets the criteria for a fully benefit-responsive investment contract and is therefore reported at contract value. Contract value is the relevant measurement attribute because it is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's capacity to fulfill its obligations may be affected by future economic or regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or removal of equity wash provisions; (3) bankruptcy of the Plan sponsor or other sponsor-related events (such as divestitures or spinoffs) that cause significant withdrawals; (4) the failure of the Plan to maintain its qualified status under the Internal Revenue Code or failure to satisfy applicable prohibited transaction exemptions under ERISA; or (5) premature termination of the contract. As of the financial statement date, no such events are considered probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of a material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Charles Schwab Trust Bank is the Plan's trustee and, therefore, the Plan's payment of trustee fees to Charles Schwab Trust Bank qualify as party-in-interest transactions. Investment management fees are also paid by the Plan to parties-in-interest and are reflected as a reduction of the investment returns earned by the Plan on its investments. Notes receivable from participants held by the Plan are also considered party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 7 – TAX STATUS**

The Plan adopted a prototype plan document from USI Consulting Group, which received an opinion letter from the IRS on June 30, 2020, stating that the pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and that the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
