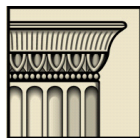

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Khorporate Holdings, Inc. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i —Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Years ended December 31, 2024

1. Description of the Plan

The following description of the Khorporate Holdings, Inc. Employees' Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan, which was established effective July 1, 2016, is a defined contribution plan sponsored by Khorporate Holdings, Inc. (Company). The Plan covers substantially all full-time eligible employees of Alliance Winding Equipment, Inc., CR Magnetics, Inc.; Electric-Tec, LLC; Mossberg Industries, Inc.; X-Y Tool and Die, Inc.; Bralin Laser Services, Inc.; EM&S Motors, LLC; K & S Mold, Inc.; and Plastic Components – PCI, LLC starting August 1, 2022, who have attained the age of 21 and have completed one year of service. The entry date for this Plan is the first day of each plan quarter coinciding with or next following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

An employee, excluding union, leased, and non-resident alien employees, becomes eligible to enter the Plan on the first day of the quarter immediately following attainment of the age of 21 and one year of service.

Contributions

Participants may defer and contribute a percentage or dollar amount of their pre-tax or after tax (Roth) compensation, as defined by the Plan, not to exceed certain dollar limitations that are set by law. Contribution elections may be updated at any time but take effect the first day of each Plan quarter. Participants age 50 or older may elect to defer and contribute additional amounts to the Plan up to a maximum that is set by law. Participants may also make rollover contributions of amounts representing distributions from other plans and certain Individual Retirement Accounts (IRA). Additionally, the Plan allows participants to change the amount of their contribution in accordance with the procedures the Company provides.

Each adopting division may make a discretionary matching contribution equal to a uniform percentage of the amount of salary reduction each participant elects to defer. For the years ended December 31, 2024 and 2023, the adopting matching rates were: Alliance Winding Equipment, Inc. – 50 percent of the first 6 percent of eligible compensation; Bralin Laser Services, Inc. – 100 percent of the first 3 percent of eligible compensation; CR Magnetics, Inc. – effective July 1, 2023,

Contributions (continued)

50 percent of the first 6 percent of eligible compensation (prior to June 30, 2023, 100 percent match of the employee contribution up to 2 percent of total compensation with a maximum annual contribution of \$500 per participant); K&S Mold, Inc.—100 percent of the first 4 percent of eligible compensation; Mossberg Industries, Inc.—100 percent of the first 4 percent of eligible compensation; X-Y Tool, Inc.—50 percent of the first 6 percent of eligible compensation; Electric-Tec, LLC—50 percent of the first 6 percent of eligible compensation effective July 1, 2022; Plastic Components—PCI, LLC—25 percent of the first 6 percent of eligible compensation effective August 1, 2022; EM&S Motors, LLC—50 percent of the first 6 percent of eligible compensation effect July 1, 2023. Each adopting division may also make an additional nonelective contribution to the Plan (excluding all highly compensated employees).

Investment Options

Participants can direct that their pre-tax and Company contributions, plus earnings or losses thereon, be invested in any of the participant directed investment options offered pursuant to the Plan. The Plan allows participants to change their investment elections on a daily basis.

The investments of the Plan consisted of diverse portfolios with no significant concentration of risk by issuer, industry, or geographic location.

Participant Accounts

Each participant's account is credited or charged with allocations of (a) the participant's contributions, (b) the Company's matching and nonelective contributions, (c) investment gains or losses, and (d) participant fees (including but not limited to quarterly asset and contract fees related to investment funds held and withdrawal charges for disbursements and loans). Plan earnings (losses) are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant contributions, matching Company contributions, and Company nonelective contributions are invested at the direction of the participant in the investment options available to the Plan. A participant may change his investment options as permitted by the Plan.

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in their contributions, including rollovers, plus actual investment earnings or losses thereon. Vesting in the Company's matching contribution is based upon years of service. Participants become 25 percent vested in the Company's contribution after one year of service and increase by 25 percent each year, until they become 100 percent vested after 5 years of service.

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their employer contribution amount. These forfeitures are used to reduce employer contributions or pay Plan administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$16,177 and \$2,747, respectively, were used to pay Plan administrative expenses. At December 31, 2024 and 2023, there was \$825 and \$38,660, respectively, in the forfeiture account to reduce employer contributions or pay Plan administrative expenses.

Notes Receivable from Participants

Participants may borrow approved amounts, not less than \$1,000, from their vested account balance up to the lesser of (a) \$50,000 reduced by (if any) the highest outstanding balance of loans from the Plan in the past twelve-month period prior to the date of the loan or (b) 50 percent of the vested account balance. A participant may have no more than one loan outstanding at a time and the term of the loan may not exceed 60 months. If a loan is for the purchase of a primary residence, the term will be 360 months. The loans are secured by the balance in the participant's vested account and bears interest at a prime rate as determined by the Plan administrator. The loan must provide at least quarterly payments under a level amortization schedule. For participants currently employed by the Company, the Plan requires the participant receiving a loan from the Plan to enter into a payroll deduction agreement to repay the loan.

Payment of Benefits

Normal retirement age under the Plan is 65 years, with the option to withdraw funds at the age of 59½. Minimum distributions are required once the participant reaches a specific age as required by law. On termination of service or retirement, a participant has the following options regarding his or her value of the vested interest: a) receive a lump-sum payment, b) roll over the balance into

another qualified plan, or c) remain in the Plan as an inactive participant. However, if a terminated participant's vested account balance is \$7,000 or less and they have not elected a rollover, they will involuntarily receive a lump-sum distribution. If a participant is still a current employee and has not yet reached retirement age, the participant (or beneficiary) can only withdraw funds in the event of death, a disability which prevents them from working, or through a hardship withdrawal. Hardship withdrawals are only allowed from elective deferral accounts, as outlined in the Plan document.

Administrative Expenses

The expenses of administering the Plan are paid from the Plan unless the Company elects to pay the expenses. The Company also provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. The total amount in each participant's account is to be distributed to the participant, his or her beneficiary, or continued in trust for the participant's benefit.

2. Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 5* for discussion of fair value measurements.

Investments (continued)

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

The Plan includes in the statements of changes in assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. Unrealized appreciation or depreciation in the aggregate fair value of investments represents the change in the difference between aggregate fair value and the cost of investments, including reinvestment of earnings. The realized gain or loss on sale of investments is the difference between the proceeds received and the average cost of investments sold.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan origination and annual administration fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, then the participant loan balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Use of Estimates

Preparation of the Plan's financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Reclassifications

Certain 2023 amounts have been reclassified to conform with the 2024 presentation.

3. Income Tax Status

The Plan administrator believes that the Plan, as amended, is being operated in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt and the Plan has no income subject to unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to take that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

4. Investments

Certain information related to investments disclosed in the accompanying financial statements and schedules, including investments held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments and interest and dividend income for the years then ended, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Great-West Trust Company and Great-West Life & Annuity Insurance Company, the custodians of the Plan.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to

valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 or 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Fully-Benefit Responsive Investment Contract

The Plan has a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company which is called the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$973,095 and \$846,429, respectively. The crediting interest is based on a formula agreed upon by the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator does not believe that any events such as plan termination which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The investment contract does not permit Great-West Life & Annuity Insurance Company to terminate the agreement prior to the scheduled maturity date.

7. Transactions with Parties-in-Interest

The Plan investments include an investment contract issued and managed by Great-West Life & Annuity Insurance Company and its subsidiaries. Great-West Trust Company, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as parties-in-interest.

Fees paid by the Plan to Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC, the trustees of the Plan, and LPL Financial, Old National Bank, and Retirement Plan Concepts and Services for investment management and other services amounted to \$53,269 and \$53,211 for the years ended December 31, 2024 and 2023, respectively. The Plan also had a receivable from Old National Bank of \$134,000 at December 31, 2023.

8. Subsequent Events

Management has evaluated subsequent events through July 15, 2025, the date on which the financial statements were available to be issued.
