Basis for Opinion

NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of the E-Force Logistics, LLC 401(k) Plan (the "Plan") are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan are adjusted annually to closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on these investments are computed using adjusted basis on the first-in, first-out method. Security transaction expenses are considered in computing realized gains and losses on investments.

Investments: Investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis and are considered in the determination of the net asset value. Gains and losses (realized and unrealized) are reported in net appreciation in fair value of investments in the statements of changes in net assets available for benefits.

Payment of Benefits: Benefit payments are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Reclassification: Certain reclassifications of prior year amounts have been made to conform to the current year presentation. These reclassifications had no impact on the reported change in net assets available for benefits.

NOTE B – DESCRIPTION OF PLAN

The following description of the E-Force Logistics, LLC 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan formed on January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and covers substantially all full-time employees of E-Force Logistics, LLC (the Plan Sponsor) who are age eighteen or older, not a member of an excluded class, and have three months of service. The Plan is for the exclusive benefit of its participants and their beneficiaries.

SECURE 2.0 Act: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Company is evaluating the provisions and has not amended the Plan as of the date of these financial statements.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B – DESCRIPTION OF PLAN - continued

Contributions: Participants may contribute up to the maximum amount permitted by the Plan subject to certain limitations of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Plan Sponsor may match 50% of the first 2% of compensation (as defined by the Plan) that the participant contributes to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant Accounts: Each participant's account is credited with his or her contributions as well as allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts, plus actual earnings is based on years of service. A participant is fully vested after two years of service.

Forfeitures: Forfeited non-vested accounts are retained in the Plan and may be used to restore accounts, reduce employer contributions, or pay administrative expenses. Forfeitures used to offset employer contributions totaled \$10,323 in 2024. No forfeitures were used in 2023. There were no forfeiture account balances at December 31, 2024 or 2023.

Participants' Notes Receivable: Participants' notes receivable are stated at their unpaid principal balance plus any accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a loan payment and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

Payment of Benefits: Benefits may be paid upon severance of employment, death, or disability. Mandatory distributions are required for terminated participants with an account balance less than \$5,000; however, for distributions made after December 31, 2023, this threshold increases to \$7,000 pursuant to provisions of the SECURE 2.0 Act. Benefits are payable in the form of cash or annuities, as outlined in the Plan's provisions. Hardship withdrawals are available subject to certain limitations.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments and participants' notes receivable at December 31, 2024 and 2023, and the related investment earnings and interest on participant's notes for the years then ended, were certified and held by Matrix Trust Company, the Custodian, and were not audited by the independent auditor.

NOTE D – INCOME TAX STATUS

The Internal Revenue Service has ruled that the Plan qualifies under section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to income tax under present income tax law. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax return remains subject to examination.

NOTE E – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

NOTE F – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used to determine fair value, nor transfers between levels. Following is a description of the valuation methodologies used for assets measured at fair value:

Cash and Money Market Accounts: Valued at cost, which approximates fair value due to their short-term maturity and high liquidity.

Mutual Funds: Valued at closing prices reported on the active markets where the securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
