### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Aquent LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## ***Notes to Financial Statements***

### ***Note 1 - Description of Plan***

The following description of the Aquent LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution profit sharing plan with a cash deferral arrangement covering all employees of Aquent LLC (the “Employer”), except temporary hires, non-resident aliens, leased employees and any employee covered under a collective bargaining agreement, on the first day of the month following his or her employment (the “Participant”). Fidelity Management Trust Company (“Fidelity”), the trustee and custodian and provides recordkeeping services for the Plan. The Employer is the Plan’s administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

#### ***Participant Contributions***

Participants may contribute up to 75% of their annual eligible compensation to the Plan, up to certain limitations. The Plan also allows for Roth elective deferrals for all eligible participants. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

#### ***Employer Contributions***

##### ***Employer Matching Contributions***

Each year the Employer may make an Employer matching contribution at its discretion. For the year ended December 31, 2024, the Employer contributed 50% of the first 6% of eligible compensation that a staff or salaried consultant contributes to the Plan and 10% of the first 10% of eligible compensation for hourly talent. The match does not cover catch-up contributions. For the year ended December 31, 2024, the Employer matching contribution totaled \$3,781,057.

##### ***Employer Discretionary Contributions***

The Employer may make discretionary contributions. A participant must complete at least 1,000 hours of service and be employed by the Employer on the last day of the Plan year to be eligible for the Employer discretionary contributions. Such contributions are allocated in the same proportion of each eligible participant’s compensation bears to total eligible participants’ compensation. For the Plan year ended December 31, 2024, there were no Employer discretionary profit sharing contributions made.

## *Notes to Financial Statements*

### **Note 1 - Description of Plan (Continued)**

#### ***Participant Accounts***

Participants direct the investment of all contributions into various investment options offered by the Plan, which consists of shares in mutual funds, commingled funds and a self-directed brokerage. Each participant's account is credited with the Participant's contributions and allocations of the Employer's contributions and Plan earnings, and reduced by direct loan fees. Allocations are based on participant earnings, account balances or specific participant contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account. The Plan allocates amounts held in the revenue credit account after paying Plan expenses to participants based on participant balances.

#### ***Vesting***

Participants are always fully vested in their deferral account, rollover account, Employer matching and Employer discretionary contributions, plus earnings thereon.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$76,329 and \$63,265, respectively. These amounts represent prior year over funding of Employer contributions (\$29,416 and \$18,626 as of December 31, 2024 and 2023, respectively) and uncashed stale distribution checks (\$46,912 and \$44,638 as of December 31, 2024 and 2023, respectively). The excess contribution amounts may be used to restore any accounts for re-hired employees, offset Plan expenses or reduce Employer contributions and the uncashed stale checks may be used to re-issue checks to former employees that were not initially located. No forfeitures were used to reduce 2024 Employer contribution requirements.

#### ***Payments of Benefits***

In-service withdrawals from a participant's elective deferral account are permitted only due to financial hardship or upon reaching 59½. Hardship withdrawals may be taken from any account without respect to earnings. The amount of hardship distribution cannot exceed the amount to meet the immediate financial hardship. Upon termination of service, if a participant's account balance is greater than \$1,000, the participant may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments of such amounts, frequency and duration as the participant or beneficiary may elect. If the account balance is less than \$1,000, after notification, the entire amount will be paid in a lump sum as soon as possible. If a former participant's vested account is greater than \$1,000, but not more than \$5,000, the Plan administrator, after notification, will distribute his or her entire non-forfeited account balance to an IRA rollover account for the benefit of the former participant.

## ***Notes to Financial Statements***

### ***Note 2 - Summary of Significant Accounting Policies***

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Subject to approval by the Plan administrator, a participant may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance reduced by the highest outstanding loan balance in the prior twelve month period. A participant may only have two loans outstanding at a time. Loan terms are up to five years (or up to 10 years for the purchase of a primary residence). The loans are secured by the balance in the Participant's vested account and bear interest at an interest rate equal to the prime rate reported in the Wall Street Journal plus 1% at the day the loan is given. Principal and interest are paid ratably through payroll deductions.

#### ***Plan Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by Fidelity.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

#### ***Unit Values***

Individual participant accounts for the commingled funds trust are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the trust, but do have an interest therein represented by units which are valued daily. The trust earns dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the trust are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

#### ***Subsequent Events***

The Plan administrator has evaluated subsequent events through June 23, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### ***Note 3 - Information Certified by the Trustee and Custodian***

Plan investments are held by the Plan's trustee and custodian, Fidelity Management Trust Company ("Fidelity"). Fidelity has certified to the fair value of investments as of December 31, 2024 and 2023 and investment transactions for the year ended December 31, 2024. Investment transactions include interest and dividend income and net appreciation in fair value of investments. Information included in the supplemental Schedule of Assets (Held at End of Year), including participant loans (notes receivable from participants), has also been derived from information certified by Fidelity.

### ***Note 4 - Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

### **Note 4 - Fair Value Measurements (Continued)**

Level II – Inputs other than quoted prices within Level I that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Common Stocks, Mutual Funds, Exchange Traded Funds, and Cash Funds (Self-Directed Brokerage Account)***

Valued at closing price reported on the active market on which the individual securities are traded.

#### ***Commingled Funds***

Commingled funds are valued at the NAV of units of the underlying investment. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments less its liabilities. The practical expedient is not used when its determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Redemptions may be processed daily.

### Note 6 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### Note 8 - Tax Status

The Trust, established by the Plan to hold the Plan's assets, qualifies as tax-exempt under Internal Revenue Code Section 401(a). The most recent favorable determination letter from the Internal Revenue Service was received by the Plan, dated June 30, 2020. The Plan has been amended subsequent to this determination. Management believes the Plan's operations have been and intend to continue to be in accordance with all applicable provisions of the Internal Revenue Code and ERISA. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 9 - Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. During the Plan year ended December 31, 2024, \$384,788 of administrative expenses were incurred by the Plan to Fidelity and other Plan providers. In addition, notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Aquent LLC 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## ***Notes to Financial Statements***

### ***Note 1 - Description of Plan***

The following description of the Aquent LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution profit sharing plan with a cash deferral arrangement covering all employees of Aquent LLC (the “Employer”), except temporary hires, non-resident aliens, leased employees and any employee covered under a collective bargaining agreement, on the first day of the month following his or her employment (the “Participant”). Fidelity Management Trust Company (“Fidelity”), the trustee and custodian and provides recordkeeping services for the Plan. The Employer is the Plan’s administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

#### ***Participant Contributions***

Participants may contribute up to 75% of their annual eligible compensation to the Plan, up to certain limitations. The Plan also allows for Roth elective deferrals for all eligible participants. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

#### ***Employer Contributions***

##### ***Employer Matching Contributions***

Each year the Employer may make an Employer matching contribution at its discretion. For the year ended December 31, 2024, the Employer contributed 50% of the first 6% of eligible compensation that a staff or salaried consultant contributes to the Plan and 10% of the first 10% of eligible compensation for hourly talent. The match does not cover catch-up contributions. For the year ended December 31, 2024, the Employer matching contribution totaled \$3,781,057.

##### ***Employer Discretionary Contributions***

The Employer may make discretionary contributions. A participant must complete at least 1,000 hours of service and be employed by the Employer on the last day of the Plan year to be eligible for the Employer discretionary contributions. Such contributions are allocated in the same proportion of each eligible participant’s compensation bears to total eligible participants’ compensation. For the Plan year ended December 31, 2024, there were no Employer discretionary profit sharing contributions made.

## ***Notes to Financial Statements***

### ***Note 1 - Description of Plan (Continued)***

#### ***Participant Accounts***

Participants direct the investment of all contributions into various investment options offered by the Plan, which consists of shares in mutual funds, commingled funds and a self-directed brokerage. Each participant's account is credited with the Participant's contributions and allocations of the Employer's contributions and Plan earnings, and reduced by direct loan fees. Allocations are based on participant earnings, account balances or specific participant contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account. The Plan allocates amounts held in the revenue credit account after paying Plan expenses to participants based on participant balances.

#### ***Vesting***

Participants are always fully vested in their deferral account, rollover account, Employer matching and Employer discretionary contributions, plus earnings thereon.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$76,329 and \$63,265, respectively. These amounts represent prior year over funding of Employer contributions (\$29,416 and \$18,626 as of December 31, 2024 and 2023, respectively) and uncashed stale distribution checks (\$46,912 and \$44,638 as of December 31, 2024 and 2023, respectively). The excess contribution amounts may be used to restore any accounts for re-hired employees, offset Plan expenses or reduce Employer contributions and the uncashed stale checks may be used to re-issue checks to former employees that were not initially located. No forfeitures were used to reduce 2024 Employer contribution requirements.

#### ***Payments of Benefits***

In-service withdrawals from a participant's elective deferral account are permitted only due to financial hardship or upon reaching 59½. Hardship withdrawals may be taken from any account without respect to earnings. The amount of hardship distribution cannot exceed the amount to meet the immediate financial hardship. Upon termination of service, if a participant's account balance is greater than \$1,000, the participant may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments of such amounts, frequency and duration as the participant or beneficiary may elect. If the account balance is less than \$1,000, after notification, the entire amount will be paid in a lump sum as soon as possible. If a former participant's vested account is greater than \$1,000, but not more than \$5,000, the Plan administrator, after notification, will distribute his or her entire non-forfeited account balance to an IRA rollover account for the benefit of the former participant.

### ***Note 2 - Summary of Significant Accounting Policies***

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Subject to approval by the Plan administrator, a participant may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance reduced by the highest outstanding loan balance in the prior twelve month period. A participant may only have two loans outstanding at a time. Loan terms are up to five years (or up to 10 years for the purchase of a primary residence). The loans are secured by the balance in the Participant's vested account and bear interest at an interest rate equal to the prime rate reported in the Wall Street Journal plus 1% at the day the loan is given. Principal and interest are paid ratably through payroll deductions.

#### ***Plan Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by Fidelity.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

### ***Note 2 - Summary of Significant Accounting Policies (Continued)***

#### ***Unit Values***

Individual participant accounts for the commingled funds trust are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the trust, but do have an interest therein represented by units which are valued daily. The trust earns dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the trust are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

#### ***Subsequent Events***

The Plan administrator has evaluated subsequent events through June 23, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### ***Note 3 - Information Certified by the Trustee and Custodian***

Plan investments are held by the Plan's trustee and custodian, Fidelity Management Trust Company ("Fidelity"). Fidelity has certified to the fair value of investments as of December 31, 2024 and 2023 and investment transactions for the year ended December 31, 2024. Investment transactions include interest and dividend income and net appreciation in fair value of investments. Information included in the supplemental Schedule of Assets (Held at End of Year), including participant loans (notes receivable from participants), has also been derived from information certified by Fidelity.

### ***Note 4 - Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

### **Note 4 - Fair Value Measurements (Continued)**

Level II – Inputs other than quoted prices within Level I that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Common Stocks, Mutual Funds, Exchange Traded Funds, and Cash Funds (Self-Directed Brokerage Account)***

Valued at closing price reported on the active market on which the individual securities are traded.

#### ***Commingled Funds***

Commingled funds are valued at the NAV of units of the underlying investment. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments less its liabilities. The practical expedient is not used when its determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Redemptions may be processed daily.

### Note 6 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### Note 8 - Tax Status

The Trust, established by the Plan to hold the Plan's assets, qualifies as tax-exempt under Internal Revenue Code Section 401(a). The most recent favorable determination letter from the Internal Revenue Service was received by the Plan, dated June 30, 2020. The Plan has been amended subsequent to this determination. Management believes the Plan's operations have been and intend to continue to be in accordance with all applicable provisions of the Internal Revenue Code and ERISA. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 9 - Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. During the Plan year ended December 31, 2024, \$384,788 of administrative expenses were incurred by the Plan to Fidelity and other Plan providers. In addition, notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.
