## Notes to Financial Statements

### James River Air Conditioning Company 401(k) Profit Sharing Plan

#### December 31, 2024 and 2023

##### Note A - Description of the Plan

The following description of the James River Air Conditioning Company 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan covering full-time employees of James River Air Conditioning Company (the “Company”), who have completed twelve months of service. Full-time is defined as 1,000 hours of service in the previous twelve months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective October 31, 1973. The trustees are responsible for the oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

##### Contributions

Each year, participants may contribute 75% of their pretax annual compensation, as defined in the Plan, up to \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants elect the investment options in which contributions are invested. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a discretionary matching contribution to the Plan for those employees who contribute to the Plan.

Matching contributions by the Company are discretionary and determined annually. The Company matched fifty percent (up to \$3,000) of the amount deferred by participants during 2024 amounting to \$178,568 which was remitted to the Plan in 2025. The Company may, at its discretion, make an employer profit-sharing contribution and qualified non-elective contributions to the Plan. These contributions are decided annually and allocated in proportion to the compensation eligible to share in the allocations. The Company did not make a profit-sharing contribution for the Plan year ended December 31, 2024. Contributions are subject to certain limitations.

##### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings (losses) and charged with participant distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

##### Investment Options

The Plan permits every participant to direct the investment of his or her account balance under the Plan. The Plan is intended to comply with Section 401(k) of ERISA which requires that participants have an opportunity to choose from a broad range of investment options that have different risk and return characteristics.

##### Note A - Description of the Plan - Continued

###### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in employer matching and non-elective profit-sharing contributions on a 6-year graded schedule, with 0-1 year 0% vested; 2 years 20% vested; 3 years 40% vested; 4 years 60% vested; 5 years 80% vested; and 6 years 100% vested.

###### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's vested benefit in the Plan exceeds \$1,000, a participant must consent to the distribution before it can be made. If the vested benefit is less than \$1,000, the benefit will be distributed in a lump-sum as soon as practicable following the distributable event. Hardship distributions are not permitted by the Plan. For a termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Beginning January 1, 2024, the Plan allows for in-service distributions to participants over the age of 65.

###### Forfeitures

The Plan requires forfeited accounts to be used to reduce Company contributions and/or to pay administrative expenses. At December 31, 2024 there were no forfeited non-vested accounts. At December 31, 2023, forfeited non-vested accounts totaled \$3,477. During the year ended December 31, 2024, \$3,485 of forfeitures were used to reduce current year employer contributions during the year ended December 31, 2024.

##### Note B - Summary of Significant Accounting Policies

###### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

###### Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

###### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company and can be significant. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

##### Note B - Summary of Significant Accounting Policies - Continued

###### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

###### Payments of Benefits

Benefits are recorded when paid by the Plan.

###### Excess Contributions Payable

The Plan Administrator reviews deferral elections and performs annual compliance testing to identify any excess contributions. When excess contributions are identified, corrective distributions are made in a timely manner, generally by April 15 of the following plan year, in accordance with IRS guidelines. As of December 31, 2024, the Plan had recorded an excess contribution liability of \$40,752, which is reflected in the accompanying Statement of Net Assets Available for Benefits as Excess Contributions Payable. This amount is shown as a reduction of employee contributions in the accompanying Statement of Changes in Net Assets Available for Benefits. This liability represents amounts identified as excess contributions related to the plan year that are pending distribution as of year-end.

Corrective distributions related to this liability were or will be made within the required correction period to ensure continued tax qualification of the Plan.

Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the certified information, except for comparing it to information included in the Plan's financial statements and supplemental schedule of assets held at end of year.

##### Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

##### Note E - Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract (FBRIC) with Standard Insurance Company ("Standard") totaling \$1,096,087 and \$1,673,581 at December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The FBRIC does not permit Standard to terminate the agreement prior to the scheduled maturity date. The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for the FBRIC because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

##### **Note F - Transactions with Parties in Interest**

The Plan has an agreement with the Trustee, who is a party in interest, to provide investment advisory, trust, and administrative services. The Trustee receives revenue from mutual fund service providers for services the Trustee provides to the funds. This revenue offsets some administrative fees charged to the Plan.

##### **Note G - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in the net assets available for benefits.

##### **Note H - Tax Status**

The Plan is an adoption of a Prototype Non-Standardized 401(k) Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on November 30, 2020, in which the IRS stated that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, and the Prototype Plan has been amended since receiving the determination letter. However, the Plan's management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and therefore, the Plan and related trust continue to be tax-exempt. Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has determined there are no uncertain tax positions. The Plan is subject to routine audits; however, there are currently no audits for any tax periods in progress.

##### Note I - Plan Termination

Although the Company has not expressed any intention to do so, it has the right under the terms of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

##### Note J - Subsequent Events

The Plan management has evaluated all subsequent events through August 4, 2025, which is the date these financial statements were available to be issued.
