***Opinion***

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Savio House Retirement Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedules Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of Assets (Held at End of Year) as of December 31, 2024, Assets (Acquired and Disposed within the Year) for the year ended December 31, 2024 and Reportable Transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.




1. Description of the plan

The following description of the Savio House Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the all eligible employees of Savio House (Plan sponsor) who have one year of service, as defined by the Plan, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employer contributions

Each year, the Plan sponsor’s board of directors may elect to make a discretionary profit sharing contribution to the Plan. Participants are not permitted to make contributions to the Plan.

Investment options

The Trustees of the Plan are responsible for oversight of the plan, monitoring investment performance and making investment allocations. All Plan assets are invested in a portfolio of registered investment companies and money market funds as directed by the Trustees.

Participant accounts

Each participant’s account is credited with an allocation of (a) the Plan sponsor’s discretionary contribution, (b) Plan earnings or losses, and (c) forfeitures of terminated participants’ non-vested accounts. Allocations are based on participant earnings, account balances, and years of service, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in the Plan sponsor’s discretionary contribution and the re-allocated forfeitures (see below) portion of accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive the value of the participant’s vested interest in his or her account in either a lump-sum amount, or in partial withdrawals or installments for participants under required minimum distribution rules (RMD). For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts

There are no non-allocated forfeitures in the Plan as of December 31, 2024 and 2023. The Plan reallocates forfeited amounts to participants annually in the year in which the funds are forfeited. Forfeitures reallocated to participants during the year ended December 31, 2024 totaled \$50,825. The funds are reallocated to participants based on a combined compensation and years of service point system, as defined by Plan provisions.

2. Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits to participants are recorded when paid.

Expenses

The majority of the expenses of maintaining the Plan are paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements.

The Plan's trustees maintain an administrative policy charging an annual administrative fee of 5% of the most recent account valuation for participants terminated in prior years who elect to leave their account balances in the Plan. The administrative fee is included in Plan administrative expenses.

3. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Fair Value Measurement Topic of the Accounting Standards Codification (ASC 820) are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value:

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange traded funds: Valued at the closing price reported on the active market on which the individual securities are traded.

4. Related parties

The Plan has recorded a net payable to the Plan sponsor for administrative fees on terminated participant account balances of \$33,222 and \$21,052 as of December 31, 2024 and 2023, respectively, for transactions recorded by the Plan on behalf of the Plan sponsor.

The Plan has recorded profit sharing contributions receivable from the Plan sponsor of \$352,175 and \$367,018 as of December 31, 2024 and 2023, respectively.

5. Plan termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

6. Tax status

Effective January 1, 2022, the Plan document was amended and restated by adopting a volume submitter plan. The amendment and restatement is a Cycle 3 restatement to bring the plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37. There were no substantial changes to the plan terms as result of the restatement. The volume submitter obtained an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Subsequent events

Subsequent events were evaluated through date of the auditor's report, which is the date the financial statements were available to be issued.
