## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Yellow Corporation 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Yellow Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits - in liquidation as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Yellow Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Yellow Corporation 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

## **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Compensation Committee of the Board of Directors approved a plan of liquidation effective July 31, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Yellow Corporation 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Yellow Corporation 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Yellow Corporation 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF THE PLAN

The following description of the Yellow Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and administration

The Plan is intended to be a defined contribution, qualified profit-sharing plan under section 401(a) of the Internal Revenue Code ("IRC") with a qualified cash or deferred arrangement under IRC section 401(k). Further, the Plan is intended to constitute a plan described in section 404(c) of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the related regulations. As a section 404(c) plan, the fiduciaries under the Plan may be relieved of liability for any losses that are the direct and necessary result of investment instructions given by Plan participants and beneficiaries.

The Plan Sponsor, Yellow Corporation (the "Company") is the Plan Administrator and Fidelity Management Trust Company (the "Trustee") is the Plan Trustee. Fidelity Workplace Services LLC, an affiliate of the Trustee, provides record-keeping services. The Plan is subject to the provisions of ERISA.

On August 6, 2023, the Company and certain of its direct and indirect subsidiaries (the "Company Parties") filed the Chapter 11 Cases under Chapter 11 of the Bankruptcy Code in the U.S. Bankruptcy Court for the District of Delaware. On the Petition Date, the Company Parties filed a motion with the Bankruptcy Court seeking to jointly administer the Chapter 11 Cases under the caption "In re: Yellow Corporation, et al."

Administrators of the Company filed a final Chapter 11 plan on September 2, 2024, with the U.S. Bankruptcy Court for the District of Delaware. An amended plan was filed on March 28, 2025. The approval of this plan is pending as of the date of this report. Through August 3, 2024, the participants continued to make contributions to the Plan. As described below, the Company ceased employer contributions to the Plan during 2023.

On July 9, 2024, the Compensation Committee of the Board of Directors passed a resolution to terminate the Plan effective July 31, 2024 (the "Plan Termination Date"). To the extent not already vested, each Participant became fully vested in his or her entire account balance under the Plan as of the Plan Termination Date.

Eligibility and contributions

In general, employees of Yellow Corporation, YRC Inc. (doing business as YRC Freight), Yellow Logistics, Inc., YRC Enterprise Services, Inc., USF Holland LLC, USF Reddaway Inc., and New Penn Motor Express LLC (collectively, the "Employers") are eligible to participate in the Plan. Employees are not eligible to participate in the Plan if the employees are covered by collective bargaining agreements, working outside the United States on a permanent basis, nonresident aliens, leased employees, classified as independent contractors, or eligible to participate in a similar plan sponsored by an affiliate of the Company. Full-time and part-time employees become eligible to participate in the Plan on the first day of the calendar month following 30 days of employment with the Company.

Each year, a participant may contribute no less than 1% and no more than 89% of combined pretax and after-tax compensation. In addition, a participant may contribute no less than 1% and no more than 15% of after-tax compensation. The Plan provides for automatic participant enrollment with a pretax contribution of 6% of eligible compensation for employees who are eligible to participate. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Employees may affirmatively elect not to participate in the Plan or elect a higher or lower contribution rate. All contributions are subject to certain limitations of the IRC and the Plan.

The Plan allows for rollover contributions.

The Employers may make discretionary (non-matching) contributions in cash. Any discretionary contribution allocated to the participant's accounts is allocated based on the proportion of an individual participant's compensation to the total of all participant compensation. There were no discretionary contributions in 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and an allocation of the Plan's earnings or losses. A participant is entitled to the benefit that can be provided from any balances in the participant's accounts. Participant accounts are charged with an allocation of administrative expenses.

Vesting

The accounts of all participants are 100% vested and nonforfeitable at all times except the Employer discretionary non-matching contribution and prior profit-sharing plan accounts. Participants' Employer discretionary contributions and prior profit-sharing plan accounts vest 20% each year, becoming fully vested after five years of service. At December 31, 2024 and 2023, all participant accounts were fully vested. There were no participant accounts remaining at December 31, 2024.

Investment options

Participants may direct the investment of their account balances in any of a number of discretionary investment funds included in the Plan and held within the Yellow Corporation Retirement Savings Plan Trust (the "Master Trust"). The discretionary investment funds represent a broad range of investment options with investment categories that range from those having potentially more inflation risk and less investment risk to those having less inflation risk and more investment risk, including a brokerage account feature. Participants may change their investment options daily.

Notes receivable from participants

Participants may borrow from certain designated accounts. The Plan Administrator determines the rules for participant loans, including the interest rate charged for the loans. The minimum loan amount is \$1,000, and the maximum loan amount is the lesser of \$50,000 or 50% of the participant's vested account balance. Up to 50% of the participant's account balance collateralizes the participant's loan. Notes receivable must be paid back within five years, unless the loan is used to acquire the participant's principal residence. Participant loans are recorded at their unpaid principal balance plus accrued interest. Any outstanding balance of a prior loan must be repaid in full before a new loan may be approved. In the event of termination, any outstanding loan balance is considered in default and shall be paid by the participant within 90 days. Due to the plan termination, there were no balances remaining at December 31, 2024, of notes receivable from participants.

Benefits paid to participants

Distributions upon termination of employment are made in a single lump sum, provided that a participant may elect to roll over his or her account to an individual retirement account ("IRA") or another employer's qualified plan. If a participant's account balance (excluding any rollover accounts) does not exceed \$5,000 at the time of his or her termination, then the participant's benefit shall be distributed in a single lump-sum payment as soon as practicable following termination. Any participant account balance that is more than \$1,000 but does not exceed \$5,000 will be rolled over into an IRA designated by the Plan Administrator if the participant does not elect a different distribution option. If a participant retires on or after attaining normal retirement age, or terminates employment due to death or total and permanent disability, the full value of his or her accounts shall become distributable.

Benefits paid to participants (continued)

Under the Plan's in-service withdrawal feature, participants are permitted to withdraw up to 100% of their after-tax contribution account, rollover contribution account or prior profit-sharing account at any time. Upon reaching age 59 1/2, a participant may withdraw his or her remaining accounts. Participants in the former Roadway LLC 401(k) Stock Savings Plan also may withdraw accounts from their account balances, which transferred from that former plan. This withdrawal option does not require compliance with the IRC financial hardship rules. Any withdrawal that constitutes a hardship withdrawal must meet the IRC requirements for a demonstrated financial need. Hardship withdrawals may be made after taking all other available distributions from the pretax contribution accounts if the maximum nonhardship withdrawal has been made from the participant's other accounts.

Plan termination

As discussed in Note 1 above, the Plan was formally terminated pursuant to a resolution adopted by the Compensation Committee of the Board of Directors. No further contributions were made to the Plan after that date, and all participant accounts were fully vested. The Plan Administrator took all necessary steps to distribute plan assets in accordance with applicable IRS and DOL regulations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

As a result of the plan termination described in Note 1, the Plan has adopted the liquidation basis of accounting effective July 31, 2024, in accordance with U.S. generally accepted accounting principles ("U.S. GAAP").

Use of estimates

The preparation of financial statements is in accordance with U.S. GAAP and requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Fair value measurements

FASB Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- *Level 2* - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets that are not active, and other inputs that are observable or can be corroborated by observable data for substantially the full term or the assets or liabilities.
- *Level 3* - Inputs to the valuation methodology include inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Master Trust's assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Such assets are classified as Level 1.
- *Common/collective trusts* - The common/collective trusts are valued at NAV based on the market value of underlying investments. For units of common/collective trust funds holding fixed-income bonds, it is calculated at the net unit value multiplied by the number of units held as of the measurement date.
- *Brokerage accounts* - Common stock, mutual funds and trusts in the self-directed brokerage accounts are at current value based on published market quotations from individual investments composing the brokerage accounts. Such assets are classified as Level 1.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Changes in the Plan's interest in the Master Trust includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant's loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses paid by the Company are excluded from these financial statements. Certain other administrative expenses are paid directly by the Plan. The investment income of the Plan is net of any investment advisory fees charged by the investment managers and participant revenue credits received.

3. INTEREST IN THE MASTER TRUST

The Plan's investment assets are held by the Trustee and consist of a divided interest in the Master Trust. As of December 31, 2024 and 2023, the Master Trust included assets of the Plan and assets of the Reddaway Hourly 401(k) Plan. The Plan's interest in the net assets of the Master Trust was approximately 0% and 97% at December 31, 2024 and 2023, respectively. This was determined by comparing the Plan's investments in the Master Trust to total net assets in the Master Trust. Investment income and administrative expenses relating to the Trust are allocated to the individual participants in the Plans based upon individual participant activity.

Certain Plan investments are shares of registered investment companies and a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are netted against investment income.

7. TAX STATUS

The Plan obtained its latest determination letter on September 21, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
