NOTE A - DESCRIPTION OF PLAN

The following description of Service Energy, LLC Combined Profit Sharing Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of Service Energy, LLC, Service Energy Transport, LLC, Clean Delaware, LLC, Watermaxx, LLC, John Cardullo & Son, LLC, Super Cylinder, LLC, Reliable Environmental Services, Clean Delaware Inc., LLC and Reliable Service, LLC who have completed 500 hours of service in their first six months or 1,000 hours of service in twelve consecutive months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Company makes a safe harbor contribution, to those employees who have completed six months of service, of 100% of the employee contribution up to 3% of compensation and matches 50% of the employee contribution that exceeds 3% of compensation up to 5% of compensation. The Company can also make discretionary contributions. No discretionary contributions were made for the December 31, 2024 and 2023 Plan years.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's contribution and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their accounts among available investment options.

**Vesting** - Participants are vested immediately in their contributions and the Company's safe harbor contributions, plus actual earnings or losses thereon. Participants become fully vested in other Company contributions plus actual earnings or losses based on years of continuous service. A participant becomes 20% vested after the completion of two years earning 20% each year thereafter until becoming fully vested after six years of credited service.

**Notes Receivable From Participants** - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear a fixed rate of interest at 4.75% to 10.00%, which is commensurate with local prevailing rates at the time the note is originated. All notes must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home loans that may be repaid over a reasonable period of time that may exceed five years. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

**Payment Of Benefits** - On termination of service and under specific situations of financial hardship, a participant or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a series of equal annual installments over the period necessary to satisfy the distribution requirements. The Plan also allows in-service distributions for eligible participants.

**Forfeited Accounts** - Forfeitures may be used to reduce future employer contributions. During 2024 and 2023, the Plan utilized \$2,441 and \$0, respectively, of forfeitures to reduce employer contributions. For the years ended December 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$0.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis Of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation And Income Recognition** - Investments in registered investment companies and self-directed accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in benefit-responsive insurance contracts are reported at contract value. Contract value is the price participants would receive if they were to initiate permitted transactions under the terms of the Plan. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Use Of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Payment Of Benefits** - Benefits are recorded when paid.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Plan Expenses** - The Company absorbs significant administrative costs of the Plan.

**Subsequent Events** - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through August 19, 2025, the date the financial statements were available to be issued.

NOTE C - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, custodian, and was not subject to audit.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-Directed Brokerage Account** - These accounts hold common stocks which are valued at the closing price reported on the major market on which the individual securities are traded and are generally classified within Level 1 of the valuation hierarchy.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31, 2024 and 2023, by caption on the Statements of Net Assets available for benefits within the valuation hierarchy.

NOTE E - INVESTMENT CONTRACT

The Plan currently offers a fixed income guaranteed option through Principal Life Insurance Company.

The Principal fixed income guaranteed option is a benefit-responsive group annuity contract. The methodology for calculating the interest crediting rate is defined by the contract. Under the terms of the contract, the Composite Crediting Rate is currently reset on a semiannual basis and will never be less than the Guaranteed Minimum Interest Rate. Amounts allocated to the fixed income option are backed by the Company's general account. No portion of the general account is attributable to a particular plan nor do plans have any undivided ownership interest in the general account assets. Withdrawals to pay participants benefits from the fixed income option are made at contract value.

NOTE F - PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment services and/or transactional fees amounted to \$53,845 and \$43,499 for the years ended December 31, 2024 and 2023, respectively.

NOTE F - PARTIES-IN-INTEREST TRANSACTIONS - CONTINUED

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$234,630 and \$202,667, respectively.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE H - TAX STATUS

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020 in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan administrator timely adopted the restated prototype plan. The Plan administrator believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE I - RISKS AND UNCERTAINTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.
