Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Kinzler Employee Stock Ownership Plan and Trust Agreement (the Plan) provides only general information. Participants should refer to the Plan agreement for complete information.

General

Kinzler Construction Services, Inc. (the Company) established the Plan effective January 1, 2017. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company operates under a common control group with an affiliate, Auto Truck Repair Center, Inc. An independent third-party administers the Plan.

Eligibility

Employees of the Company and Auto Truck Repair Center, Inc. who are non-union members are eligible after reaching the age of 18 and completing one month of service. Eligible employees enter the plan each January 1, April 1, July 1 and October 1.

Contributions

The Plan agreement allows the Company to make discretionary contributions and safe harbor matching contributions to the Plan. The Company is not required to make discretionary contributions. Participants must provide at least 1,000 hours of service and be employed at the end of the Plan year to receive an allocation of any discretionary contributions. Discretionary contributions and any forfeitures are allocated to participants based on each participant's pro-rata share of total eligible compensation paid to all eligible participants for a given plan year. The Plan agreement defines eligible compensation. Total discretionary contributions were \$0 during the years ended December 31, 2024 and 2023. In addition, the Company makes safe harbor matching contributions to the Plan which are credited to each eligible participant's account. Safe harbor matching contributions are equal to 100% of the participant's elective deferral to the Kinzler Construction Services, Inc. 401(k) Plan which do not exceed 1% of compensation plus 50% of elective deferrals to the Kinzler Construction Services, Inc. 401(k) Plan which exceed 1%, but do not exceed 6% of compensation. Total safe harbor matching contributions were \$715,640 and \$705,335 during the years ended December 31, 2024 and 2023, respectively.

Interest income is allocated to participants in the ratio of each participant's cash account balance at the beginning of the year to the total of all participants' cash accounts.

Kinzler Employee Stock Ownership Plan and Trust Agreement Notes to Financial Statements

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participant's non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance to the total account balance of all participants.

Vesting

Participants vest in their allocated balances of discretionary contributions based on total years of service with the Company and Auto Truck Repair Center, Inc. Participants vest 20% per year of service starting with the completion of their second year of service and are 100% vested after six years of service. Participants are 100% vested in safe harbor matching contributions after two years of service. In the event of death, permanent disability, or attaining normal retirement age, the participant becomes fully vested.

Forfeited Accounts

Forfeitures are reallocated to participants based on their proportionate share of eligible wages. The Plan allocated \$16,078 and 1,893 shares and \$15,582 and 1,736 shares to participant accounts during the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon termination of service for legal retirement age, qualifying disability or other termination, a participant with an account balance of less than \$7,000 will be paid in lump sum, otherwise a balance great than \$7,000 will be paid in annual installments not to exceed a five-year period. However, if a participant's account balance exceeds \$1,080,000, the maximum payment period is extended per the terms of the Plan document and as allowed for under the IRC. All distributions will be made in the form of cash. At December 31, 2024 and 2023, respectively, participants that had terminated employment but had not yet received a Plan distribution had vested account balances totaling \$1,747,006 and \$1,336,269, respectively.

Voting Rights

Each participant, under certain circumstances that are mandated by the IRC, is entitled to exercise voting rights attributable to the shares allocated to his or her account. All allocated Company stock as to which instructions have been received, which may include an instruction to abstain, shall be voted by the Trustee in accordance with such instructions, provided that the Trustee may vote the shares as it determines is necessary to fulfill its fiduciary duties under ERISA. The Plan's Committee shall direct the Trustee how to vote for any Company stock in the Trust Fund as to which no voting instructions have been received.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations and includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who have reached age 55 and have at least ten years of service in the Plan may elect to diversify a portion of their account balance that is invested in Company stock. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account. In the sixth year, the percentage changes to 50%. No assets were diversified during the years ended December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting under accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value using the valuation methods described in Note 4. Purchases and sales of securities are recorded on a trade date basis.

Payments of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Administrative costs of the Plan may be paid by the Plan or the Company. Expenses paid by the Company are excluded from these financial statements.

Subsequent Events

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a valuation hierarchy for disclosure of the inputs to valuation used to measure fair value. The hierarchy prioritizes the inputs into three broad levels as follows:

Level 1: inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2: inputs are quoted prices for similar assets and liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument.

Level 3: inputs are unobservable inputs based on the Plan's own assumptions used to measure assets and liabilities at fair value.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated July 17, 2018, that the Plan is designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the Company's common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the Company's common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock. This is a related party and party-in-interest transaction. As described in Note 2, the Company typically pays all plan expenses. The Plan has a number of services providers. Such providers are parties-in-interest under ERISA.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the Plan provisions. Upon termination of the Plan, the interest of each participant in the trust fund will be distributed to such participants or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the plan administrator should direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.
