### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Honnen Equipment Company Profit Sharing 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Honnen Equipment Company Profit Sharing 401(k) Plan and Trust's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

**Note 1. Description of the Plan**

***General and Plan Termination***

The following description of Honnen Equipment Company Profit Sharing 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan sponsored by Honnen Equipment Company (the Company) for the benefit of its employees who were age 19 or older. The Plan excluded those who were members of a collective bargaining agreement, nonresident aliens, and part-time employees (employees that work less than 1,000 hours during the plan year). The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower) was the trustee and custodian of the Plan.

On January 5, 2024, the plan sponsor approved the termination of the Plan, and plan amendment became effective December 31, 2023. As of the date of the amendment, no additional employees could become eligible, no further contributions were allowed, and all employees were fully vested in the Plan. The Plan was fully liquidated on November 15, 2024.

***Contributions***

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 100 percent of their eligible compensation. Employee rollover contributions were also permitted. Participants who had attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company made matching contributions of 100 percent of employees' salary deferral amounts on the first 5 percent of employees' compensation. Employees were eligible for the Company match after one year of service. The Company was also able to make additional discretionary matching contributions. If the Company made an additional discretionary matching contribution, it would not apply as to elective deferrals exceeding 6 percent of employee compensation. The total amount of this additional discretionary matching contribution will not exceed 4 percent of employee compensation. For the period January 1, 2024 to November 15, 2024 and the year ended December 31, 2023, the Company did not make any additional discretionary matching contributions. The Company was also able to make discretionary nonelective contributions, which are allocated to participants in the ratio that each participant's eligible compensation bears to the total eligible compensation paid to all eligible participants. For the period January 1, 2024 to November 15, 2024 and the year ended December 31, 2023, the Company did not make any discretionary nonelective contributions.

***Participant Investment Account Options***

Each participant had the option of directing their contributions into any of the various investment options offered by the Plan and was able to change the allocation daily.

The plan document also included an automatic deferral feature whereby a participant is treated as electing to defer a 4 percent of eligible compensation unless the participant made an affirmative election otherwise.

Employer profit-sharing contributions to the Plan were invested at the discretion of the participant.

***Participant Accounts***

Each participant's account was credited with the participant's contribution, the Company's contributions and plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

***Vesting***

Participants were 100 percent vested in all contributions.

***Notes Receivable from Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account. Principal and interest was paid ratably through biweekly payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the vested interest in their account or annual installments over a period not to exceed the participants life expectancy. Upon termination of service for other reasons, a participant could receive the value of the vested interest in their account only as a lump-sum distribution.

***Forfeited Accounts***

At November 15, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$4,036, respectively. These accounts could be used to reduce employer contributions or administrative expenses. In 2024 and 2023, employer contributions and administrative expenses were reduced by \$0 and \$14, respectively. In 2024, the Plan allocated the remaining forfeiture balance of \$4,044 equally to each participant.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the liquidation basis of accounting for 2024 and the accrual basis of accounting for 2023.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Quoted market prices, if available, were used to value investments.

Fully benefit-responsive investment contracts were valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

***Notes Receivable from Participants***

Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

***Administrative Expenses***

Administrative expenses were paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, a qualified institution, certified the following information included in the accompanying financial statements was complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of November 15, 2024 and December 31, 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the periods ended November 15, 2024 and December 31, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Empower was the issuer of the Plan's guaranteed investment contract, which was part of the general account of Empower. Empower is the trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$27,082 and \$5,193 of recordkeeping fees to Empower during the period ended November 15, 2024 and the year ended December 31, 2023, respectively. Additionally, the Plan paid \$14,204 and \$34,654 in investment management fees to Empower for the period ended November 15, 2024 and the year ended December 31, 2023, respectively. The Company provided certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

***Recurring Measurements***

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the period January 1, 2024 to November 15, 2024 and the year ended December 31, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 3 investments identified.

**Note 6. Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive traditional investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract was fully benefit responsive; therefore, contract value was the relevant measurement. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 7. Tax Status**

The Plan operated under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust. This prototype plan document was filed with the appropriate agency and had obtained a determination letter from the IRS stating that the prototype constituted a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date.
