**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Viking Group, Inc. Savings and Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution profit sharing plan covering substantially all non-union employees of Viking Group, Inc., the Plan sponsor, and certain related employers (collectively referred to hereafter as the Company). Employees become eligible to participate in 401(k) portion of the plan on the first day of the calendar quarter following completion of three months of employment and attainment of age 18. Temporary or seasonal employees are excluded from participation unless they meet eligibility requirements of one year of employment with the Company and attainment of age 21. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may elect to make contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

The Company provides a safe harbor contribution of a percentage of each eligible employee's compensation, as defined by the Plan. This contribution is intended to qualify the Plan under safe harbor provisions of the Internal Revenue Code. For the 2024 Plan year, the Company provided a safe harbor contribution of 5% of eligible compensation.

The Company may also make an additional discretionary profit-sharing contribution in an amount determined by the board of directors of the Company. For the year ended December 31, 2024, the Company provided a discretionary matching contribution equal to 3% of eligible participant compensation, and a discretionary profit sharing amount equal to 1% of eligible discretionary compensation. To receive a matching and discretionary contribution, a participant must be employed on the last day of the Plan year and must have at least 1,000 hours of service during the Plan year.

**Plan Operations**

The Company has appointed Fidelity Management Trust Company (trustee) to act as trustee and a committee of employees to act as plan administrator. The trustee is responsible for holding the investment assets of the Plan, executing investment transactions and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled and approves certain distributions from the Plan to participants.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying schedule of assets held at end of year.

**Vesting**

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in employer discretionary contribution accounts is based on years of continuous service, as follows:

**Vesting (continued)**

A participant also becomes fully vested in employer contributions at the time of the participant's death, if the participant becomes disabled while employed or upon attainment of normal retirement age.

**Notes Receivable from Participants**

Under certain conditions, a participant may obtain a loan from the Plan. A participant's loan cannot exceed the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 4.25 – 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service a participant may elect to receive a lump sum amount equal to the value or a portion of the value of the participant's vested interest in his or her account. In-service withdrawals are permitted upon attaining age 59½ and in cases of financial hardship. Certain withdrawals are allowed after attaining age 55.

**Forfeited Accounts**

The balance in the forfeited non-vested account was \$1,594 and \$8,914 at December 31, 2024 and 2023, respectively. During 2024, \$88,748 was used to reduce employer contributions and \$986 was used to reduce administrative fees.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. While management believes it has consistently applied its best judgment in those areas requiring estimates, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

For the year ended December 31, 2024, plan management has evaluated subsequent events for potential recognition and disclosure through August 5, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS AND DISCLOSURES**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The mutual funds and money market funds have been valued using the unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Using unadjusted quoted prices for identical investments in active markets that the Plan has the ability to access is defined as a level 1 measurement method.

The common/collective trust fund has been valued using quoted prices that are observable for the assets either directly or indirectly. These include quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets, inputs that are observable for the assets, or inputs that are derived principally from or corroborated by observable market data. Using such quoted prices is defined as a level 2 measurement method.

**NOTE 4 - RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds and a common/collective trust fund managed by an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan made payments to the third party administrator of \$78,995 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the plan's operation.

**NOTE 5 - TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.
