## **Notes to Financial Statements**

### **1. Description of the Plan**

The following description of the Tak Shing Hong, Inc. 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The sponsor of the Plan is Tak Shing Hong, Inc. (the "Company").

#### **General**

The Plan is a defined contribution plan and effective on January 1, 2002, the Company established the Plan (Plan 001) for all eligible full-time employees of the Company with the exception of nonresident aliens and residents of Puerto Rico. The last amendment was adopted in 2020. Employees of the Company are eligible to participate in the Plan on either January 1 or July 1, immediately following the date the employee completes 12 months of service with 1000 hours worked and reaches age 21. The Plan is subject to the provisions of the Employee retirement Income security Act of 1974 ("ERISA").

The retirement service provider for the Plan is ADP while Merrill Lynch is its financial advisor. At the direction of the Plan Committee, the Custodian had the responsibility to invest, hold, and distribute the assets held by the Custodian for the benefit of the participants and their beneficiaries.

The Custodian maintains the Plan's assets in various fund accounts, which are credited with actual earnings on the underlying investments and charged for Plan withdrawals.

#### **Contributions**

Participants may make voluntary contributions in the form of salary deferrals up to 90% at participant's discretion subject to the annual maximum amount imposed by the Internal Revenue Service. The Company matches 15% of the participants' deferrals up to \$700 per year.

#### **Participant Accounts**

Each Participant's account is credited with the participant's and Company contributions and related earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### 1. Description of the Plan, continued

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings thereon is based on years of continuous service as follows:

Deceased and disable participants are immediately 100% vested in all sources.

#### Payment of Benefits

A participant's account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in either a single lump-sum amount or installment payments equal to the value of the participant's account, if the vested value of the participant's account is larger than \$5,000. If the vested interest is less than \$5,000, the participant may only receive the distribution in a lump sum. In-service withdrawals from transfer accounts, distribution after age 59.5 and hardship distributions are also allowed by the Plan.

#### Forfeited Accounts

In the event that a participant terminates employment prior to 100% vesting, the portion of Company's contributions which is not vested is forfeited at that time. Any forfeiture will be used to reduce the Company's matching contribution and the administrative expenses in future years. In 2024, forfeited unvested amounts totaled \$1,725 and the Plan has applied \$321 to reduce its employer matching. The balances of the forfeited non-vested participant accounts as of December 31, 2024 and 2023 were \$1,749 and \$314 respectively.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefits are recorded when paid.

### **2. Summary of Significant Accounting Policies, continued**

#### **Basis of Accounting, continued**

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

#### **Significant Risk and Uncertainty**

The fair value of the Plan's assets is subject to change as a result of changes in market rates and prices. A significant change in market rates and prices can significantly reduce the net assets available for Plan benefits and concurrently participant balances. Plans that invest in foreign securities are subject to foreign exchange and political risks among other risks.

#### **Valuation of Investments and Income Recognition**

The Plan's investments in the mutual funds are valued at fair value based on quoted market prices in active markets. Investments on common and collective trusts are valued at fair value as reported to the Plan by Reliance Trust Company. The Plan presents, in the statement of change in net assets available for benefits with fund information, the net appreciation (depreciation) in the fair value of its investments, which consist of the realized gains or losses and the unrealized appreciation (depreciation) of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Participant contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings. Company contributions are recorded based upon the required Company matching levels as defined in the Plan agreement.

### **2. Summary of Significant Accounting Policies, continued**

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator and trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at December 31, 2024 and 2023 and the reported amounts of additions to and deductions from net assets for the year ended December 31, 2024. Actual results may differ from those estimates.

#### **Date of Management's Review**

Subsequent events were evaluated through July 24, 2025, which is the date the financial statements were available to be issued.

### **3. Investments**

Investments are held in custodial capacity by Reliance Trust Company, the trustee of the plan. Individual Plan participants direct the transactions that take place in their accounts. Allocations of gains (losses) are at the individual contract level. During the year ended December 31, 2024, the Plan's investments (including gains and losses on mutual funds bought and sold as well as held during the year) appreciated (depreciated) in value by \$209,402.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from, or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### 4. Fair Value Measurements, continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value of shares held by the Plan at year end. The NAV is a quoted price in an active market.

Common / Collective Trusts: The Plan has concluded that the net asset value as adjusted and reported by State Street denotes readily determinable fair value. Therefore these funds are classified in Level 1 in the fair value hierarchy.

Pooled Separate Accounts: Assets owned by the Accounts are primarily limited fund offerings issued by the underlying fund. These are classified within Level 1, as fair values of the underlying funds are based upon reported net asset values ("NAV"), which represent the values at which each sub-account can redeem its investments.

Changes in valuation techniques may result in transfer in or out of an assigned level within the disclosure hierarchy. Transfers between investment levels may occur as the availability of a price source or data used in an investment's valuation changes. Transfers between investment levels are recognized at the beginning of the reporting period. There have been no transfers between any level of fair value measurements during the year ended December 31, 2024.

### 5. Participant Notes Receivable

Under the terms of the Plan, participants may borrow from their vested balances, subject to certain limitations as set forth in the Plan and the Internal Revenue Code. The loan amount must be between a minimum of \$500 only 1 outstanding loan is allowed at any time. Maximum repayment period is generally 5 years unless for the purchase of a primary residence. The amounts borrowed carry fixed interest rates which are prime + 2%. Loans are payable in full upon the participant's termination of employment from the Company. There was no employee loan granted during the year ended December 31, 2024.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### 8. Income Tax Status

The Company has adopted a prototype plan which has received a favorable determination letter from the Internal Revenue Service dated October 6, 2020 that the Plan qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Company is of the opinion that the Plan is currently being operated in compliance with the applicable requirements of the IRC and that the trust, which forms a part of the Plan, is tax exempt. Accordingly, no provision for state or federal income taxes has been provided.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

### **9. Related Party and Party-in-interest Transactions**

Certain Plan recordkeeping functions are performed by ADP, LLC which charged a total of \$9,825 in 2024. The Plan also paid a total of \$13,789 investment advisory and investment management fees to the plan trustee. Certain plan investments are held in investments managed by the plan trustee, and these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transaction under ERISA.

Certain Administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

### **10. Operating Expenses**

During the year of 2024, \$23,614 of administrative fees was paid by the plan.

### **11. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
