## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
OB-GYN Associates, P.C. Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of OB-GYN Associates, P.C. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**NOTE 1 — DESCRIPTION OF THE PLAN**

The following brief description of the OB-GYN Associates, P.C. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that covers substantially all employees of OB-GYN Associates, P.C. (the Company) who have one year of service (over 1,000 hours) and are age twenty-one or older. The Plan allows immediate entry into the Plan upon satisfaction of age and service eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 100% of compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute pre-tax amounts representing distributions from other qualified plans. The Company contributes a safe harbor match equal to 3% of eligible compensation. Additional discretionary profit sharing amounts may be contributed at the option of the Company's Board of Directors.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contribution, allocations of the Company's discretionary profit sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and all Company contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their account up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Outstanding loans are limited to one per participant at any given time, are secured by the balance in the participant's account, and bear a reasonable interest rate. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or be paid in installments, partial withdrawals, or annuities, as defined. In-service withdrawals are available as defined. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over the vested balance to another plan, as defined.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Contributions**

Contributions from participants are recorded in the year in which they are withheld from compensation.

**Administrative Expenses**

The cost of administering the Plan is shared among the Plan participants and the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included as net appreciation (depreciation) in fair value of investments.

**NOTE 3 — INFORMATION CERTIFIED BY FIDELITY**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity (the trustee and custodian of the Plan).

**NOTE 4 — FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority):

Level 1 — defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 — defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and

Level 3 — defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

**NOTE 4 — FAIR VALUE MEASUREMENTS (Continued)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.
- *Collective investment funds and stable value fund*: The fair value of units are valued at net asset value, determined using available market information of the underlying securities including quoted prices for identical or similar securities in active or nonactive markets, similar to a mutual fund. These redemption values are the values at which a participant would transact on a daily basis. There are no restrictions on the ability to transact with the funds at net asset value.

**NOTE 6 — INCOME TAX STATUS**

The Plan was created from a prototype plan developed by Fidelity. The IRS has issued an opinion letter, dated June 30, 2020, that the prototype plan is qualified, and the trust established under the Plan is tax-exempt under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC under the prototype.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. Plan management has not identified any uncertain tax positions.

**NOTE 7 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include mutual funds managed by Fidelity, the trustee of the Plan. Additionally, a participant who acquires a participant loan is a party-in-interest. However, these transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 — SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.
