Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of KMG Prestige Incorporated Retirement 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1-Description of Plan

The following description of the KMG Prestige Incorporated Retirement 401(K) Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution employee 401(K) retirement plan covering substantially all employees age 18 or older and provides for retirement benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the IRS maximum limits of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans. Additional employer contributions can be made each year at the discretion of the Board of Directors of KMG Prestige Incorporated.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, rollover contributions, and allocations of the Company’s contribution and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous services. A participant is 100% vested after five years of credited service.

Payment of Benefits

Benefits are paid as a lump sum payment based on the vested service and account balance. The Plan provides for normal retirement at age 65 at which time the participant is entitled to 100% of their account balance. Benefits equal to 100% of the participant’s balance will be paid to the participant or the participant’s beneficiary in the event of disability or death.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$37,512 and \$28,600, respectively. These accounts may be used to reduce employer contributions. Employer contributions were reduced by \$37,025 and \$28,600 from forfeited nonvested accounts for the years ended December 31, 2024 and 2023.

Participate Loans

Participants may borrow from their fund accounts a minimum of \$1,000 with the maximum amount the lessor of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest is paid over a period determined by the plan administrator, but such period shall not exceed five years unless such purpose of the loan is for the purchase of a principal residence in which case the repayment period shall not exceed 10 years. Payments are made through payroll deductions with equal installments made each pay period.

NOTE 2-Summary of Significant Accounting Policies

Basis of Accounting

These financial statements are prepared on the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Fees for the administration of participant loans and withdrawal fees are included in administrative expenses and are charged directly to participant's accounts.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when paid by the participant. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant loan is deemed in default, to the extent permitted by law, the participants vested account balance may be offset by the outstanding balance of the loan. Loans are deemed in default as of the last day of the calendar quarter following the calendar quarter in which the unpaid installment was due. As of December 31, 2024 and 2023 no allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through August 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3-Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since the determination letter, the Plan administrator believes the plan is designed and is currently operated in compliance with applicable requirements of the IRC.

NOTE 4-Fair Value of Investments

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The Standard Stable Asset fund is an insurance contract with Standard Insurance Company, it is not actively traded and significant other observable inputs are not available. The Plan's investment contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. The Standard believes that contract value is an appropriate measurement for the Plan's Standard Stable Asset for reporting and financial statement purposes, and that contract value approximates fair value. The Plan's Standard Stable Asset's contract value is a general liability against Standard Insurance Company on the Plan's behalf. There are no particular segregated or identifiable assets of Standard Insurance Company ascribed to the Plan's Standard Stable Asset investment. The contract value is guaranteed by the full faith and credit of Standard Insurance Company.
