Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Ball Janik LLP 401(k) Profit Sharing Plan and Trust, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Notes to Financial Statements December 31, 2024

Note 1 - Description of the Plan

The following description of the Ball Janik LLP 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1986, and was most recently amended and restated effective December 17, 2024. The Plan is a defined contribution 401(k) profit sharing plan covering all eligible employees of Ball Janik LLP (the "Partnership") who have attained 21 years of age. Employees are eligible to enter the 401(k) portion of the Plan on the first day of the calendar quarter following their date of hire. The Plan excludes temporary employees who perform less than 1,000 hours of service in a Plan year and on-call/substitute employees from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's Administrative Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan agreement. Participant salary deferral contributions are made voluntarily, subject to certain limits set by the Internal Revenue Code ("IRC"). Participants direct the investment of their contributions and any employer contributions into various investment options offered by the Plan.

Employees become eligible to enter the profit-sharing portion of the Plan either January 1 or July 1 following completion of one year and 1,000 hours of service within 12 consecutive months and must be employed on the last day of the year. The Partnership may make discretionary profit-sharing contributions, as determined annually by the Partnership. Partnership contributions are also subject to certain limits set by the IRC. In 2024, the Partnership contributed 5% of the participants' eligible compensation plus an additional contribution of 13.33% of eligible compensation over \$100,000.

The Partnership makes safe harbor minimum contributions of 3.0% to 5.0% of the participants' eligible compensation, when necessary, for associates, staff or partners who have not yet satisfied the service requirement or are not eligible for the profit-sharing portion of the Plan.

The Plan was amended on December 17, 2024, to allow for Roth contributions effective January 1, 2025.

Participant accounts

Each participant's account is credited with the participant's contributions and the Partnership's contributions, as well as allocations of Plan earnings, and charged with an allocation of administrative expenses that are activities specific to each account. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service.

Payment of benefits

On termination of service due to death, disability or retirement, participants may elect to receive either a lump-sum amount equal to the value of the participants' vested interest in their accounts or annual installments not to exceed the life expectancy of the participant and/or beneficiary. Partial or full withdrawal of participants' account balances are also available under certain circumstances described in the Plan agreement.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,293 and \$39,234, respectively. Forfeitures can be used to reinstate previously forfeited accounts, to reduce future employer contributions, or to pay Plan expenses. The 2024 Partnership contributions were reduced by \$16,293 from forfeited nonvested accounts.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies, utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the matching contributions from the Partnership are recorded in the year in which the employee contributions are withheld from compensation.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Partnership and are excluded from these financial statements. Administrative expenses occurring within the self-directed partnership accounts and other accounts are paid from those accounts (see Note 4). Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest-bearing cash and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed partnership and other accounts: Accounts consist of investments in mutual funds, common stock, government securities, corporate bonds, partnership interests and notes receivable (other than from participants).

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common stock, government securities, and corporate bonds are valued at the closing price reported on the active market on which the individual securities are traded.
- Partnership interests are valued at NAV (or its equivalent) based upon the allocation of the partners' capital held in the partnerships, which is determined based upon the audited financial statements of the partnerships.
- Notes receivable (other than from participants) are valued at their outstanding balances plus any accrued interest.

Morrison Street Debt Opportunities Fund II, L.P.

The investment objective of the fund is to invest in real property and real estate related assets.

Morrison Street Fund VI, L.P.

The investment objective of the fund is to invest in debt and preferred equity real estate related assets.

Morrison St. Income Fund, L.P.

The investment objective of the fund is to invest in commercial real estate, subordinated debt (including but not limited to mezzanine loans and B-notes), and real estate related debt securities.

Note 4 - Related party transactions and party-in-interest transactions

Certain Plan investments are units of a money market fund or are assets held in partnership accounts managed by Charles Schwab Trust Bank. Purchases, sales and related fees incurred qualify as party-in-interest transactions. Northwest Plan Services ("NWPS") provides certain administrative services to the Plan pursuant to an Administrative Services Agreement ("ASA") between the Partnership and NWPS. NWPS receives revenue from registered investment company service providers for services NWPS provides to the funds. This revenue is used to offset certain amounts owed to NWPS for its administrative services to the Plan.

If the revenue received by NWPS from such registered investment company service providers exceeds the amount owed under the ASA, NWPS remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no amounts in excess of NWPS expenses that were remitted to the Plan. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. For the year ended December 31, 2024, fees paid by the Plan for the administrative or investment management and administrative services that were not paid through revenue sharing totaled \$2,240. The Plan Sponsor pays directly any other fees related to the Plan's operations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Tax status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, CCH Incorporated, has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the plan agreement, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended and restated since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Note 7 - Certified investments

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment gain for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Trust Bank, a custodian of the Plan. The certified investments totaled \$25,562,761 as of December 31, 2024, and certified investment gain of \$3,589,175 for the year ended December 31, 2024.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
